Interested firms must have a proven track record in similar projects, including the construction of RCC pile foundations, tower foundations, and erection & stringing works, executed within DISCOs (PPMC) or NTDC over the past 10 years. Such experience must be substantiated with a completion certificate, duly attested by a sitting officer, clearly mentioning their name and contact details for verification. Additionally, bidders must be: Registered with the Provincial Sales Tax (PST) in Balochistan, Compliant with the Income Tax Department, Listed in the Active Taxpayers List (ATL) of the Federal Board of Revenue (FBR), Government of Pakistan. Detailed project specifications and requirements are outlined in the Bill of Quantities (BOQ). Only technically and financially compliant bids meeting the stipulated criteria will be considered for further evaluation.

To acquire the tender documents, bidders must submit the attested copies of documents; Computerized National Identity Card (CNIC), Valid PEC License (2024-2025) (Original to be presented for verification), Experience Certificates & Completion Certificates (for similar works), National Tax Number (NTN) & Balochistan Revenue Authority (BRA), Tax returns for the Fiscal Year 2023-2024, Current work orders (undertaking required), A non-judicial stamp paper (duly countersigned by an oath commissioner) must be submitted, wherein the firm's owner undertakes that all provided documents are genuine. If any document is found falsified later, the firm shall bear full legal and financial consequences. A lump-sum CDR of PKR-1.500 Million (Pak Rupees One Million Five Hundred Thousand) in the firm's name, issued for the specified work. The tender documents will be issued only to the firm's proprietor or their legally authorized representative. If collected by a representative, an authorization letter on non-judicial stamp paper (countersigned by an oath commissioner and signed by the owner in original) must be presented. Deadline for issuance of Tender Documents for above work is 26th June, 2025 (Thursday). The tender documents are available for purchase at a nonrefundable fee of PKR-10,000/- (Pak Rupces Ten Thousand Only), payable through a pay order drawn in favor of the Project Director (GSC) QESCO, Quetta. Bidders must meticulously fill out the Bill of Quantities (BOQ), ensuring all rates are clearly mentioned in figures and words, inclusive of all applicable taxes. Any overwriting, cutting, or corrections in the BOQ will render the tender non-responsive and lead to its outright rejection.
