## A. General

- 1. Scope of Bid**
- 1.1 In connection with the Invitation for Bids indicated in the Bid Data Sheet (BDS), the Employer, as indicated in the BDS, issues this Bidding Document for the procurement of plant and services as specified in Section 6 (Employer's Requirements). The name, identification, and number of tranches (contracts) of the International Competitive Bidding (ICB) are provided in the BDS.
- 1.2 Unless otherwise stated, throughout this Bidding Document definitions and interpretations shall be as prescribed in Section 7 (General Conditions of Contract).
- 2. Source of Funds**
- 2.1 The Employer shall finance the project both for the foreign component of the list of goods & services as well as erection & civil works etc. in Pak Rupees from Federal PSDP.
- 3. Fraud and Corruption**
- 3.1 Employer Anticorruption Policy requires that Bidders, suppliers, and contractors under contracts, observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, :
- (a) defines, for the purposes of this provision, the terms set forth below as follows:
- (i) "corrupt practice" means the offering, giving, receiving, or soliciting, directly or indirectly, anything of value to influence improperly the actions of another party;
  - (ii) "fraudulent practice" means any act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation;
  - (iii) "coercive practice" means impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
  - (iv) "collusive practice" means an arrangement between two or more parties designed to achieve an improper purpose, including influencing improperly the actions of another party;
  - (v) "integrity violation" means any act, as defined under QESCO's Integrity Principles and Guidelines, which violates QESCO's Anticorruption Policy including corrupt, fraudulent, coercive, or collusive practice, abuse, and obstructive practice;
  - (vi) "obstructive practice" means (a) deliberately destroying, falsifying, altering or concealing of evidence material to QESCO's investigation; (b) making false statements to investigators in order to materially impede a QESCO's investigation; (c) failing to comply with requests to provide information, documents or records in connection with an Office of Anticorruption and Integrity (OAI) investigation; (d) threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the

investigation or from pursuing the investigation, or (e) materially impeding Employer contractual rights of audit or access to information.

- (b) will reject a proposal for award if it determines that the Bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices or other integrity violations in competing for the Contract;
- (c) will have the right to require that a provision be included in bidding documents and in contracts financed by Employer, requiring Bidders, suppliers and contractors to permit Employer or its representative to inspect their accounts and records and other documents relating to the bid submission and contract performance and to have them audited by auditors appointed by Employer.

3.2 Furthermore, Bidders shall be aware of the provision stated in GCC 9.6 and GCC 42.2.1 (c).

#### 4. Eligible Bidders

4.1 A Bidder may be a natural person, private entity, or government-owned enterprise subject to ITB 4.5 - or any combination of them with a formal intent to enter into an agreement or under an existing agreement in the form of a Joint Venture. In the case of a Joint Venture,

- (a) A foreign firm can only participate as a Joint Venture (JV) with a Pakistani Company in accordance with latest Pakistan Engineering Council (PEC) byelaws. "Selection and tendering process" It is clarified that Joint Venture/Consortium shall not be more than **THREE Partners/members**
- (b) Bidder as single entity must be duly licensed by Pakistan Engineering Council (PEC) in Category **C-B** having specialization code of CE-10 & EE-05 renewed for the year 2020-21. In case of Joint Venture with Foreign bidder, Local member of joint venture must be duly licensed by Pakistan Engineering Council (PEC) in category **C-1** having specialization code of CE-10 & EE-05 renewed for the year 2020-21. However, in case of a foreign bidder (as a member of JV), the foreign bidder shall obtain license in category **FC-B** from Pakistan Engineering Council in accordance with PEC Bye-Laws before start of any activity and submit an under taking to this effect.

Note: Pursuant to latest PEC bye-laws "Two or more licensees can apply jointly to construct or operate a project of a category higher than the category of their individual licenses provided that the cost of such project does not exceed the sum total of the limit of costs of projects permitted by the categories of the individual licensees. No separate license for such joint venture shall be required under these by-laws provided that the joint venture fulfills all other requirements of these bye-laws concerning such a project."

- (c) All partners shall be jointly and severally liable in case of a JV. The JV shall nominate a Representative who shall have the authority to conduct all business for and on behalf of any and all the partners of the JV during the bidding process and, in the event the JV is awarded the Contract, during contract execution.

- 4.2 A Bidder, and all partners constituting the Bidder, shall have the nationality of an eligible country, in accordance with Section 5 (Eligible Countries). A Bidder shall be deemed to have the nationality of a country if the Bidder is a citizen or is constituted, incorporated, or registered, and operates in conformity with the provisions of the laws of that country. This criterion shall also apply to the determination of the nationality of proposed subcontractors or suppliers for any part of the Contract including related services.
- 4.3 A Bidder shall not have a conflict of interest. All Bidders found to have a conflict of interest shall be disqualified. A Bidder may be considered to be in a conflict of interest with one or more parties in this bidding process if any of, including but not limited to, the following apply:
- (a) they have controlling shareholders in common; or
  - (b) they receive or have received any direct or indirect subsidy from any of them; or
  - (c) they have the same legal representative for purposes of this bid; or
  - (d) they have a relationship with each other, directly or through common third parties, that puts them in a position to have access to material information about or improperly influence the bid of another Bidder, or influence the decisions of the Employer regarding this bidding process; or
  - (e) a Bidder participates in more than one bid in this bidding process, either individually or as a partner in a Joint Venture, except for alternative offers permitted under ITB 13. This will result in the disqualification of all Bids in which it is involved. However, subject to any finding of a conflict of interest in terms of ITB 4.3 (a) - (d) above, this does not limit the participation of a Bidder as a subcontractor in another Bid or of a firm as a subcontractor in more than one Bid; or
  - (f) a Bidder, Joint Venture partner, associates, parent company or any affiliated entity, participated as a consultant in the preparation of the design or technical specifications of the plant and services that are the subject of the Bid; or
  - (g) a Bidder was affiliated with a firm or entity that has been hired (or is proposed to be hired) by the Employer as **Project Engineer** for the Contract; or
  - (h) a Bidder would be providing goods, works, or non-consulting services resulting from or directly related to consulting services for the preparation or implementation of the project specified in the BDS ITB 2.1 that it provided or were provided by any affiliate that directly or indirectly controls, is controlled by, or is under common control with that firm.
- 4.4 A firm shall not be eligible to participate in any procurement activities while under sanction by Employer pursuant to its Anticorruption Policy (see ITB 3), whether such sanction was directly imposed by Employer, or imposed by Employer pursuant to the Agreement for Mutual Enforcement of Debarment Decisions. A bid from a sanctioned or cross-debarred firm will be rejected.

- 4.5 Government-owned enterprises in the Employer's country shall be eligible only if they can establish that they (i) are legally and financially autonomous, (ii) operate under commercial law, and (iii) are not dependent agencies of the Employer.
- 4.6 A Bidder shall not be under suspension from bidding by the Employer as the result of the execution of a Bid–Securing Declaration.
- 4.7 Bidders shall provide such evidence of their continued eligibility satisfactory to the Employer, as the Employer shall reasonably request.
- 4.8 Firms shall be excluded if by an act of compliance with a decision of the United Nations Security Council taken under Chapter VII of the Charter of the United Nations, the Borrower's country prohibits any import of goods or contracting of works or services from that country or any payments to persons or entities in that country.
- 4.9 In case a prequalification process has been conducted prior to the bidding process, this bidding is open only to prequalified Bidders.
- 5. Eligible Plant and Services**
- 5.1 The plant and services to be supplied under the Contract shall have their origin in eligible source countries as defined in ITB 4.2 and all expenditures under the Contract will be limited to such plant and services.
- 5.2 For purposes of ITB 5.1 above, "origin" means the place where the plant, or component parts thereof are mined, grown, produced, or manufactured, and from which the services are provided. Plant components are produced when, through manufacturing, processing, or substantial or major assembling of components, a commercially recognized product results that is substantially in its basic characteristics or in purpose or utility from its components.

- 6.1 The Bidding Document consists of Parts I, II, and III, which include all the sections indicated below, and should be read in conjunction with any addenda issued in accordance with ITB 8.

- 6.2 The IFB issued by the Employer is not part of the Bidding Document.
- 6.3 The Employer is not responsible for the completeness of the Bidding Document and its addenda, if they were not obtained directly from the source stated by the Employer in the IFB.



- 6.4 The Bidder is expected to examine all instructions, forms, terms, and specifications in the Bidding Document. Failure to furnish all information or documentation required by the Bidding Document may result in the rejection of the Bid.
- 7. Clarification of Bidding Document, Site Visit, Pre-Bid Meeting**
- 7.1 A prospective Bidder requiring any clarification on the Bidding Document shall contact the Employer in writing at the Employer's address indicated in the BDS, or raise inquiries during the pre-bid meeting if provided for in accordance with ITB 7.4. The Employer will respond to any request for clarification, provided that such request is received no later than **14 days** prior to the deadline for submission of bids. The Employer's response shall be in writing with copies to all Bidders who have acquired the Bidding Document in accordance with ITB 6.3, including a description of the inquiry but without identifying its source. Should the Employer deem it necessary to amend the Bidding Document as a result of a request for clarification, it shall do so following the procedure under ITB 8 and ITB 24.2.
- 7.2 The Bidder is advised to visit and examine the site where the plant is to be installed and its surroundings and obtain for itself on its own responsibility all information that may be necessary for preparing the Bid and entering into a contract for the provision of plant and services. The costs of visiting the site shall be at the **Bidder's own expense**.
- 7.3 The Bidder and any of its personnel or agents will be granted permission by the Employer to enter its premises and lands for the purpose of such visit, but only upon the express condition that the Bidder, its personnel, and agents, will release and indemnify the Employer and its personnel and agents from and against all liability in respect thereof, and will be responsible for death or personal injury, loss of or damage to property, and any other loss, damage, costs, and expenses incurred as a result of the inspection.
- 7.4 The Bidder's designated representative is invited to attend a pre-bid meeting, if provided for in the BDS. The purpose of the meeting will be to clarify issues and to answer questions on any matter that may be raised at that stage.
- 7.5 The Bidder is requested to submit any questions in writing, to reach the Employer not later than 1 week before the pre-bid meeting.
- 7.6 Minutes of the pre-bid meeting, including the text of the questions raised, without identifying the source, and the responses given, together with any responses prepared after the meeting, will be transmitted promptly to all Bidders who have acquired the Bidding Document in accordance with ITB 6.3. Any modification to the Bidding Document that may become necessary as a result of the pre-bid meeting shall be made by the Employer exclusively through the issue of an addendum pursuant to ITB 8 and not through the minutes of the pre-bid meeting.
- 7.7 Nonattendance at the pre-bid meeting will not be a cause for disqualification of a Bidder.
- 8. Amendment of Bidding Document**
- 8.1 At any time prior to the deadline for submission of Bids, the Employer may amend the Bidding Document by issuing addenda.

- 8.2 Any addendum issued shall be part of the Bidding Document and shall be communicated in writing to all who have obtained the Bidding Document from the Employer in accordance with ITB 6.3.
- 8.3 To give prospective Bidders reasonable time in which to take an addendum into account in preparing their Bids, the Employer may, at its discretion, extend the deadline for the submission of Bids, pursuant to ITB 24.2.

### **C. Preparation of Bids**

- 9. Cost of Bidding** 9.1 The Bidder shall bear all costs associated with the preparation and submission of its Bid, and the Employer shall in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.
- 10. Language of Bid** 10.1 The Bid, as well as all correspondence and documents relating to the bid exchanged by the Bidder and the Employer, shall be written in the language specified in the BDS. Supporting documents and printed literature that are part of the Bid may be in another language provided they are accompanied by an accurate translation of the relevant passages into the language specified in the BDS, in which case, for purposes of interpretation of the Bid, such translation shall govern.
- 11. Documents Comprising the Bid** 11.1 The Bid shall comprise two envelopes submitted simultaneously, one containing the Technical Bid and the other the Price Bid, both envelopes enclosed together in an outer single envelope.
- 11.2 The Technical Bid submitted by the Bidder shall comprise the following:
- (a) Letter of Technical Bid;
  - (b) Undertaking of Bid Security , in accordance with ITB 21;
  - (c) alternative Bids, if permissible, in accordance with ITB 13;
  - (d) written confirmation authorizing the signatory of the Bid to commit the Bidder, in accordance with ITB 22.2;
  - (e) documentary evidence in accordance with ITB 14.1, that the plant and services offered by the Bidder in its Bid or in any alternative Bid, if permitted, are eligible;
  - (f) documentary evidence in accordance with ITB 15, the Bidder's eligibility and qualifications to perform the contract if its Bid is accepted;
  - (g) Technical Proposal in accordance with ITB 17.
  - (h) documentary evidence in accordance with ITB 16, that the plant and services offered by the Bidder conform to the Bidding Document;
  - (i) in the case of a bid submitted by a Joint Venture, the Bid shall include a copy of the Joint Venture Agreement entered into by all partners. Alternatively, a Letter of Intent to execute a Joint Venture Agreement in the event of a successful bid shall be signed by all partners and submitted with the Bid, together with a copy of the proposed agreement;
  - (j) list of subcontractors, in accordance with ITB 17.2; and
  - (k) any other document required in the BDS.

- 11.3 The Price Bid submitted by the Bidder shall comprise the following:
- (a) Letter of Price Bid;
  - (b) Bid Security or Bid-Securing Declaration, in accordance with ITB 21;
  - (c) completed schedules as required, including Price Schedules, in accordance with ITB 12 and ITB 18;
  - (d) alternative price Bids, if permissible, in accordance with ITB 13; and
  - (e) any other document required in the BDS.
- 12. Letter of Bid and Schedules**
- 12.1 The Letters of Technical Bid and Price Bid, and the Schedules, and all documents listed under ITB 11, shall be prepared using the relevant forms furnished in Section 4 (Bidding Forms). The forms must be completed without any alterations to the text, and no substitutes shall be accepted. All blank spaces shall be filled in with the information requested and as required in the BDS.
- 13. Alternative Bids**
- 13.1 The BDS indicates whether alternative Bids are allowed. If they are allowed, the BDS will also indicate whether they are permitted in accordance with ITB 13.3, or invited in accordance with ITB13.2 and/or ITB 13.4.
- 13.2 When alternatives to the Time Schedule are explicitly invited, a statement to that effect will be included in the BDS, and the method of evaluating different time schedules will be described in Section 3 (Evaluation and Qualification Criteria).
- 13.3 Except as provided under ITB 13.4 below, Bidders wishing to offer technical alternatives to the Employer's requirements as described in the Bidding Document must also provide: (i) a price at which they are prepared to offer a plant meeting the Employer's requirements; and (ii) all information necessary for a complete evaluation of the alternatives by the Employer, including drawings, design calculations, technical specifications, breakdown of prices, and proposed installation methodology and other relevant details. Only the technical alternatives, if any, of the lowest evaluated Bidder conforming to the basic technical requirements shall be considered by the Employer.
- 13.4 When Bidders are invited in the BDS to submit alternative technical solutions for specified parts of the facilities, such parts shall be described in Section 6 (Employer's Requirements). Technical alternatives for the specific parts of the facilities that comply with the performance and technical criteria specified for the plant and services shall be considered by the Employer on their own merits, pursuant to ITB 32.
- 14. Documents Establishing the Eligibility of Plant and Services**
- 14.1 To establish the eligibility of the plant and services in accordance with ITB 5, Bidders shall complete the Country of Origin Declaration Form included in Section 4 (Bidding Forms).
- 15. Documents Establishing the Eligibility and Qualifications of the Bidder**
- 15.1 To establish its eligibility and qualifications to perform the Contract in accordance with Section 3 (Evaluation and Qualification Criteria), the Bidder shall provide the information requested in the corresponding information sheets included in Section 4 (Bidding Forms).
- 15.2 Domestic Bidders, individually or in Joint Ventures, applying for eligibility for domestic preference shall supply all information required to satisfy the criteria for eligibility as described in ITB 38.

- 16. Documents Establishing Conformity of the Plant and Services**
- 16.1 The documentary evidence of the conformity of the plant and services to the Bidding Document may be in the form of literature, drawings and data, and shall furnish:
- (a) a detailed description of the essential technical and performance characteristics of the plant and services, including the functional guarantees of the proposed plant and services, in response to the Specification;
  - (b) a list giving full particulars, including available sources, of all spare parts and special tools necessary for the proper and continuing functioning of the plant for the period named in the BDS, following completion of plant and services in accordance with provisions of the contract; and
  - (c) a commentary on the Employer's Specifications and adequate evidence demonstrating the substantial responsiveness of the plant and services to those specifications. Bidders shall note that standards for workmanship, materials and equipment designated by the Employer in the Bidding Document are intended to be descriptive (establishing standards of quality and performance) only and not restrictive. The Bidder may substitute alternative standards, brand names and/or catalog numbers in its Bid, provided that it demonstrates to the Employer's satisfaction that the substitutions are substantially equivalent or superior to the standards designated in the Specifications.
- 17. Technical Proposal, Subcontractors**
- 17.1 The Bidder shall furnish a Technical Proposal including a statement of work methods, equipment, personnel, schedule and any other information as stipulated in Section 4 (Bidding Forms), in sufficient detail to demonstrate the adequacy of the Bidders' proposal to meet the work requirements and the completion time.
- 17.2 For major items of plant and services as listed by the Employer in Section 3 (Evaluation and Qualification Criteria), which the Bidder intends to purchase or subcontract, the Bidder shall give details of the name and nationality of the proposed Subcontractors, including Manufacturers, for each of those items. In addition, the Bidder shall include in its Bid information establishing compliance with the requirements specified by the Employer for these items. Bidders are free to list more than one Subcontractor against each item of the plant and services. Quoted rates and prices will be deemed to apply to whichever Subcontractor is appointed, and no adjustment of the rates and prices will be permitted.
- 17.3 The Bidder shall be responsible for ensuring that any Subcontractor proposed complies with the requirements of ITB 4, and that any plant, or services to be provided by the Subcontractor comply with the requirements of ITB 5 and ITB 15.1
- 18. Bid Prices and Discounts**
- 18.1 Unless otherwise specified in the BDS and/or Section 6 (Employer's Requirements), bidders shall quote for the entire plant and services on a "single responsibility" basis such that the total Bid price covers all the Contractor's obligations mentioned in or to be reasonably inferred from the Bidding Document in respect of the design, manufacture, including procurement and subcontracting (if any), delivery, construction, installation,

and completion of the plant. This includes all requirements under the Contractor's responsibilities for testing, pre-commissioning and commissioning of the plant and, where so required by the Bidding Document, the acquisition of all permits, approvals, and licenses, etc.; the operation, maintenance, and training services and such other items and services as may be specified in the Bidding Document, all in accordance with the requirements of the General Conditions. Items against which no price is entered by the Bidder will not be paid for by the Employer when executed and shall be deemed to be covered by the prices for other items.

- 18.2 Bidders are required to quote the price for the commercial, contractual and technical obligations outlined in the Bidding Document. If a Bidder wishes to make a deviation, such deviation shall be listed in the relevant form in Section 4 (Bidding Forms). The Bidder shall also provide the additional price if any, for withdrawal of the deviation.
- 18.3 Bidders shall give a breakdown of the prices in the manner and detail called for in the Price Schedules included in Section 4 (Bidding Forms). Where no different Price Schedules are included in the Bidding Document, Bidders shall present their prices in the following manner: Separate numbered Schedules included in Section 4 (Bidding Forms) shall be used for each of the following elements. The total amount from each Schedule (No. 1, 2 & 3) shall be summarized in a Grand Summary (Schedule No. 4) giving the total bid price(s) to be entered in the Letter of Price Bid. Absence of the total bid price in the Letter of Price Bid may result in the rejection of the Bid.

Schedule No. 1: Plant and Mandatory Spare Parts Supplied from  
Abroad/Local

Schedule No. 2: Installation and Other Services

Schedule No. 3: Vehicle for Employer/Engineer

Schedule No. 4: Grand Summary

Bidders shall note that the plant and mandatory spare parts included in Schedule No. 1 above exclude materials used for civil, building, and other construction works. All such materials shall be included and priced under Schedule No. 2, Installation and Other Services.

- 18.4 In the Schedules, Bidders shall give the required details and a breakdown of their prices as follows:
- (a) Plant to be Supplied from Abroad (Schedule No. 1):
- (i) the price of the plant shall be quoted carriage and insurance paid (CIP)-named place of **destination basis specified in the BDS**;
  - (ii) all customs duties and other taxes paid or payable in the Employer's country on the plant if the contract is awarded to the Bidder; and
  - (iii) the total price for the plant.
- (b) Plant Supplied from Within the Employer's Country (Schedule No. 1):
- (i) the price of the plant shall be quoted on an EXW Incoterm basis (ex works, ex factory, ex warehouse, ex showroom, as applicable), including all customs duties and sales and other taxes

- already paid or payable on the components and raw material used in the manufacture or assembly of plant quoted ex works or ex factory, or on the previously imported plant of foreign origin quoted ex warehouse, ex showroom; including Transportation to place of **destination basis specified in the BDS;**
- (ii) sales tax payable in the Employer's country on the plant if the contract is awarded to the Bidder, and
  - (iii) the total price for the plant.
- (c) Installation and Other Services (Schedule No. 2) shall be quoted separately and shall include rates or prices for local transportation, insurance, and other services incidental to delivery of the plant, all labor, contractor's equipment, temporary works, materials, consumables, and all matters and things of whatsoever nature, including operations and maintenance services, the provision of operations and maintenance manuals, training, etc., where identified in the Bidding Document, as necessary for the proper execution of the installation and other services, including all taxes, duties, levies, and charges payable in the Employer's country as of 28 days prior to the deadline for submission of bids.
- 18.5 The current edition of Incoterms, published by the International Chamber of Commerce shall govern.
- 18.6 The prices shall be either fixed or adjustable as specified in the BDS.
- (a) In the case of Fixed Price, prices quoted by the Bidder shall be fixed during the Bidder's performance of the contract and not subject to variation on any account. A Bid submitted with an adjustable price quotation will be treated as nonresponsive and rejected.
  - (b) In the case of Adjustable Price, prices quoted by the Bidder shall be subject to adjustment during performance of the contract to reflect changes in the cost elements such as labor, material, transport, and contractor's equipment in accordance with the procedures specified in the corresponding appendix to the Contract Agreement. A Bid submitted with a fixed price quotation will be treated as nonresponsive and be rejected. The Bidder shall furnish the indexes (e.g. for labor and materials), their weightings and source in the Tables of Adjustment Data included in Section 4 (Bidding Forms). The Employer may require the Bidder to justify its proposed indexes and weightings. Any bid that omits indexes and weightings shall be subject to clarification with the Bidder.
- 18.7 If so indicated in BDS 1.1, Bids are being invited for individual tranche (contracts) or for any combination of tranches (packages). Bidders wishing to offer any price reduction (discount) for the award of more than one contract shall specify in their Letter of Price Bid the price reductions applicable to each package, or alternatively, to individual contracts within the package, and the manner in which the price reductions will apply.

- 19. Currencies of Bid and Payment**
- 19.1 The currency(ies) of the bid shall be, as specified in the BDS.
- 19.2 Bidders may be required by the Employer to justify, to the Employer's satisfaction, their local and foreign currency requirements.
- 20. Period of Validity of Bids**
- 20.1 Bids shall remain valid for the period specified in the BDS after the bid submission deadline date prescribed by the Employer. A bid valid for a shorter period shall be rejected by the Employer as nonresponsive.
- 20.2 In exceptional circumstances, prior to the expiration of the bid validity period, the Employer may request Bidders to extend the period of validity of their Bids. The request and the responses shall be made in writing. If a bid security is requested in accordance with ITB 21, it shall also be extended 28 days beyond the deadline of the extended bid validity period. A Bidder may refuse the request without forfeiting its bid security. A Bidder granting the request shall not be required or permitted to modify its Bid.
- 21. Bid Security/ Bid Securing Declaration**
- 21.1 Unless otherwise specified in the BDS, the Bidder shall furnish as part of its Bid, in original form, either a Bid-Securing Declaration or a bid security as specified in the BDS. In the case of a bid security, the amount and currency shall be as specified in the BDS.
- 21.2 If a Bid-Securing Declaration is required pursuant to ITB 21.1, it shall use the form included in Section 4 (Bidding Forms). The Employer will declare a Bidder ineligible to be awarded a Contract for a specified period of time, as indicated in the BDS, if a Bid-Securing Declaration is executed.
- 21.3 If a bid security is specified pursuant to ITB 21.1, the bid security shall be, at the Bidder's option, in any of the following forms:
- (a) an unconditional bank guarantee,
  - (b) an irrevocable letter of credit,
  - (c) a cashier's check, or Cash Deposit Receipt (CDR)
- all from a reputable source from an eligible country as described in Section 5 (Eligible Countries). In the case of a bank guarantee, the bid security shall be submitted using either the Bid Security Form included in Section 4 (Bidding Forms) or another form acceptable to the Employer. The form must include the complete name of the Bidder. The bid security shall be valid for 28 days beyond the original validity period of the Bid, or beyond any period of extension if requested under ITB 20.2.
- 21.4 Unless otherwise specified in the BDS, any Bid not accompanied by a substantially compliant bid security or Bid-Securing Declaration, if one is required in accordance with ITB 21.1, shall be rejected by the Employer as non-responsive.
- 21.5 If a bid security is specified pursuant to ITB 21.1, the bid security of the unsuccessful Bidder shall be returned promptly upon the successful Bidder's furnishing of the performance security pursuant to ITB 46.
- 21.6 If a bid security is specified pursuant to ITB 21.1, the bid security of successful Bidders shall be returned promptly once the successful Bidder has signed the Contract and furnished the required performance security.

- 21.7 The bid security may be forfeited or the Bid-Securing Declaration executed, if
- (a) notwithstanding ITB 26.3, a Bidder withdraws its Bid during the period of bid validity specified by the Bidder on the Letters of Technical Bid and Price Bid, except as provided in ITB 20.2 or
  - (b) the successful Bidder fails to:
    - (i) sign the Contract in accordance with ITB 45;
    - (ii) furnish a performance security in accordance with ITB 46; or
    - (iii) accept the arithmetical corrections of its Bid in accordance with ITB 36.
- 21.8 If the bid security is required as per ITB 21.1, the bid security of a Joint Venture shall be in the name of the Joint Venture that submits the Bid. If the Joint Venture has not been legally constituted at the time of bidding, the bid security shall be in the name of any or all of the Joint Venture partners. If the Bid-Securing Declaration is required as per ITB 21.1, the Bid-Securing Declaration of a Joint Venture shall be in the name of the Joint Venture that submits the Bid. If the Joint Venture has not been legally constituted at the time of bidding, the Bid-Securing Declaration shall be in the names of all future partners as named in the letter of intent referred to in ITB 4.1.
- 22. Format and Signing of Bid**
- 22.1 The Bidder shall prepare one original set of the Technical Bid and one original set of the Price Bid comprising the Bid as described in ITB 11 and clearly mark it "ORIGINAL - TECHNICAL BID" and "ORIGINAL - PRICE BID". Alternative bids, if permitted in accordance with ITB 13, shall be clearly marked "ALTERNATIVE". In addition, the Bidder shall submit copies of the Bid, in the number specified in the BDS and clearly mark each of them "COPY." In the event of any discrepancy between the original and the copies, the original shall prevail.
- 22.2 The original and all copies of the Bid shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Bidder. This authorization shall consist of a written confirmation as specified in the BDS and shall be attached to the Bid. The name and position held by each person signing the authorization must be typed or printed below the signature. If a Bidder submits a deficient authorization, the Bid shall not be rejected in the first instance. The Employer shall request the Bidder to submit an acceptable authorization within the number of days as specified in the BDS. Failure to provide an acceptable authorization within the period stated in the Employer's request shall cause the rejection of the Bid. If either the Letter of Technical Bid or Letter of Price Bid or the Bid-Securing Declaration (if applicable) is not signed, the Bid shall be rejected.
- 22.3 A Bid submitted by a Joint Venture shall be signed so as to be legally binding on all partners.
- 22.4 Any amendments such as interlineations, erasures, or overwriting shall be valid only if they are signed or initialed by the person signing the Bid.



## D. Submission and Opening of Bids

- 23. Submission, Sealing, and Marking of Bids**
- 23.1 Bidders may submit their Bids by mail or by hand. When so specified in the BDS, Bidders shall have the option of submitting their Bids electronically. Procedures for submission, sealing and marking are as follows:
- (a) Bidders submitting Bids by mail or by hand shall enclose the original and each copy of the Bid, including alternative Bids, if permitted in accordance with ITB 13, in separate sealed envelopes, duly marking the envelopes as "ORIGINAL," "ALTERNATIVE," and "COPY." These envelopes containing the original and the copies shall then be enclosed in one single envelope. The rest of the procedure shall be in accordance with ITB 23.2 to ITB 23.6.
  - (b) Bidders submitting Bids electronically shall follow the electronic bid submission procedures specified in the BDS.
- 23.2 The inner and outer envelopes shall
- (a) bear the name and address of the Bidder,
  - (b) be addressed to the Employer in accordance with ITB 24.1, and
  - (c) bear the specific identification of this bidding process indicated in the BDS 1.1. and
  - (d) bear a warning not to open before the time and date for bid opening.
- 23.3 The outer envelopes and the inner envelopes containing the Technical Bid shall bear a warning not to open before the time and date for the opening of Technical Bid, in accordance with ITB 27.1.
- 23.4 The inner envelopes containing the Price Bid shall bear a warning not to open until advised by the Employer in accordance with ITB 27.7.
- 23.5 Alternative Bids, if permissible in accordance with ITB 13, shall be prepared, sealed, marked, and delivered in accordance with the provisions of ITB 20 and ITB 21, with the inner envelopes marked in addition "ALTERNATIVE NO...." as appropriate.
- 23.6 If all envelopes are not sealed and marked as required, the Employer will assume no responsibility for the misplacement or premature opening of the Bid.
- 24. Deadline for Submission of Bids**
- 24.1 Bids must be received by the Employer at the address and no later than the date and time indicated in the BDS.
- 24.2 The Employer may, at its discretion, extend the deadline for the submission of bids by amending the Bidding Document in accordance with ITB 8, in which case all rights and obligations of the Employer and Bidders previously subject to the deadline shall thereafter be subject to the deadline as extended.
- 25. Late Bids**
- 25.1 The Employer shall not consider any Bid that arrives after the deadline for submission of Bids, in accordance with ITB 24. Any Bid received by the Employer after the deadline for submission of Bids shall be declared late, rejected, and returned unopened to the Bidder.

- 26. Withdrawal, Substitution, and Modification of Bids**
- 26.1 A Bidder may withdraw, substitute, or modify its Bid after it has been submitted by sending a written notice, duly signed by an authorized representative, and shall include a copy of the authorization in accordance with ITB 22.2 (except for withdrawal notices, which do not require copies). The corresponding substitution or modification of the Bid must accompany the respective written notice. All notices must be:
- (a) prepared and submitted in accordance with ITB 22 and ITB 23 (except for withdrawal notices, which do not require copies), and in addition, the respective envelopes shall be clearly marked “WITHDRAWAL,” “SUBSTITUTION,” “MODIFICATION;” and
  - (b) received by the Employer prior to the deadline prescribed for submission of Bids, in accordance with ITB 24.
- 26.2 Bids requested to be withdrawn in accordance with ITB 26.1 shall be returned unopened to the Bidders.
- 26.3 No Bid may be withdrawn, substituted, or modified in the interval between the deadline for submission of Bids and the expiration of the period of bid validity specified by the Bidder on the Letter of Technical Bid or any extension thereof.
- 27. Bid Opening**
- 27.1 The Employer shall open the Technical Bids in public at the address, on the date, and time specified in the BDS in the presence of Bidder’s designated representatives and anyone who choose to attend. Any specific electronic bid opening procedures required if electronic bidding is permitted in accordance with ITB 23.1, shall be as specified in the BDS. The Price Bids will remain unopened and will be held in custody of the Employer until the specified time of their opening. If the Technical Bid and the Price Bid are submitted together in one envelope, the Employer may reject the entire Bid. Alternatively, the Price Bid may be immediately resealed for later evaluation.
- 27.2 First, envelopes marked “WITHDRAWAL” shall be opened and read out and the envelope with the corresponding Bid shall not be opened, but returned to the Bidder. No bid withdrawal shall be permitted unless the corresponding withdrawal notice contains a valid authorization to request the withdrawal and is read out at bid opening.
- 27.3 Second, outer envelopes marked “SUBSTITUTION” shall be opened. The inner envelopes containing the Substitution Technical Bid and/or Substitution Price Bid shall be exchanged for the corresponding envelopes being substituted, which are to be returned to the Bidder unopened. Only the Substitution Technical Bid, if any, shall be opened, read out, and recorded. Substitution Price Bid will remain unopened in accordance with ITB 27.1. No envelope shall be substituted unless the corresponding Substitution Notice contains a valid authorization to request the substitution and is read out and recorded at bid opening.
- 27.4 Next, outer envelopes marked “MODIFICATION” shall be opened. No Technical Bid and/or Price Bid shall be modified unless the corresponding Modification Notice contains a valid authorization to request the modification and is read out and recorded at the opening of Technical Bids. Only the Technical Bids, both Original as well as Modification, are to be opened, read out, and recorded at the opening. Price Bids, both Original as well as Modification, will remain unopened in accordance with ITB 27.1.

- 27.5 All other envelopes holding the Technical Bids shall be opened one at a time, and the following read out and recorded:
- (a) the name of the Bidder;
  - (b) whether there is a modification or substitution;
  - (c) the presence of a bid security or a Bid-Securing Declaration, if required; and
  - (d) any other details as the Employer may consider appropriate.

Only Technical Bids and alternative Technical Bids read out and recorded at bid opening shall be considered for evaluation. Unless otherwise specified in the BDS, all pages of the Letter of Technical Bid are to be initialed by at least three representatives of the Employer attending the bid opening. No Bid shall be rejected at the opening of Technical Bids except for late Bids, in accordance with ITB 25.1.

- 27.6 The Employer shall prepare a record of the opening of Technical Bids that shall include, as a minimum: the name of the Bidder and whether there is a withdrawal, substitution, or modification; and alternative Bids; and the presence or absence of a bid security or a Bid-Securing Declaration, if one was required. The Bidders' representatives who are present shall be requested to sign the record. The omission of a Bidder's signature on the record shall not invalidate the contents and effect of the record. A copy of the record shall be distributed to all Bidders who submitted Bids on time, and posted online when electronic bidding is permitted.

- 27.7 At the end of the evaluation of the Technical Bids, the Employer will invite bidders who have submitted substantially responsive Technical Bids and who have been determined as being qualified for award to attend the opening of the Price Bids. The date, time, and location of the opening of Price Bids will be advised in writing by the Employer. Bidders shall be given reasonable notice of the opening of Price Bids.

- 27.8 The Employer will notify Bidders in writing who have been rejected on the grounds of their Technical Bids being substantially nonresponsive to the requirements of the Bidding Document and return their Price Bids unopened.

- 27.9 The Employer shall conduct the opening of Price Bids of all Bidders who submitted substantially responsive Technical Bids, in the presence of Bidders' representatives who choose to attend at the address, on the date, and time specified by the Employer. The Bidder's representatives who are present shall be requested to sign a register evidencing their attendance.

- 27.10 All envelopes containing Price Bids shall be opened one at a time and the following read out and recorded:
- (a) the name of the Bidder;
  - (b) whether there is a modification or substitution;
  - (c) the Bid Prices, including any discounts and alternative offers; and
  - (d) any other details as the Employer may consider appropriate.

Only Price Bids, discounts, and alternative offers read out and recorded during the opening of Price Bids shall be considered for evaluation. Unless otherwise specified in the BDS, all pages of the Letter of Price Bid and Price

Schedules are to be initialed by at least three representatives of the Employer attending bid the opening. No Bid shall be rejected at the opening of Price Bids.

- 27.11 The Employer shall prepare a record of the opening of Price Bids that shall include, as a minimum: the name of the Bidder, the Bid Price (per tranche if applicable), any discounts, and alternative offers. The Bidders' representatives who are present shall be requested to sign the record. The omission of a Bidder's signature on the record shall not invalidate the contents and effect of the record. A copy of the record shall be distributed to all Bidders who submitted Bids on time, and posted online when electronic bidding is permitted.

### **E. Evaluation and Comparison of Bids**

- 28. Confidentiality**
- 28.1 Information relating to the evaluation of Bids and recommendation of contract award, shall not be disclosed to Bidders or any other persons not officially concerned with such process until publication of Contract award.
- 28.2 Any attempt by a Bidder to influence the Employer in the evaluation of the Bids or Contract award decisions may result in the rejection of its Bid.
- 28.3 Notwithstanding ITB 28.2, from the time of bid opening to the time of Contract award, if any Bidder wishes to contact the Employer on any matter related to the bidding process, it should do so in writing.
- 29. Clarification of Bids**
- 29.1 To assist in the examination, evaluation, and comparison of the Technical and Price Bids, and qualification of the Bidders, the Employer may, at its discretion, ask any Bidder for a clarification of its Bid. Any clarification submitted by a Bidder that is not in response to a request by the Employer shall not be considered. The Employer's request for clarification and the response shall be in writing. No change in the substance of the Technical Bid or prices in the Price Bid shall be sought, offered, or permitted, except to confirm the correction of arithmetic errors discovered by the Employer in the evaluation of the Bids, in accordance with ITB36.
- 29.2 If a Bidder does not provide clarifications of its Bid by the date and time set in the Employer's request for clarification, its Bid may be rejected.
- 30. Deviations, Reservations, and Omissions**
- 30.1 During the evaluation of Bids, the following definitions apply:
- (a) "Deviation" is a departure from the requirements specified in the Bidding Document;
  - (b) "Reservation" is the setting of limiting conditions or withholding from complete acceptance of the requirements specified in the Bidding Document; and
  - (c) "Omission" is the failure to submit part or all of the information or documentation required in the Bidding Document.
- 31. Examination of Technical Bids**
- 31.1 The Employer shall examine the Technical Bid to confirm that all documents and technical documentation requested in ITB 11.2 have been provided, and to determine the completeness of each document submitted. If any of these documents or information is missing, the Bid may be rejected.

- 31.2 The Employer shall confirm that the following documents and information have been provided in the Technical Bid. If any of these documents or information is missing, the offer shall be rejected.
- (a) Letter of Technical Bid;
  - (b) written confirmation of authorization to commit the Bidder;
  - (c) Undertaking of Bid Security, and
  - (d) Technical Proposal in accordance with ITB 17.
- 32. Responsiveness of Technical Bid**
- 32.1 The Employer's determination of a bid's responsiveness is to be based on the contents of the Bid itself, as defined in ITB11.
- 32.2 A substantially responsive Technical Bid is one that meets the requirements of the Bidding Document without material deviation, reservation, or omission. A material deviation, reservation, or omission is one that,
- (a) if accepted, would:
    - (i) affect in any substantial way the scope, quality, or performance of the plant and services specified in the Contract; or
    - (ii) limit in any substantial way, inconsistent with the Bidding Document, the Employer's rights or the Bidder's obligations under the proposed Contract; or
  - (b) if rectified, would unfairly affect the competitive position of other Bidders presenting substantially responsive Bids.
- 32.3 The Employer shall examine the technical aspects of the Bid submitted in accordance with ITB 17, Technical Proposal, in particular to confirm that all requirements of Section 6 (Employer's Requirements) have been met without any material deviation, reservation, or omission.
- 32.4 If a Bid is not substantially responsive to the requirements of the Bidding Document, it shall be rejected by the Employer and may not subsequently be made responsive by correction of the material deviation, reservation, or omission.
- 33. Nonmaterial Nonconformities**
- 33.1 Provided that a Bid is substantially responsive, the Employer may waive any nonconformities in the Bid that do not constitute a material deviation, reservation, or omission.
- 33.2 Provided that a Bid is substantially responsive, the Employer may request that the Bidder submit the necessary information or documentation, within a reasonable period of time, to rectify nonmaterial nonconformities in the Bid related to documentation requirements. Requesting information or documentation on such nonconformities shall not be related to any aspect of the Price Bid. Failure of the Bidder to comply with the request may result in the rejection of its Bid.
- 33.3 Provided that a Bid is substantially responsive, the Employer shall rectify quantifiable nonmaterial nonconformities related to the Bid Price. To this effect, the Bid Price shall be adjusted, for comparison purposes only, to reflect the price of a missing or nonconforming item or component. The adjustment shall be made using the method indicated in Section 3 (Evaluation and Qualification Criteria).

- 34. Detailed Evaluation of Technical Bids**
- 34.1 The Employer will carry out a detailed technical evaluation of the Bids not previously rejected as being substantially nonresponsive, to determine whether the technical aspects are in compliance with the Bidding Document. The Bid that does not meet minimum acceptable standards of completeness, consistency, and detail, and the specified minimum and/or maximum requirements for specified functional guarantees, will be treated as nonresponsive and hence rejected. To reach such a determination, the Employer will examine and compare the technical aspects of the bids on the basis of the information supplied by the Bidders, taking into account the following:
- (a) overall completeness and compliance with the Employer's Requirements; deviations from the Employer's Requirements; conformity of the plant and services offered with specified performance criteria; suitability of the plant and services offered in relation to the environmental and climatic conditions prevailing at the site; and quality, function and operation of any process control concept included in the Bid. The Bid that does not meet minimum and/or maximum acceptable standards of completeness, consistency, and detail will be rejected for non-responsiveness;
  - (b) type, quantity, and long-term availability of mandatory and recommended spare parts and maintenance services; and
  - (c) other relevant factors, if any, listed in Section 3 (Evaluation and Qualification Criteria).
- 34.2 Where alternative technical solutions have been allowed in accordance with ITB 13, and offered by the Bidder, the Employer will make a similar evaluation of the alternatives. Where alternatives have not been allowed but have been offered, they shall be ignored.
- 35. Eligibility and Qualification of the Bidder**
- 35.1 The Employer shall determine to its satisfaction during the evaluation of Technical Bids whether a Bidder meets the eligibility and qualifying criteria specified in Section 3 (Evaluation and Qualification Criteria).
- 35.2 The determination shall be based upon an examination of the documentary evidence of the Bidder's qualifications submitted by the Bidder, pursuant to ITB 15. Unless permitted in the BDS, the determination shall not take into consideration the qualifications of other firms such as the Bidder's subsidiaries, parent entities, affiliates, subcontractors (other than Specialist Subcontractors if permitted in the bidding document), or any other firm(s) different from the Bidder.
- 35.3 An affirmative determination shall be a prerequisite for the opening and evaluation of a Bidder's Price Bid. The Employer reserves the right to reject the bid of any bidder found to be in circumstances described in GCC 42.2.1(a). A negative determination shall result into the disqualification of the Bid, in which event the Employer shall return the unopened Price Bid to the Bidder.
- 35.4 The capabilities of the manufacturers and subcontractors proposed in its Bid for the major items of plant and services to be used by a Bidder will also be evaluated for acceptability in accordance with Section 3 (Evaluation and Qualification Criteria). Their participation should be

confirmed with a letter of intent between the parties, as needed. Should a manufacturer or subcontractor be determined to be unacceptable, the Bid will not be rejected, but the Bidder will be required to propose, without changing its bid price, an acceptable substitute manufacturer or subcontractor meeting the minimum technical specifications stated in Section 6 (Employer's Requirements). If a Bidder does not provide an acceptable substitute manufacturer or subcontractor by the date and time set in the Employer's request for substitution of manufacturer or subcontractor, its Bid may be rejected.

- 35.5 Prior to signing the Contract, the corresponding Appendix to the Contract Agreement shall be completed, listing the approved manufacturers or subcontractors for each item concerned.
- 36. Correction of Arithmetical Errors**
- 36.1 During the evaluation of Price Bids, the Employer shall correct arithmetical errors on the following basis:
- (a) where there are errors between the total of the amounts given under the column for the price breakdown and the amount given under the Total Price, the amounts given under the column for the price breakdown/Unit Price shall prevail and the Total Price will be corrected accordingly;
  - (b) where there are errors between the total of the amounts of Schedule Nos. 1 to 3 and the amount given in Schedule No. 4 (Grand Summary), the total of the amounts of Schedule Nos. 1 to 3 shall prevail and the Schedule No. 4 (Grand Summary) will be corrected accordingly;
  - (c) if there is a discrepancy between the grand total price given in Schedule No. 4 (Grand Summary) and the bid amount in **item (c)** of the Letter of Price Bid, the grand total price given in Schedule No. 4 (Grand Summary) will prevail and the bid amount in **item (c)** of the Letter of Price Bid will be corrected; and
  - (d) if there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetical error, in which case the amount in figures shall prevail subject to (a), (b), and (c) above.
- 36.2 If the Bidder that submitted the lowest evaluated Bid does not accept the correction of errors, its Bid shall be disqualified and its bid security may be forfeited or its Bid-Securing Declaration executed.
- 37. Conversion to Single Currency**
- 37.1 For evaluation and comparison purposes, the currency(ies) of the Bid shall be converted into a single currency as specified in the BDS.
- 38. Domestic Preference**
- 38.1 Unless otherwise specified in the BDS, domestic preference shall not apply.
- 39. Evaluation and Comparison of Price Bids**
- 39.1 The Employer shall use the criteria and methodologies listed in this clause. No other evaluation criteria or methodologies shall be permitted.
- 39.2 I. To evaluate a Price Bid, the Employer shall consider the following:
- (a) the bid price, excluding provisional sums and the provision, if any, for contingencies in the Price Schedules;

- (a) price adjustment for correction of arithmetical errors in accordance with ITB 36.1;
- (b) price adjustment due to discounts offered in accordance with ITB 18.7;
- (c) price adjustment due to quantifiable nonmaterial nonconformities in accordance with ITB 33.3;
- (d) converting the amount resulting from applying (a) to (c) above, if relevant, to a single currency in accordance with ITB 37;
- (e) assessment whether the bid is abnormally low in accordance with ITB 40; and
- (f) the evaluation factors indicated in Section 3 (Evaluation and Qualification Criteria).
- (g) The evaluation of the bid will exclude the Provincial Sales Tax (PST) and it shall not be taken into the Bid Price.

II. The Employer's evaluation of a Bid will exclude and not take into account,

- (a) in the case of Plant and Mandatory Spare Parts (Schedule No. 1) supplied from abroad, all taxes and duties, applicable in the Employer's country and payable on the Plant and Mandatory Spare Parts if the Contract is awarded to the Bidder; and
  - (b) in the case of Plant and Mandatory Spare Parts (Schedule No. 1) supplied from within the Employer's country, sales and other taxes, applicable in the Employer's country and payable on the Plant and Mandatory Spare Parts if the Contract is awarded to the Bidder.
- 39.3 If price adjustment is allowed in accordance with ITB 18.6, the estimated effect of the price adjustment provisions of the Conditions of Contract, applied over the period of execution of the Contract, shall not be taken into account in bid evaluation.
- 39.4 If this Bidding Document allows Bidders to quote separate prices for different tranches (contracts), and the award to a single Bidder of multiple tranches (contracts), the methodology to determine the lowest evaluated price of the tranches (contract) combinations, including any discounts offered in the Letter of Price Bid, is specified in Section 3 (Evaluation and Qualification Criteria).
- 39.5 If the Bid, which results in the lowest Evaluated Bid Price, is seriously unbalanced or front loaded in the opinion of the Employer, the Employer may require the Bidder to produce detailed price analyses for any or all items of the Price Schedules, to demonstrate the internal consistency of those prices with the methods and time schedule proposed. After evaluation of the price analyses, taking into consideration the terms of payments, the Employer may require that the amount of the performance security be increased at the expense of the Bidder to a level sufficient to protect the Employer against financial loss in the event of default of the successful Bidder under the Contract.
- 39.6 The Employer shall compare all substantially responsive Bids to determine the lowest evaluated Bid, in accordance with ITB 39.2.

#### **40. Abnormally Low Bids**

- 40.1 An abnormally low bid is one where the bid price, in combination with other elements of the bid, appears to be so low that it raises concerns as to the capability of the Bidder to perform the contract for the offered bid price.
- 40.2 When the offered bid price appears to be abnormally low, the Employer shall undertake a three-step review process as follows:
- (a) identify abnormally low costs and unit rates by comparing them with the



Engineer's estimates, other substantially responsive bids, or recently awarded similar contracts;

- (b) clarify and analyze the bidder's resource inputs and pricing, including overheads, contingencies and profit margins; and
- (c) Decide whether to accept or reject the bid.

40.3 With regard to ITB 40.2 (b) above, the Employer will seek a written explanation from the bidder of the reasons for the offered bid price, including a detailed analysis of costs and unit prices, by reference to the scope, proposed methodology, schedule, and allocation of risks and responsibilities. This may also include information regarding the economy of the manufacturing process; the services to be provided, or the construction method to be used; the technical solutions to be adopted; and any exceptionally favorable conditions available to the bidder for the works, equipment or services proposed.

40.4 After examining the explanation given and the detailed price analyses presented by the bidder, the Employer may:

- (a) accept the bid, if the evidence provided satisfactorily accounts for the low bid price and costs, in which case the bid is not considered abnormally low;
- (b) accept the bid, but require that the amount of the performance security be increased at the expense of the bidder to a level sufficient to protect the Employer against financial loss. The amount of the performance security shall generally be not more than 20% of the contract price; or
- (c) reject the bid if the evidence provided does not satisfactorily account for the low bid price, and make a similar determination for the next ranked bid, if required.

**41. Employer's Right to Accept Any Bid, and to Reject Any or All Bids**      41.1 The Employer reserves the right to accept or reject any Bid, and to annul the bidding process and reject all Bids at any time prior to contract award, without thereby incurring any liability to Bidders. In case of annulment, all Bids submitted and specifically, bid securities, shall be promptly returned to the Bidders.

**42. Notice of Intention for Award of Contract**      42.1 If Standstill provisions apply as specified in the BDS, the standstill period shall be defined in the BDS to specify the duration subsequent to notification of intention for award of contract (before making the actual contract award) within which any unsuccessful bidder can challenge the proposed award.

## **F. Award of Contract**

**43. Award Criteria**      43.1 The Employer shall award the Contract to the Bidder whose offer has been determined successful in line with ITB 34 to ITB 40 above to be the lowest evaluated Bid and is substantially responsive to the Bidding Document, provided further that the Bidder is determined to be eligible and qualified to perform the Contract satisfactorily.

43.2 The Employer reserves the right to accept any of the deviations submitted in accordance with ITB 18.2 by the lowest evaluated bidder, at the price shown for the deviation in the bid.

**44. Notification of Award**      44.1 Prior to the expiration of the period of bid validity and upon expiry of the standstill period specified in ITB 42.1, or upon satisfactory resolution of a complaint filed within standstill period, if applicable, the Employer shall transmit the Notification of Award using the form included in Section 9 (Contract Forms) to the successful Bidder, in writing, that its Bid has been

accepted. At the same time, the Employer shall also notify all other Bidders of the results of the bidding.

44.2 Unless standstill period applies, upon notification of award, unsuccessful Bidders may request in writing to the Employer for a debriefing seeking explanations on the grounds on which their Bids were not selected. The Employer shall promptly respond in writing and/or in a debriefing meeting to any unsuccessful Bidder who, after publication of contract award, requests a debriefing.

44.3 Until a formal contract is prepared and executed, the notification of award shall constitute a binding Contract.

44.4 Within 2 weeks of the award of contract or expiry of the standstill period, where such period applies, or, if a complaint has been filed within the standstill period, upon receipt of **Employer's Grievance committee** confirmation of satisfactory resolution of the complaint, the Employer shall publish in an English language newspaper or widely known and freely accessible website the results identifying the bid and tranche or package numbers, as applicable and the following information:

- (a) name of each Bidder who submitted a bid;
- (b) bid prices as read out at bid opening;
- (c) name and evaluated prices of each bid that was evaluated;
- (d) name of Bidders whose Bids were rejected and the reasons for their rejection; and
- (e) name of the winning Bidder, and the price it offered, as well as the duration and summary scope of the contract awarded.

44.5 The employer reserves the right to increase or decrease the quantities by 15%, at the time of issuance of Notification of award or during Contract Execution phase.

#### **45. Signing of Contract**

45.1 Promptly after notification, the Employer shall send the successful Bidder the Contract Agreement.

45.2 Within 28 days of receipt of the Contract Agreement, the successful Bidder shall sign, date, and return it to the Employer.

#### **46. Performance Security**

46.1 Within 28 days of the receipt of notification of award from the Employer, the successful Bidder shall furnish the performance security in accordance with the conditions of contract, subject to ITB 39.5 and ITB 40.4, using for that purpose the Performance Security Form included in Section 9 (Contract Forms), or another form acceptable to the Employer. If the institution issuing the performance security is located outside the country of the employer, it shall have a correspondent financial institution located in the country of the employer to make it enforceable.

46.2 Failure of the successful Bidder to submit the abovementioned Performance Security or sign the Contract shall constitute sufficient grounds for the annulment of the award and forfeiture of the bid security or execution of the Bid-Securing Declaration. In that event, the Employer may award the Contract to the next lowest evaluated Bidder whose offer is substantially responsive and is determined by the Employer to be qualified to perform the Contract satisfactorily.

#### **47. Bidding-Related Complaints**

47.1 The procedures for dealing with Bidding-Related Complaints arising out of this bidding process are specified in the BDS.

## **1. Evaluation**

### **1.1 Technical Evaluation**

In addition to the criteria listed in ITB 34.1 (a) - (b), other relevant factors are as follows:

Evaluation of the Bidder's Technical Proposal will include an assessment of the Bidder's technical capacity to mobilize key equipment and personnel for the contract consistent with its proposal regarding work methods, scheduling, and material sourcing in sufficient detail and fully in accordance with the requirements stipulated in Section 6 (Employer's Requirements).

Non-compliance with equipment and personnel requirements described in Section 6 (Employer's Requirements) shall not normally be a ground for bid rejection and such non-compliance will be subject to clarification during bid evaluation and rectification prior to contract award.

### **1.2 Alternative Technical Solutions**

Technical alternatives under ITB 13.4 shall not be permitted.

### **1.3 Economic Evaluation**

In addition to the criteria listed in ITB 39.2 I (a)–(f), other relevant factors are as follows:

Adjustments in price that result from the procedures outlined below shall be added, for purposes of comparative evaluation only, to arrive at an "Evaluated Bid Price." Bid prices quoted by Bidders shall remain unaltered.

#### **1.3.1 Quantifiable Deviations and Omissions**

Pursuant to ITB 33.3, the cost of all quantifiable nonmaterial nonconformities or omissions from the contractual and commercial conditions shall be evaluated. The Employer will make its own assessment of the cost of any nonmaterial nonconformities and omissions for the purpose of ensuring fair comparison of Bids.

##### **(a) Financial Adjustment of Bid Price (Commercial Aspects)**

The evaluation of a bid will take into account, in addition to the Bid Price, the following commercial factors (adjustments) in the manner and the extent indicated hereof, to determine the Evaluated Bid Price.

##### **i. Price Adjustment for Deviation in Terms of Payment**

If a bid deviates from the terms of payment/payment conditions as specified in the Conditions of Contract and if such deviation is considered acceptable to the Employer for a range of 10%, mark-up earned for any earlier payments involved in the terms outlined in the bid as compared to those stipulated in the Conditions of Contract shall be calculated at the following mark-up rates:

- for foreign currency component : 5 % per annum
- for local currency component :10 % per annum

And shall be added to the Corrected Total Bid Price for comparison purposes only.

The invoice will be done as per the actual work done at Site.

##### **ii. Price Adjustment on account of Late Completion (NOT APPLICABLE)**

**(b) Financial Adjustment of Bid Price (Technical Aspects)**

In addition to price adjustment due to commercial aspects, the price of bid will also be adjusted on account of minor technical omission/noncompliance and due to minor omissions or missing items in the scope of supply, services, etc. in the manner and to the extent indicated hereof, to determine the Evaluated Bid Price.

**i. Price Adjustment for Completeness in Scope of Supply**

The cost of minor missing items in the scope of supply, services, etc. shall be added to the bid price to allow for bid comparison on an equal basis. The price adjustment shall be based on a reasonable estimate of the cost by the bid evaluation committee, taking into consideration the corresponding quoted prices from next higher responsive bid.

**1.3.2 Time Schedule**

Time to complete the plant and services for each tranche from the effective date specified in Article 3 of the Contract Agreement for determining time for completion of commissioning activities shall be **450** days maximum. The adjustment rate in the event of completion beyond the minimum period shall be half of a percent (**0.5%**) for each week of delay with maximum period of 70 days. Tolerance above, the bid will be rejected. No credit will be given for completion earlier than the minimum designated period.

- (b) Plant and Mandatory Spare Parts supplied from abroad shall be quoted **CIP** (Section 4, Bidding Forms, Schedule No. 1) and Plant and Mandatory Spare Parts supplied from within the Employer's country shall be quoted **EXW** (ex-works, ex-factory, ex-warehouse, ex-showroom, or off-the-shelf, as applicable)+ **Inland Transportation, free of Sales Tax** (Section 4, Bidding Forms, Schedule No. 1).
- (c) All other cost components for services and works such installation and commissioning shall be quoted separately (Section 4, Bidding Forms, Schedule No. 2).
- (d) In the comparison of Bids, only the CIP price component of each Bid for the Plant and Equipment offered from outside the Employer's country shall be increased by 15%.

- (e) No domestic preference shall be applied to any of the Services or Works included in the contract.
- (f) Bidders shall not be permitted or required to modify the mix of local and foreign Plant and Equipment after bid opening.

## 1. Scope of Supply of Plant and Services

The scope of work includes manufacture, insurance to Site(s), delivery to wharf at port of Karachi, unloading and loading at Karachi, transportation to the transmission lines site, unloading and storage at site, installation, testing and commissioning of Plant as specified here below and listed in the Price Schedules.

Procurement of Plant-Design, Manufacture, Supply and Construction of foundations, Erection of Towers, Installation of Transmission Line conductor, Hardware, accessories, Insulators, Stock bridge dampers, Stringing, Testing and Commissioning of (Coastal/Non-Coastal areas) for interconnection of Isolated Gwadar/Makran area with National Grid System of Pakistan.

**Tranche-01**                      **T/Line #4.** 132kV D/C Transmission line from 132 kV Grid station Panjgoor to 132kV Grid Station Nag (new) (134.5 km).

**Tranche-02**                      **T/Line #5.** 132kV D/C Transmission line from 132 kV Grid station Nag (new) to 132kV Grid Station Basima (85 km).  
**T/Line #6.** 132kV D/C Transmission line from 132 kV Grid station Basima to 132kV Grid Station Nal (67 km).

All materials, tools, equipment and services, necessary for the reliable and safe operation of the transmission line whether specified in these Documents or not, shall be included in the Bids.

The scope of work includes the Procurement of Plant-Design, Manufacture, Supply and Construction of foundations, Erection of Towers, Installation of Transmission Line conductor, Hardware, accessories, Insulators, Stock bridge dampers, Stringing, Testing and Commissioning of 132kV Transmission Lines as per Volume – II, Technical Provisions of these Bidding Documents.

The Lines shall be of AASC “Cairo” conductor per phase for 132kV having overhead alumoweld shield wire.

## 2. Specifications

- 2.1 All designs, equipment, materials and workmanship shall comply with and be tested in accordance with requirements of the specifications. Equipment or parts, which are not covered by the specifications, shall comply with rules, codes and regulations of the international electro-technical commission or approved National Standardizing bodies.
- 2.2 The general intent of these Specifications is to require the supply of equipment and materials equal or superior to those actually described herein. Unless otherwise stated, reference to the brand or manufacture, if make is only for the sake of comparison as type, design, character or quality of the equipment and materials desired and shall not be interpreted as eliminating other equipment and materials of equal performance, quality and durability.
- 2.3 The Technical Provisions are provided separately in Volume – II of the Bidding Documents. The equipment/material shall be supplied in strict conformity of these specifications.
- 2.4 Type Test requirements have been delineated in “Latest Revised Type Test Policy” issued by NTDC. An undertaking in context of said Policy is required to be submitted by the Bidder at the Bidding Stage. “Form: Undertaking for Type Test of Equipment” are attached herewith as **Annexure-A**.

The ordered plant/equipment shall be subject to tests as per relevant provisions of the specification. The Bidder shall also supply type test reports from reputed independent laboratory along with the bid for the equipment offered as per NTDC Type Test Policy (revised to date).

In case the type test reports furnished by the bidder are not from one of reputed independent testing laboratories accredited by STL (Short Circuit Testing Liaison) or HV&SC Rawat Lab Pakistan or not relevant to the equipment offered or do not meet or comply with the rating and other requirements of the Purchaser’s specifications included in this bidding document

or are otherwise not to the satisfaction of the purchaser in any respect, the bidder will have to arrange necessary type testing in case of award at any of the reputed/ recognized independent testing laboratory accredited by STL or HV&SC Rawat Lab Pakistan, entirely at his cost and arrangements, including the expenses for witnessing the type test by one representative of the Employer and one representative of Consultant covering all the expenditures of the each member of inspection team for living, boarding lodging in an A Class Hotel, inland transportation, return air tickets, etc. will be borne by the contractor whereas daily allowance will be US\$ 200/- per day per person for foreign visit and Rs. 5,000/- per day per person for local visit, without effecting stipulated delivery schedule.

The employer and one representative of Consultant shall be entitled to attend and witness the aforesaid tests (Factory Acceptance/Pre-shipment) of plant/equipment/material and/or inspection, provided that the Contactor shall bear all costs and expenses incurred in connection with such attendance, covering all the expenditures of the each member of inspection team for living, boarding lodging in an A Class Hotel, inland transportation, return air tickets, etc. will be borne by the contractor whereas daily allowance will be US\$ 200/- per day per person for foreign visit and Rs. 5,000/- per day per person for local visit, without effecting stipulated delivery schedule.

In case the Goods fail to withstand any test, the cost of repeating such test and the cost of witnessing such test by the approved representatives shall be borne by the Contractor and the equipment released or modified to the satisfaction of the Employer without any additional cost to him.

### 3. Drawings

3.1 The Drawings are provided separately in Volume – II of the Bidding Documents.

3.2 The Contract shall be executed in strict conformity with the Drawings given or mentioned in Volume- II of the Bidding Document and the Contractor shall do no „Work“ without proper specifications, instructions and/or Drawings.

3.3 Specifications and/or drawings are intended to complement each other so that if anything is shown on the drawings as required but not mentioned in the specifications or vice versa, It shall be of like effect as if shown or mentioned in both. If any errors, omissions or discrepancies are found in the figures, specifications and/or drawings or, if any feature shall appear to the supplier to be indefinite or unclear, the same shall be referred to the Employer whose written explanation and/or clarification shall be obtained before proceeding with the



work.

- 3.4 The Contractor shall submit to the Employer within 30 days of the issuance of the Notification of Award, for approval of the Employer, copies of all drawings, technical literature, data, operation and maintenance instruction books and /or manuals required under the specifications, in accordance with the Schedule given Supplementary Information and such other documents as required in the Technical Provisions and other provisions of the Bidding Document. Employer shall review the submittal and return one copy to the Contractor marked “Approved” / “Approved Except as Noted”. If Employer deems necessary changes or modifications to be made therein, the same shall be returned marked “Returned for Correction” to the Contractor.
- 3.5 The Contractor after incorporating the desired changes in the drawings shall resubmit four (4) Sets of the same to the Employer for approval. Two prints of which shall be stamped “Approved” by the Employer and returned to the Contractor for his record.
- 3.6 On completion of the Contract, the Contractor shall deliver to the Employer all approved drawings, technical literature, data in accordance with the Schedule given in Clause SI-06 which shows the work in the final or “As Built” condition. The said drawings and documents shall be permanent and non-fad able. In addition to above, two editable soft copies of above mentioned final drawings made on Auto-CAD (latest version) and Final as Build Plan and Profile made on PLS-CADD Genuine/original Version, on two separate CDs/USBs shall also be provided to the Employer.
- 3.7 The Contractor shall allow fourteen (14) days for the Employer’s approval of drawings in his schedule of work and in the time allowed for completion of the Contract. Extra time required for approval of drawings due to deficiencies in design or errors in submitted drawings shall be the responsibility of the Contractor and no extension in time will be allowed on this account.
- 3.8 All drawings and documents furnished by the Contractor in accordance with the Contract shall become the property of the Employer.
- 3.9 Wherever reference is made in the Technical Provisions to specific standards and codes to be met by the plant and materials to be furnished or tested, the provisions of the latest current edition or revision of the relevant standards or codes in effect shall apply, unless otherwise expressly stated in the Contract. Where such standards and codes are national or relates to a particular country or regions, other authoritative standards that ensure substantial equivalence to the standards and codes specified will be acceptable. IEC Standard Equivalence will be preferred.
- 3.10 All correspondence, literature, drawings, name plates, diagrams, applicable data, equipment details, instructions and maintenance books and manuals, spare parts, books and descriptive data shall be in the **English language** only.

#### **4. Supplementary Information**

##### **SI-01 ACQUAINTANCE WITH SITE**

The Contractor shall be deemed to have inspected and examined all the line route and its surroundings and information available in connection therewith and before submitting his Bid, as to the form and nature thereof, including the subsurface conditions, the hydrological and climatic conditions, the extent and nature of Installation Services and Plant necessary for the completion of the Facilities, the means of access to the Site and the accommodation he may require and, in general, shall be deemed to have obtained all necessary information, subject as above mentioned, as to risks, contingencies and all other circumstances which may influence or affect his Bid.

##### **SI-02 DESCRIPTION OF PROJECT**

### SI-02.1 Possession of Site

Save, in so far as the Contract may prescribe, the extent of portions of the Site of which, the Contractor is to be given possession from time to time and the order in which such portions shall be made available to him and subject to any requirement in the Contract as to the order in which work shall be executed. ### SI-03 SITE CONDITIONS

#### SI-03.1 Site Conditions and Meteorological Data

- (2) Employer does not guarantee the correctness of any data provided herein nor any interpretations, deductions or conclusions relative to subsurface conditions at Site. The Bidder/Contractor must form his own opinion of the character of the work and of the materials to be excavated. He must make his own interpretations, and satisfy himself by his own investigations and research regarding all conditions affecting the work to be done. The Bidder/Contractor must assume all responsibility for deductions / conclusions as to the nature or conditions of the materials to be excavated and of doing other work affected by the geology at the Site.

## **SI-04 MATERIAL AND WORKMANSHIP**

### **SI-04.1 Material And Workmanship**

- (1) All materials, manufacturing, testing and workmanship of Plant shall comply with the requirements of the Contract Documents. Plant or parts which are not covered by these Specifications shall comply with the applicable standards, rules, codes and regulations of the internationally approved standardizing bodies.
- (2) In choosing materials and their finishes due regard shall be given to the conditions prevailing at Site.
- (3) All matters relating as to the acceptability or otherwise of the Plant offered under this Contract shall be decided by the Employer whose decision shall be final.

### **SI-04.2 Extent of Specifications**

The extent of the Contract Documents is to provide for the Facilities herein specified to be fully complete in every detail for the function designated. All Facilities which are not specifically mentioned in the Contract Documents, but which, in the opinion of the Employer, are usual or necessary for the satisfactory completion of the Facilities shall be deemed to be included in the Contract and shall be provided by the Contractor without extra cost to Employer.

## **SI-05 PLANT AND INSTALLATION SERVICES BY CONTRACTOR**

The works to be performed under these specifications on the rates provided in the Price Schedule include, but not limited to the following:

1. Clearing right -of-way;
2. Alignment of line route (diverted portion).
3. Check Survey and Check Survey report for already surveyed portion, Construction of Foundations/ Piles.
4. Detailed survey using latest techniques of RTK (diverted portion);
5. Sub-soil investigation along the route including Laboratory tests (confirmatory);
6. Preparation of plan & profile drawings, tower spotting etc. using PLS CADD genuine/original software (diverted portion);
7. Preparation of construction structure list;
8. Material calculation including detailing of tower/Pole fabrication drawings;
9. Ordering/Procurement of the finally required quantity of transmission line materials like towers including stub angles (to be procured as per tower fabrication drawings), conductor and AWS along with associated equipment & hardware, insulators, hardware, accessories, stock bridge dampers, aircraft warning spheres balls. Grounding materials and required spare parts including hydraulic compressors with dies etc.;
10. Manufacturing, testing, furnishing, packing, insuring, delivery to site & storing the Goods;
11. Surveying of tower site, tower staking and establishing correct location of footings;
12. Excavation, grading, blasting and backfill, installing tower grounding as per Technical Provisions and Specification drawings, including disposal of surplus excavated material;

13. Furnishing materials and constructing reinforced concrete tower foundations including installation of Stub Angles as per Technical Provisions and Specification drawings;
14. Loading of transmission line materials from the site stores, transporting and distributing/unloading at the sites of installation;
15. Erection of steel towers/Poles;
16. Installing of insulator assemblies for conductors,
17. Stringing of conductors, overhead shield wire(s) by controlled tension method complete with all accessories and dampers;
18. Installing tower signs (Danger signs, Number signs, Aerial markers etc.), anti-climbing devices complete with barbed wire and aircraft warning spheres balls.
19. Cleaning-up of right-of-way;
20. Testing and commissioning
21. Provision of Spare Parts (including Operation & Maintenance etc.) in accordance with the requirements; and
22. Any other item which is not included here but is necessary for integrated operation of the Transmission Line as advised by the Employer.

**NOTE:**

- (1) QESCO will not supply any material / goods, which is to be installed / erected at the site.
- (2) QESCO shall not give any equipment/T&P for survey, foundation, erection and stringing to the Contractor for this project. It is also mentioned that the stringing equipment/T&P and other construction equipment/T&P shall be arranged by the Contractor.
- (3) The Contractor is responsible to mobilize sufficient numbers of crews for surveying, foundations, tower erection and stringing each equipped with T&P complete in all respects for smooth execution of each activity. Contractor is responsible for timely completion, to adhere to the project schedule and ensure that the sufficient resources are available with the crews before commencement of each activity. Detailed methodology and list of T&P should be got approved from the Employer well before the commencement of each activity. The detail of construction equipment/T&P to be arranged/imported from abroad by the Contractor must be furnished in his Bid.
- (4) In case Contractor fails to arrange the required numbers of crews along with requisite T&P in good working condition for inspection at site prior to commencement of respective activity, the Employer has the right, in addition to withhold current payment, terminate the Contract and forfeit the Performance Security at any stage and to get executed the balance Installation Services through other contractors at the Contractor's risk and cost. At Bidding stage the Bidder shall submit an undertaking to this effect on the "Form: Undertaking for supply of equipment required for execution / construction of the project" provided in Section 4-Bidding Forms.

**SI-06 DRAWINGS**

**SI-06.1 Drawings in Contract**

**SI-06.1.1 Specification Drawings**

The specification drawings contained in Volume – II of the Bidding Documents show the scope of work to be performed by the Contractor which are the reference drawings to be used for filling the Schedule of Prices only. These Drawings shall

not be used for the execution of the Work unless the Employer gives specific instructions for such use.

### **SI-06.1.2 Contractor's Bid Drawings**

The Contractor's Bid drawings are the drawings prepared by the Contractor for bidding purposes, and shall be part of his Bid.

The specification drawings and Contractor's Bid drawings shall not be used for execution of the Works unless specific instructions for such use are given by the Employer.

### **SI-06.1.3 Approved Drawings**

The work shall be performed in accordance with the approved drawings in terms of Clause 20 of the General Conditions of Contract.

### **SI-06.2 Drawings and Other Data to be furnished by the Contractor**

All drawings and other data shall be in English language and all dimensions shall be in Metric System. Symbols shall be in accordance with IEC standards. All drawings/data submitted for approval shall conform to ISO paper sizes A0 to A4. All drawings shall be clearly marked:

The Contractor shall submit detailed civil, electrical and mechanical drawings for approval by the Employer, in accordance with Sub-Clause 20.3 of the General Conditions of the Contract, within the time schedule to be submitted under Sub-Clause 18.2 of General Conditions of Contract.

### **SI-06.2.1 Line Route, Outline, Plant and Equipment Drawings and Specific Plant Data**

The Contractor shall submit the line route for the diverted section (if required), outline drawings, drawings and Specific Plant Data of all the installation services and Plant and Equipment within thirty (30) days after signing of Contract for approval of the Employer, together with overall and handling weights and dimensions of the Plant & Equipment to be provided under the Contract.

### **SI-06.2.2 Detail Drawings**

The Contractor shall submit, detail drawings as required herein and in accordance with schedule to be made by the Contractor according to Sub-Clause 18.2 of General Conditions of Contract. All computations, drawings, functional description of Plant and Equipment, schemes and other information required to check adequacy of the design shall accompany with the drawings submitted for approval. The drawings shall be complete in all respects, shall have been reviewed and checked by the Contractor and shall be submitted in due time and in logical order to facilitate proper coordination.

### **SI-06.2.3 Drawings, Data and Instruction Manuals**

The following detail drawings shall be submitted in both soft and hard form within the time stated herein and above in accordance with the Schedule stipulated in Sub-Clause 18.2 of General Conditions of Contract:

- 1) **Steel Towers/Poles**
  - i. Detail fabrication and shop drawings of steel towers material including gusset plates & bolts etc;
  - ii. Bill of quantity for required tower material shall indicate quantity and information related to size of angles and tower hardware, material

type, unit and total weight of black section and weight after galvanization;

- iv. Packing details;
- v. Any other information and drawing which may be required by the Employer ; and
- vi. Tower load testing program indicating details of tests & tentative schedule.

## **2) Conductor and Alumoweld Shield Wire along with associated equipment**

Detail drawings of reels and Specific Plant Data, test program indicating details of tests & tentative schedule, other drawings and data required to be submitted in the Specifications.

## **3) Accessories**

Dimensioned drawings, Specific Plant Data for each item including packing drawings, installation instructions and test program indicating details of tests & tentative schedule.

## **4) Stock bridge Vibration Dampers**

Dimensioned drawings, Specific Plant Data including packing details, installation instructions, spacing data and test program indicating the details of tests and tentative schedule.

## **5) Insulators & Hardware**

Dimensioned drawings of insulators & hardware, Specific Plant Data, packing drawings and test program indicating details of all tests to be carried out and their tentative schedule.

## **6) Installation Services**

- i. Route map, plan & profile drawings for any diverted line route (if required) and after check survey, showing spotted towers, construction structure list, soil investigation reports (if required) and other data as required by the Employer .
- ii. Foundation drawings proposal for each tower for conventional as well as pile foundations and stub joint arrangement drawings.
- iii. Drawings (if required) indicating crossings of transmission line over Railway tracks and Highways along with foundation design calculations.
- iv. Specifications and details of concrete mix ratio and aggregate grading.
- v. Sag-templates for tower spotting.
- vi. Sag-tension and stringing tables for construction purposes.
- vii. Sets of construction drawings showing assembly & fabrication of towers, insulators & hardware, conductor, Aluminum Clad shield wire, accessories and stock bridge vibration dampers etc.
- viii. Any other information and drawing which may be required for construction purposes.

### **SI-06.2.4 Data Other Than Drawings**

All of the applicable requirements of this Clause with reference to the drawings to be prepared by the Contractor shall apply equally to catalogues, illustrations, printed specifications or other data submitted for approval.

### **SI-06.3 Submission and Approvals**

#### **SI-06.3.1 Drawings/data for Approval**

Drawings/data for approval shall be distributed to addresses and in number as specified in Clause SI-06.3.6 hereof.

All drawings / Data submitted for approval shall be provided with a blank white space, approximately 90mm height by 120mm with width, near the lower right-hand corner to be used for notations by the Employer.

#### **SI-06.3.2 Approval of Drawings/data**

- (1) All Drawings submitted for Approval will be reviewed and stamped by the **Employer** and will be marked "APPROVED" "APPROVED EXCEPT AS NOTED" or "RETURNED FOR CORRECTION" on the relevant drawings. One print will be returned to the Contractor. The other shall be retained by the Employer for his own use and for the use of the Employer and shall serve as the Master Copy and shall prevail in case of any doubt or discrepancy subsequently arising.
- (2) If the drawing is returned to the Contractor stamped "APPROVED" he may immediately proceed with the Works. Any drawing marked "APPROVED" by the Employer shall be known as an "Approved Drawing".
- (3) If the drawing is returned to the Contractor stamped "APPROVED EXCEPT AS NOTED" he may proceed with the Facilities taking into account the corrections and comments noted on the drawing. The Contractor shall revise the drawings as required and resubmit them in the same route as before for record purposes.
- (4) If the drawing is returned to the Contractor stamped "RETURNED FOR CORRECTION" he shall not proceed with the Works but shall make the changes and corrections or prepare new drawings and resubmit the revised drawing to the Employer for approval at no change in price or Schedule. Resubmitted prints and calculations will be subject to the same routine as before. Time required for such revisions and re-submittal of drawings or calculations will not entitle the Contractor to any extension in contract time.
- (5) If the Contractor does not agree with exceptions taken by the Employer, the Contractor shall state in his letter of re-submittal his reasons for not complying with the Employer exceptions. Revision number and date and description of change shall be shown on all drawings or calculations revised.

#### **SI-06.3.3 Work Prior to Approval**

Any work done prior to the approval of drawings/data shall be at the Contractor's risk. The Employer shall have the right to request additional details and to require the Contractor to make any change in the design, which are necessary to conform to the provisions and intent of these Specifications and such changes shall be made without additional cost to the Employer. The approval of the drawings/data by the Employer shall not be construed as a complete check but will indicate only that the general method of construction and detailing is satisfactory. Approval by the Employer of the Contractor's drawings/data shall not be held to relieve the Contractor of the obligations to meet all the requirements of these Specifications or of the responsibility for the correctness of the Contractor's drawings/data or for correct fit of assembled Plant furnished by the Contractor.

#### **SI-06.3.4 Sequence of Submission**

The sequence of submission of all drawings shall be such that all information is available for checking each drawing when it is received.

### SI-06.3.5 Approved Drawings and Revision

All approved drawings and data shall form a part of the Contract. If revisions are made after a drawing has been approved, the Contractor shall furnish for approval additional copies specified for the initial submission, subsequent to each revision.

### SI-06.3.6 Distribution of Drawings and Documents

The drawings and documents (as applicable) shall be submitted to Employer within the time given in the Contract or within such reasonable time as the Employer may require, and in the number as specified hereunder. The Employer shall provide the required Drawings/Data /Documents to the Employer.

### SI-06.3.7 As-Built Drawings (Record Drawings)

In the event of the Plant or any part thereof being, with the approval of the Employer, properly built-in or installed otherwise than in accordance with the Approved Drawings, then the Contractor shall ensure that the Approved Drawings are marked up to show the conditions of the Plant as installed and at least two (2) copies of such marked up drawings shall be submitted by the Contractor to the Employer for



approval. One copy of each of marked up drawings approved by the Employer shall be returned to the Contractor by the Employer and these shall be used for the preparation of the As-Built Drawings pursuant to Clause 20 of the General Conditions of Contract.

A further copy of each of the marked up drawings shall be retained by the Employer for the purpose of checking the As-Built Drawings.

The Contractor shall furnish to the Employer six (06) complete sets of all Record Drawings and Data prior to issue of the Operational Acceptance Certificate.

The Contractor shall also furnish to Employer two (02) Mylar Polyester Base full size reproducible of all final record, which in the opinion of the Employer may be required for the erection, construction of Civil Work, Operation and Maintenance, for identification of parts and for ordering replacement parts and materials. The Mylar reproducible shall be 50/70 microns thick, double matte film, wash off film, printed on the front.

In addition to above the Contractor shall provide two (2) sets of As-built Drawing (soft copies) of all final Record which, in the opinion of the Employer, may be required for the erection, construction of civil Work, operation and maintenance, for identification of parts and for ordering replacement parts and materials, on computer compact diskette (CD) using PLS-CADD and AutoCAD software.

### **SI-06.3.8 Ownership of Drawings and Data etc.**

All the drawings, details, bill of materials and any other information or documents furnished by the Contractor shall become the property of the Employer and shall be non-returnable. The Employer will have the right to use this property.

## **SI-07 APPROVAL OF FACILITIES**

As soon as practicable after the Award of Contract, the Contractor shall submit for the approval of the Employer, specifications, drawings, catalogues, diagrams and other descriptive data for all materials and components of equipment which the Contractor proposes for use under this Contract. For certain materials and Plant/Goods, data may be required to be submitted in accordance with a detailed form furnished by the Employer. Items submitted shall be properly labeled to indicate owner's name, the Contract number, Project, manufacturer name, source of supply, Contract Item number, and other data required by the Specifications. All items shall be submitted in sufficient time, but not later than **Thirty (30) days** prior to use thereof, to permit proper consideration and action thereon without delaying the approved time schedule. Item sent for approval shall be shipped prepaid by the Contractor to the Employer, and the Contractor shall give the Employer advance notice in writing of all items shipped. Reference in Specification to the Product of a specific manufacturer is intended only to establish a standard of quality, durability and design and shall not be construed as limiting competition. Product of other manufacturers will be acceptable provided such products are in the opinion of the Employer equal to that specified.

## **SI-08 STANDARDS AND TYPICAL DESIGN**

### **SI-08.1 General**

The Specifications cite or imply International Standards and typical design for Work, Plant and materials. Other equivalent Standards and typical designs are equally acceptable provided that they in no way detract from the quality, safety, and operability of the Work, Plant and materials furnished. However, when standards or typical design other than those cited or implied are offered by a bidder, he shall set forth in his bid the alternative standards proposed so that a direct comparison can be made before Contract Award. Each specific difference from the Specifications shall be clearly indicated by the bidder. If the bidder sets no alternatives forth, it will be assumed that Work, Plant and materials will be in accordance with the International Standards and typical design as cited or implied in the Specifications.

Where the documents provide requirements for materials or Plant or Work by

specifying a standard such as, for example, one of the international standard organizations, which has its origin in one country, it is not the intention to restrict the requirements solely to that standard and that country. Other standards, including standards of other countries will be accepted provided the requirements thereof in the sole opinion of the Employer are at least equal to the requirements of the standards specified. The Bidder may propose to the Employer an equivalent standard other than that specified, in which case he shall submit the proposed standard and all other information required by the Employer and shall submit written demonstration that his proposed standard is equivalent to or superior to the one specified herein. The submission must be made in English language. Moreover, the bidder shall also supply copy of the latest revision of the standards used in his design.

### SI-08.2 Abbreviation of Standards

Standard specifications and codes of the following listed authorities wherever cited herein are referred to by use of the abbreviations shown below. All Plant/Goods shall be designed, manufactured and tested generally in accordance with the latest revision of the standards laid down by the institutions or other approved institutions, except where specifically directed otherwise:

### SI-08.3 Applicable Standards and Codes

- (1) All Plant, materials, Work and design shall be generally in accordance with latest

revision of the standards specified in the Technical Provisions except where specifically directed otherwise. If these Specifications conflict with any or all the standards stated in the Technical Provisions, these Specifications shall have precedence and shall govern.

- (2) In case deviation from the above standards is minor, the approval of the Employer may be given to the use of other national standards prevalent in the country of manufacture. No departure from the standard specified will be considered after the Contract has been awarded unless specific authorization is requested in writing from the Employer.

## **SI-09 PORT OF ENTRY AND DISEMBARKATION**

The Contractor would have the option to use either Karachi Port or Port Muhammad Bin Qasim or Gawadar Port or all of them, as the port(s) of entry and disembarkation, at his own risk and costs. For the purpose of clarification, the term "Wharf at the Port of Karachi" wherever used throughout this document shall mean:

- a) Wharf at the Port of Karachi, and/or
- b) Wharf at the Port of Muhammad Bin Qasim
- c) Wharf at the Port of Gawadar

## **SI-10 PACKING AND MARKING**

### **SI-10.1 Packing**

- (1) The Contractor shall prepare and pack all parts of the Plant and Equipment for shipment in accordance with the requirements of the Contract Documents and in the best possible manner to withstand damage or loss from repeated handling and extremes of climate during transport and storage at Site. All parts of the Plant and Equipment shall be packed so as to guarantee safe transportation of the Plant and Equipment to the Site under any conditions and limitations which may be encountered. The manner of packing shall be such that it protects the Plant and Equipment against breakages, damages and losses from the factory until its arrival at its final destination at the Site.
- (2) The final packing shall be such that the weight and dimensions of packages are within reasonable limits in order to facilitate handling, storage and transportation.
- (3) Tower members shall be bundled un-assembled into like-member bundles. No bundle or container shall weigh more than 900 kg. Prior to commencement of bundling, the Contractor shall submit his proposed bundling schedule to the Employer for approval. The bundling schedule shall list the number of members per bundle and the weight of each bundle.

All members of each bundle shall be wired together (at both ends of the bundle) by passing a non-corrosive steel wire through the holes that are punched in the members. The wire shall be minimum No. 20 metric wire gauge and shall be completely looped and the ends shall be twisted together and tightened securely. Bundles shall be strapped with heavy gauge (32 mm x 1 mm) non-corrosive steel strapping. Following is a guide to the number of steel straps and is meant to be a minimum requirement only, and therefore does not limit the number of straps should more be deemed necessary by either the Contractor or the Employer .

Member lengths of 0.5 m to 1.5 m - 2 straps  
 Member lengths of 1.5 m to 2.5 m - 3 straps  
 Member lengths over 2.5 m - 4 straps

Small members (less than 0.5 m length), gusset plates, clip angles, accessories, etc. shall not be bundled or shipped loose. Such members shall be wired together in small lots of like members and placed in strong wooden boxes made of nominal 25 mm lumber, dressed on the outside for marking

purposes. Construction shall be of an interlocking type with reinforced corners and edges, (i.e. double lumber). Boxes shall be nailed together with ringed, gummed, spiraled or nails, only, and any nails that protrude into the box interior shall be clinched. Boxes shall be lined with a waterproof paper. No box shall be smaller than 0.028 Cu. meter in volume nor shall exceed 90 kg gross weight, and shall be steel strapped. All boxes containing identical items shall be of a uniform size.

The Conductor shall be shipped in matched sets of twenty four (24) in nominal lengths of 2500 meters or as per requirement of client, on non-returnable reels having mixture of steel and wood. The difference between the shortest and longest length in a set shall not exceed 46 meters. The average length between sets may vary  $\pm 5\%$  from the nominal length of 2500 meters. The reels shall be designed for nominal tension stringing operations and shall conform to standard laid out by Aluminum Association of USA.

The Aluminum Clad shield wire shall be shipped in nominal length of 2500 meters on non-returnable wooden reels or non-returnable reels having mixture of steel and wood. The average length between reels may vary  $\pm 5\%$  from the nominal length of 2500 meters or as per requirement of client. The difference between the shortest and longest length of reels shall not exceed 16 meters.

The drums (reels) of the conductor/Aluminum Clad shield wire shall be wrapped with a moisture resistant protective covering. The inner flanges of the reels shall be lined with moisture resistant solid fiberboard.

The two outer layers of the conductors shall be interleaved and the outer layer covered with moisture resistant paper. One layer of waterproof paper must be inserted underneath the last layer of conductor on the drum to avoid sliding against the inner layer. Moreover, the conductor shall be tied at the beginning of the last outer turn to one flange with a suitable string and the outer end stapled to the outer flange to avoid the conductor moving from the correct position. A protective covering of a single layer of a moisture resistant solid fiberboard, secured with steel banding, shall be wrapped overall.

The reels shall be so constructed to withstand normal loads due to tension stringing operations and they shall be sufficiently sturdy to withstand the additional handling incident to ocean shipment and field of construction. The wood should be seasoned to shrinkage and warping. The timber to be used shall be new, dry, properly seasoned and suitably treated to withstand changes in temperature and humidity without deterioration or shrinkage. The reels should be treated with preservative to protect against moisture, rot fungus, termite and insect attack.

The reels shall be wood lagged, the lagging to be secured with two steel bands. The steel bands shall be intermittently stapled to the lagging.

After factory inspection the inner end of the cable shall be fitted with a suitable cap to ensure water tightness. The outer end shall be fitted with a watertight head compatible with cable pulling.

All the metal parts of reels shall be properly coated with good quality anti-corrosive paint.

The hardware, accessories, stock bridge vibration dampers of conductor, Aluminum Clad shield wire and grounding connectors shall be packed in wooden boxes secured with steel bands strong enough to withstand the strains of overland and overseas transportation.

Bolts, nuts and washers shall be packed in wooden boxes or kegs in bulk quantities. Boxes shall be nailed together with ringed, spiraled or gummed nails only and any nails that protrude into the box interior shall be clinched. Boxes shall be lined with a waterproof paper. A surplus of five (5) percent of nuts, bolts and washers shall also be packed. Boxes or kegs shall contain

only one type and size of items. Mixing of items including nuts, bolts and washers shall not be permitted.

Ground rods shall be packed in bundles and bound with steel straps. The packing shall be strong enough to protect any surface or part from damage during transportation and storing.

The insulators shall be packed in accordance with ANSI standard C29.2 latest edition. The packing shall be palletized and each pallet shall not contain more than 120 units. Packing should be good for sea shipment, inland handling and inland transportation. Each pallet shall have lifting arrangement.

- (4) Before any shipment is made, the Contractor shall get the packing detailed drawings approved by the Employer.

## **SI-10.2 Lifting**

The method of lifting, type of equipment and type of slings, used for handling the conductor /Aluminum Clad shield wire reels as well as wooden boxes are subject to approval by the Employer . The reels are so constructed as to be supported either on an axle through the arbor hole or by the reel flange. When the reels are lifted by an axle supported from above, a spreader bar must be employed to prevent reel damage by inward pressure on reel flange. In no case shall metallic slings or other metallic equipment shall come in contact with conductor or Aluminum Clad shield wire or ground wire.

## **SI-10.3 Slings**

If the use of slings is necessary, these shall be of a flexible type and preferably manila rope or other non- metallic materials. The use of steel wire, mesh or chain link slings is prohibited unless they are covered with rubber hose or some similar material.

## **SI-10.4 Marking**

### **SI-10.4.1 Identification Marking**

- (1) All members, parts, units or components of the Plant and Equipment shall be plainly die-indented with a number to identify the member, part, unit or component itself and with a letter to indicate the type of Plant and Equipment in accordance with approved drawings.

The identification marking shall be plainly legible and durable and shall be so located that the number or letter is not obscured by other member, part, unit or component when in its assembled position. All the marking on ferrous part or unit shall be made before galvanizing.

- (2) Each crate, case, box, package or bundle shall have labels and or tags made from strong waterproof material and marked in indelible and non-fade-able ink securely attached hereto. These labels or tags shall indicate at least the name of the Project, the Consignee and the manufacturer, the type of Plant and Equipment or component and the quantity it contains so that it can be easily checked upon delivery. A packing list shall be included in each crate or box.
- (3) Each package delivered under the Contract shall be consecutively numbered and shall also be marked with code number or other identification to be approved by Employer so that various components of the Plant and Equipment which are shipped, disassembled and which may not be interchangeable

can be identified, collected and stored at the Site together. Additional information and or color coding that may reasonably be required by Employer/Employer to facilitate identification, shipment to stores or site handling and storage will also be provided.

- (4) All boxes weighing in excess of 500 kilograms shall be adequately marked for straining and lifting. Whenever necessary the boxes shall be provided with lifting hooks attached by means of vertical rods secured to strong bottom supports.

#### **SI-10.4.2 Container Marking**

In addition to labels and marking indicated above all packages, bundles, containers cases or boxes shall be clearly and boldly marked on two opposite sides and on the top and all reels on both sides as follows:

### **SI-11 TRANSPORTATION OF PLANT**

#### **SI-11.1 General**

- (1) The Contractor shall insure and transport the Plant, materials and his Equipment from manufacturers works (within Pakistan or from abroad) to the Site and shall be solely responsible for selection of routes and carriers, and expediting in order that Plant is safely and expeditiously transported to the Site.

#### **SI-11.2 Shipping**

The shipping of all the consignment relating to Plant and Contractor’s Equipment shall be arranged by the Contractor through reputed shipping lines including Pakistan National Shipping Corporation (PNSC). For working out a proper schedule to match the completion of Facilities, the Contractor will keep a continuous liaison with the Agent of the respective shipping line within the country of origin.

#### **SI-11.3 Transportation in Pakistan**

1. The Plant and Equipment coming by sea can be received by the Contractor either at Karachi Port or at Port Muhammad Bin Qasim or at Port Gawadar.
2. At Port Muhammad Bin Qasim, a conveyer belt nearby Steel Mill crosses the road with a clearance of 6 meters from road surface. In case the carrier with the consignment would be more than 6 meters in height, then the Plant and Equipment can be received at Karachi Port where, except for a busy road during the day, there is no constraint.
3. The Contractor however, shall be solely responsible for satisfying himself at the time of transportation as to the adequacy of the road surfaces and structures. All costs related with reinforcement of roads, structures, diversions and the like, if any, shall be borne by the Contractor. The Contractor shall advise the concerned authorities in advance of the proposed transit of the heaviest and largest items of Plant and Equipment and shall comply with instructions given by said authorities.

4. Within the limits imposed by law, the Contractor shall be entitled to utilize all the roads and other communication facilities existing in the country, to the same extent as any other use.

#### **SI-11.4 Shipping Documents**

1. Immediately after shipment leaves the port of embarkation, the Contractor shall submit complete and full shipping documents by airmail and by registered post or by courier service.
2. The Bills of Lading shall show the following:
  - Shipper's name
  - Consigned to
  - M.V. Sailing Approx. on
  - Project name and Package No.
  - Port of discharge
  - Steamship Contract No.

#### **SI-11.5 Unloading and Storage at the Site**

- (1) The Contractor shall load Plant from manufacturer's works (within or outside Employer's country), transport & unload all Plant and other materials to the Site or client's warehouse as required. Items for permanent installations shall be properly stored and shall be protected as required to prevent damage or deterioration of any type. Storage/ Stacking methods shall be such as to cause minimum inconvenience to others and shall be arranged to facilitate inspection.
- (2) All Plant and other materials storage shall comply with the requirements of the Specifications or to the approval of the Employer.
- (3) Lifting of pieces, which are galvanized or painted, shall be by hand or by hemp rope or as approved by the Employer or by wire rope which is suitable covered with rubber or similar material lifting by steel chains is prohibited. Steel pieces shall not be dropped, thrown, or skidded over steel, concrete or rock surfaces.
- (4) When steel components are stored temporarily they shall be blocked on wood & separated to prevent damage.

#### **SI-11.6 Ownership of Packing Materials**

All packing boxes, reels, shipping containers except those containers which are not the property of the Contractor, planking covers, etc. shall become the property of the Employer. All the packing material shall be handed over to the Employer immediately after storage requirements of the Plant and Equipment including spares thereof or part thereof and other materials are over. The Employer, on application from the Contractor, may permit the Contractor to use some of the boxes and containers, without charge for construction erection/installation purposes.

#### **SI-11.7 Receiving Reports and/or Damage Reports**

1. The Contractor shall prepare and submit receiving reports to the Employer and the Employer to cover shipments received and checked at the job Site and/or storage area. Shipment on arrival at the job Site and/or storage area shall be unloaded, opened, and carefully checked by the Contractor in the presence of a designated representative of the Employer for any loss and damages in transit. In the event of loss and/or damage, the Contractor shall immediately report to Employer/Employer and a damage report countersigned by the Employer shall immediately be submitted by the Contractor to the Insurance Company with copies to the Employer. Prompt action shall be taken by the Contractor under intimation to Employer, to record the damaged or missing item(s) and it shall be ensured that the deliveries meet the final delivery dates and/or commissioning dates.

2. In all cases of irreparable damage, the Contractor shall immediately notify the Contractor for re-manufacture and supply of the damaged part(s).

## **SI-12 SHOP INSPECTION AND ORDERS FOR PLANT & EQUIPMENT**

### **SI-12.1 Inspection**

Unless otherwise authorized by the Employer, no material or equipment shall be shipped from its point of original manufacture or final shop assembly before it has been inspected and approved by the Employer. The Employer however may waive off this condition at their discretion for some items in case factory test results will be provided to the Employer.

### **SI-12.2 Plant & Equipment Orders**

The Contractor shall provide to the Employer a list of Sub- Contractors and Vendors with whom orders are to be placed for materials or equipment which will enter directly into the work of the Contract. Triplicate copies of material or equipment orders and list of stock material or equipment shall be provided to the Employer. All orders and stock lists shall state the standard specification under which the material is to be furnished, pertinent drawing and part numbers if any, and the required delivery date, and shall state the material is subject to inspection and testing by the Employer.

### **SI-12.3 Acceptance of Materials**

The approval by the Employer of any material or equipment prior to shipment shall in no way relieve the Contractor of any of his responsibilities for meeting all of the requirements of the Specifications and shall not prevent subsequent rejection if such material or equipment is later found to be defective or not conforming to the Specifications.

## **SI-13 SCHEDULE AND PROGRESS REPORTS**

### **SI-13.1 Schedule**

The Contractor shall carry out the Facilities in accordance with the dates/periods specified in Time Schedule to be provided as **Appendix-4** of Contract Agreement, and with the Schedule which shall be provided pursuant to Sub-Clause 18.2 of the General Conditions of Contract. The Contractor shall regularly review the Schedule and notify the Employer promptly of any revisions which in his view may be required from time to time.

#### **SI-13.1.1 Form of Schedule**

The Schedule to be submitted by the Contractor pursuant to Sub-Clause 18.2 of General Conditions of Contract shall be a detailed CPM (critical path method) type, time scaled according to calendar dates and Project month numbers. The CPM for planning, scheduling, and controlling will be used for the Contract. The Contractor shall submit a schedule showing the logical sequence in which the Facilities will be carried out in sufficient detail to satisfy the Employer that the Facilities are thoroughly planned and meets all the requirements of the Contract Documents.

#### **SI-13.1.2 Schedule of Shipping of Plant and Equipment to Site**

1. Each group of Plant and Equipment shall be completely delivered to the Site stated in the Contract according to Shipping Schedule to be submitted for approval by the Employer at least six (6) weeks before shipment. The Contractor shall keep the Employer informed of the progress of the Contract



and notify the Employer approximately thirty (30) days in advance, in writing, as to when the Plant/Goods will be ready for inspection and for shipping/delivering and shall supply lists covering each consignment in sufficient detail to enable the Employer to check the contents of the packages.

2. In preparing the Shipping Schedule, the Contractor shall fully take into account the requirements (and possibilities) for ocean (or air) freight, inland transportation and expediting through customs. Progress of all shipments/deliveries to the Site shall be continuously monitored and the Contractor shall provide staff or agents to expedite all shipments/deliveries to ensure compliance with the approved Schedule.

### **SI-13.1.3 Erection/Construction Schedule**

1. The Contractor shall prepare and submit Plant Erection & Commissioning Schedule as a part of detailed program to be submitted pursuant to Sub- Clause 18.2 of General Conditions of Contract. The delivery of sub- assemblies and other parts of the Plant should be so estimated so as to permit erection work and construction work to proceed in an orderly manner so that the Facilities can be completed by the required commissioning dates. The Contractor in preparing and regularly reviewing the Schedule in respect of the erection work shall comply with the requirements of the Contract.
2. The Contractor shall promptly bring to the attention of the Employer any amendment to the Schedule which in his view may at any time be required to ensure that the Commissioning Date/Periods will be met.

### **SI-13.1.4 Progress Reports**

- (1) The Contractor within twenty eight (28) days of the signing of the Contract shall submit in writing for the approval of the Employer a Schedule for the design, manufacture, delivery, erection, testing and commissioning of the Plant and design and construction of the associated civil work.
- (2) The submission to or approval by the Employer of such Schedule etc. shall not relieve the Contractor of any of his duties or responsibilities under the Contract.
- (3) At monthly intervals after submission of the Schedule, the Contractor shall submit to the Employer and Employer up to five (5) copies of a written detailed progress report in an approved form together with the copies of the above mentioned Schedule indicating the state reached in the Transportation of Plant, Erection/ Construction, in percentage terms. Such monthly reports shall show the actual progress plotted against the scheduled diagrams, bar charts and curves in approved form, as may be required by the Employer. The reports shall be forwarded not later than the 8<sup>th</sup> of the subsequent month. The number of copies shall be as stipulated in the Specifications or as instructed by the Employer.
- (4) The Employer shall at all reasonable times be afforded access to the Contractor and any Sub-Contractor's premises for the purpose of ascertaining progress.

### **SI-13.1.5 Meetings**

- (1) Soon after the date of signing of Contract, the Employer will require a Conference/Kick off Meeting with the Contractor at a place mutually agreed upon, to discuss scheduling of drawings, manufacturing, scheduled sequences of delivery and other similar problems which may be pertinent to the completion of the Project.
- (2) At monthly intervals or from time to time during the execution of the Contract, the Employer/Employer may call meetings, either in his Offices or at the

Contractor's Offices in Pakistan as is deemed necessary for the purpose of progress monitoring and proper execution of the Contract.

- (3) As required by the Employer, responsible representatives of the Contractor shall attend such meetings.
- (4) All expenses incurred by the Contractor for attending such meetings shall be borne by the Contractor and shall not be reimbursable.

#### **SI-14 SPARE PARTS**

1. The Contractor shall provide the Mandatory spare parts upon request from the employer within the defined Time Period.
2. All spare parts shall be duplicates of the original parts furnished and interchangeable therewith. The list of Mandatory spare parts has been drawn up by the Employer in the Bidding Documents. These spare parts shall serve the Plant and suitably identified and packed for long storage in containers plainly marked "SPARE PARTS ONLY". A packing list indicating the contents of each such container shall be securely fastened in a moisture proof envelope to the outside of the container. The packing list shall also provide the following information:
  - a) Contractor/Manufacturer
  - b) Contract Number
  - c) Identification, including Contractor's drawing number, reference of each spare part in the container.
3. The Contractor shall submit the consolidated Spare Parts List, showing the unit prices and quantities. All required spare parts must be delivered to Employer's designated warehouses (to be specified by the Employer before delivery of the same).
4. The Contractor shall follow a system of designating and tagging each and every spare part for ease of inventory store keeping. The final consolidated Spare Parts List shall bear such tagging particulars as will be convenient to locate the spare part without any loss of time.
5. All spare parts must be prepared and protected for long-term storage to preclude damage. Storage requirements shall be submitted to the Employer/ Employer.
6. All spare parts lists shall be in English.

#### **SI-15 SITE FACILITIES AND SERVICES**

Attention is drawn to the obligations of the Contractor to make his own arrangements at his own expense for Services or facilities provided to his employees. Any cost incurred by the Contractor in respect of any of such Site facilities or services under the Contract shall be deemed to be included in the rates and prices in the Price Schedule and no separate payment, therefore, will be made to the Contractor.

##### **SI-15.1 Accommodation**

The Contractor shall provide and maintain at his cost residential accommodation and transportation facilities for his own use.

The Contractor shall provide and maintain such housing accommodation and amenities as he may consider necessary for all of his supervisory staff and labor employed for the purposes of or in connection with this Contract including all fencing, electricity, supply, sanitation, cook houses, fire prevention, water supply and other requirements in connection with such housing accommodation or

amenities.

Contractor shall provide and maintain at his own cost separate residential accommodation and transportation facilities for Employer and Engineer/Employer's representative use, at Site.

### **SI-15.2 Offices**

- (1) The Contractor shall arrange and maintain his offices at his own cost.
- (2) Contractor shall provide and maintain at his own cost separate Office & Facilities for Employer and Engineer use, at Site.

### **SI-15.3 Work yards and Storage Areas**

- (1) Pursuant to Sub-Clause SI-11.5 hereof, no storage site shall be provided by the Employer to store Plant, materials or equipment. The Contractor shall procure, furnish, provide and arrange for all the necessary services and be responsible for the construction and maintenance of the necessary construction campus, offices and warehouses; and perform all other work necessary for completion of the Work described herein in strict conformance with these Specifications.
- (2) The Contractor shall provide his own watchman service to ensure security and safety of the Plant, materials and Work prior to the Employer's taking over the Work.

### **SI-15.4 Temporary Buildings**

- (1) The Contractor shall provide and maintain all temporary structures required including warehouses, changes, change houses for workmen, sheds, etc. He shall also provide his own field office complete with telephone so that he or his official representative can be contacted by the Employer and/or Employer's representative at all times.
- (2) Such temporary buildings and/or utilities shall remain the property of the Contractor and shall be removed by him at his expense upon the completion of the Works unless the Employer agrees otherwise and the Site reinstated to its original condition, all to the approval of the Employer.
- (3) All temporary erection facilities described above shall be removed by the Contractor after completion of the works, and the site cleared and cleaned of refuse or other foreign material as per instructions of the Employer.

## **SI-16 MEASUREMENT FOR PAYMENT**

The measurement for payment for the various items of Price Schedules will be as follows:

### **1. Installation Services and Commissioning**

#### **a) Clearing Right-of-Way**

**Measurement** for payment will be made based on the percent of right-of-way cleared and disposal completed.

**Payment** will be made from the lump sum amount given in Price Schedules. The payment shall include, but not be limited to, the cost of clearing a 35 meters wide right-of-way including cutting, grubbing, hauling, burning and clean-up and other work necessary to complete the required cleaning.

#### **b) Sub Soil Investigation (Drilling Boreholes, SPT and undisturbed sampling), if required**

**Measurement** for drilling and testing shall be made for actual length of boreholes drilled including SPT tests performed with the approval of the Employer and actual excavated depth for test pits.

**Payment** shall be based in accordance with the unit price quoted in the Price Schedules. All the necessary operations done to accomplish drilling and testing as specified shall be deemed to be part of this item and no extra payment for such operation shall be made. The cost of standard penetration tests, undisturbed sampling, rock coring and block sampling (in case of test pits) is included in the cost of Sub Soil Investigations and includes but not limited to all costs and expenses for records, operations, samples, preservation, and transportation to the laboratory of the selected disturbed/ undisturbed samples taken from the SPT Spoon.

c) **Laboratory Tests**

**No Payment** shall be made for any laboratory test performed. The unit price given for sub-soil investigations (if required) shall be deemed to include complete laboratory testing for the specified tests according to the ASTM Standards and compilation and presentation of reports including foundation design/designation in standard form as approved by the Employer .

d) **Reinforced Concrete Foundations**

**Measurement** for payment will be made for each type of foundation installed as shown on the approved relevant construction drawings for the various foundations.

**Payment:** Unit price for Foundation drawings shall include, but not be limited to tower staking, site contouring, the cost of furnishing all labor, equipment, materials (including concrete and reinforcement etc.) site levelling, blasting/cutting/grading of tower site, excavation, shuttering, dewatering, shorting, forming, reinforcing, concreting, curing, backfilling, installing stub angles, tower grounding, setting and all other associated Works to produce finished foundations.

e) **Installing Piles**

**Measurement** under this item shall be made at actual number of the foundations constructed and actual length of each pile, pile cap and tie beam installed as shown on the Drawings and according to the Specifications.

**Payment** shall be made in accordance with the unit price quoted in the Price Schedules. Such unit price shall constitute full compensation for pile foundation construction based on measurement described above. Such payment shall be deemed to include the cost of tower staking, making bore holes, cost of materials (including concrete and reinforcement etc.), ramp, placement and curing of concrete and all other arrangements required to complete the pile foundation to the satisfaction of the Employer.

f) **Steel Tower Erection**

**Measurement** for payment will be made for each type of component installed as shown on the relevant drawings for the various towers.

**Payment** will be made based on the unit prices for each tower quoted in Price Schedule. The unit prices shall include, but not be limited to, detailing of tower fabrication drawings supplied by the Employer, the cost of all labor, equipment, requisitioning, loading, transporting, from site storage areas to the sites, erecting together with bolts, nuts,

washers, step bolts, including back bolting and punching of nuts and bolts and all other associated work necessary for the completion of the towers ready for installation of overhead Aluminum Clad shield wire and conductors thereon.

**g) Welding of Nuts & Bolts**

**Measurement** for payment will be made for each tower.

**Payment** will be made on the unit price quoted for each tower. The unit prices shall include, but not limited to welding of nuts & bolts up to the waist of single and double circuit towers and application of galvanox.

**h) Stringing Overhead Steel Shield Wire (Aluminium Clad), and Conductor**

**Measurement** for payment will be made horizontally along the center line of the line route.

**Payment** will be made based on the unit price quoted in the Price Schedules. The unit prices shall include, but not be limited to, the cost of all labor, equipment, requisitioning, loading, transporting, distributing, stringing including installation of; insulator, Aluminum Clad shield wire hardware assemblies; accessories for conductor, overhead Aluminum Clad shield wire along with associated equipment; dampers for conductor and stock bridge type vibration dampers for Aluminum Clad shield wire, sagging, clipping-in, dead-ends, jumpers including installation of all hardware as shown on the relevant drawings, and all other associated work necessary for the completion of this phase of the work.

**SI-17 PAYMENT OF CUSTOM DUTIES**

The contractor shall arrange and pay for all import clearance permits for all Plant / equipment and other materials imported by the Contractor into Pakistan for the purpose of or in connection with this Contract. Furthermore, upon arrival of each consignment of such imported Plant and other materials, the Contractor shall arrange and pay for the customs examination, clearance and duties/taxes thereof. All charges including charges for loading, unloading and forwarding expenses shall be borne by the Contractor. Client shall reimburse only applicable Customs duties and Sales Tax. All the other taxes/charges shall be borne by the Contractor.

**SI-18 EXPEDITING**

The Contractor shall provide the Employer with un-priced copies of the Contractor's Purchase Orders for material or approved Sub-contracted Work at the time any such orders are placed. The Contractor shall also provide the Employer with any other relevant information requested to ensure proper expediting and scheduling of the Work.

**SI-19 PAYMENT FOR FACILITIES REQUIRED BY SUPPLEMENTARY INFORMATION**

Unless expressly excluded, the cost of all work required by the Supplementary Information shall be considered to be included in the price and amounts quoted in the Price Schedule.

**SI-20 PROJECT COMPLETION REPORT**

The Contractor shall prepare comprehensive project completion report and shall submit (02) copies for review/approval of Employer. The Contractor shall furnish sixteen (16) copies of approved project completion report as per distribution in Clause SI-06.3.6.

The GCC in this Section, read in conjunction with the Special Conditions of Contract in Section 8 and other documents listed therein, should be a complete document expressing all the rights and obligations of the contracting parties. The General Conditions herein shall not be altered.

# General Conditions

## A. Contract and Interpretation

### 1. Definitions

1.1 The following words and expressions shall have the meanings hereby assigned them:

“Contract” means the Contract Agreement entered into between the Employer and the Contractor, together with the Contract Documents referred to therein; they shall constitute the Contract, and the term “the Contract” shall in all such documents be construed accordingly.

“Contract Documents” means the documents listed in Article 1.1 (Contract Documents) of the Contract Agreement (including any amendments thereto).

“GCC” means the General Conditions of Contract.

“SCC” means the Special Conditions of Contract.

“day” means calendar day .

“year” means 365 days.

“month” means calendar month.

“Party” means the *Employer* or the Contractor, as the context requires.

“*Employer*” means the person named as such in the SCC and includes the legal successors or permitted assigns of the Employer.

“Project Manager” means the person appointed by the Employer in the manner provided in GCC Sub-Clause 17.1 (Project Manager) hereof and named as such in the SCC to perform the duties delegated by the Employer.

“Contractor” means the person(s) named as Contractor in the Contract Agreement, and includes the legal successors or permitted assigns of the Contractor.

“Contractor’s Representative” means any person nominated by the Contractor and approved by the Employer in the manner provided in GCC Sub-Clause 17.2 (Contractor’s Representative and Construction Manager) hereof to perform the duties delegated by the Contractor.

“Construction Manager” means the person appointed by the Contractor’s Representative in the manner provided in GCC Sub-Clause 17.2.4.

“Subcontractor,” including manufacturers, means any person to whom execution of any part of the Facilities, including preparation of any design or supply of any Plant, is sub-contracted directly or indirectly by the Contractor, and includes its legal successors or permitted assigns.

“Dispute Board” (DB) means the person or persons named as such in the SCC appointed by agreement between the Employer and the Contractor to make a decision on or to settle any dispute or difference



between the Employer and the Contractor referred to him or her by the parties pursuant to GCC Sub-Clause 44.... (Dispute Board) hereof.

“The Bank” means the financing institution named in the SCC.

“Contract Price” means the sum specified in Article 2.1 (Contract Price) of the Contract Agreement, subject to such additions and adjustments thereto or deductions therefrom, as may be made pursuant to the Contract.

“Facilities” means the Plant to be supplied and installed, as well as all the Installation Services to be carried out by the Contractor under the Contract.

“Plant” means permanent plant, equipment, machinery, apparatus, articles and things of all kinds to be provided and incorporated in the Facilities by the Contractor under the Contract (including the spare parts to be supplied by the Contractor under GCC Sub-Clause 7.3 hereof), but does not include Contractor’s Equipment.

“Installation Services” means all those services ancillary to the supply of the Plant for the Facilities, to be provided by the Contractor under the Contract, such as transportation and provision of marine or other similar insurance, inspection, expediting, site preparation works (including the provision and use of Contractor’s Equipment and the supply of all construction materials required), installation, testing, pre-commissioning, commissioning, operations, maintenance, the provision of operations and maintenance manuals, training, etc... as the case may require.

“Contractor’s Equipment” means all facilities, equipment, machinery, tools, apparatus, appliances or things of every kind required in or for installation, completion and maintenance of Facilities that are to be provided by the Contractor, but does not include Plant, or other things intended to form or forming part of the Facilities.

“Country of Origin” means the countries and territories eligible under the rules of the Employer as further elaborated in the SCC.

“Site” means the land and other places upon which the Facilities are to be installed, and such other land or places as may be specified in the Contract as forming part of the Site.

“Effective Date” means the date of fulfillment of all conditions stated in Article 3 (Effective Date) of the Contract Agreement, upon which the period until the Time for Completion shall be counted from.

“Time for Completion” means the time within which Completion of the Facilities as a whole (or of a part of the Facilities where a separate Time for Completion of such part has been prescribed) is to be attained, as referred to in GCC Clause 8 and in accordance with the relevant provisions of the Contract.

“Completion” means that the Facilities (or a specific part thereof where specific parts are specified in the Contract) have been completed operationally and structurally and put in a tight and clean condition, that all work in respect of Pre-commissioning of the Facilities or such specific part thereof has been completed, and that the Facilities or specific part

thereof are ready for Commissioning as provided in GCC Clause 24 (Completion) hereof.

“Precommissioning” means the testing, checking and other requirements specified in the Employer’s Requirements that are to be carried out by the Contractor in preparation for Commissioning as provided in GCC Clause 24 (Completion) hereof.

“Commissioning” means operation of the Facilities or any part thereof by the Contractor following Completion, which operation is to be carried out by the Contractor as provided in GCC Sub-Clause 25.1 (Commissioning) hereof, for the purpose of carrying out Guarantee Test(s).

“Guarantee Test(s)” means the test(s) specified in the Employer’s Requirements to be carried out to ascertain whether the Facilities or a specified part thereof is able to attain the Functional Guarantees specified in the Appendix (Functional Guarantees) to the Contract Agreement in accordance with the provisions of GCC Sub-Clause 25.2 (Guarantee Test) hereof.

“Operational Acceptance” means the acceptance by the Employer of the Facilities (or any part of the Facilities where the Contract provides for acceptance of the Facilities in parts), which certifies the Contractor’s fulfillment of the Contract in respect of Functional Guarantees of the Facilities (or the relevant part thereof) in accordance with the provisions of GCC Clause 28 (Functional Guarantees) hereof and shall include deemed acceptance in accordance with GCC Clause 25 (Commissioning and Operational Acceptance) hereof.

“Defect Liability Period” means the period of validity of the warranties given by the Contractor commencing at Completion of the Facilities or a part thereof, during which the Contractor is responsible for defects with respect to the Facilities (or the relevant part thereof) as provided in GCC Clause 27 (Defect Liability) hereof.

- 2. Contract Documents**            2.1 Subject to Article 1.2 (Order of Precedence) of the Contract Agreement, all documents forming part of the Contract (and all parts thereof) are intended to be correlative, complementary and mutually explanatory. The Contract shall be read as a whole.
- 3. Interpretation**            3.1 In the Contract, except where the context requires otherwise:
- (a) words indicating one gender include all genders;
  - (b) words indicating the singular also include the plural and words indicating the plural also include the singular;
  - (c) provisions including the word “agree”, “agreed” or “agreement” require the agreement to be record in writing;
  - (d) the word “tender” is synonymous with “bid”, “tenderer” with “bidder” and “tender documents” with “bidding documents”; and
  - (e) “written” or “in writing” means hand-written, type-written, printed or electronically made, and resulting in a permanent record.

The marginal words and other headings shall not be taken into consideration in the interpretation of these Conditions.

### 3.2 Incoterms

Unless inconsistent with any provision of the Contract, the meaning of any trade term and the rights and obligations of parties thereunder shall be as prescribed by Incoterms.

*Incoterms* means international rules for interpreting trade terms published by the International Chamber of Commerce (latest edition), 38 Cours Albert 1<sup>er</sup>, 75008 Paris, France.

### 3.3 Entire Agreement

Subject to GCC Sub-Clause 16.4 hereof, the Contract constitutes the entire agreement between the Employer and Contractor with respect to the subject matter of Contract and supersedes all communications, negotiations and agreements (whether written or oral) of parties with respect thereto made prior to the date of Contract.

### 3.4 Amendment

No amendment or other variation of the Contract shall be effective unless it is in writing, is dated, expressly refers to the Contract, and is signed by a duly authorized representative of each party hereto.

### 3.5 Independent Contractor

The Contractor shall be an independent contractor performing the Contract. The Contract does not create any agency, partnership, joint venture or other joint relationship between the parties hereto. Subject to the provisions of the Contract, the Contractor shall be solely responsible for the manner in which the Contract is performed. All employees, representatives or Subcontractors engaged by the Contractor in connection with the performance of the Contract shall be under the complete control of the Contractor and shall not be deemed to be employees of the Employer, and nothing contained in the Contract or in any subcontract awarded by the Contractor shall be construed to create any contractual relationship between any such employees, representatives or Subcontractors and the Employer.

### 3.6 Non-Waiver

3.6.1 Subject to GCC Sub-Clause 3.6.2 below, no relaxation, forbearance, delay or indulgence by either party in enforcing any of the terms and conditions of the Contract or the granting of time by either party to the other shall prejudice, affect or restrict the rights of that party under the Contract, nor shall any waiver by either party of any breach of Contract operate as waiver of any subsequent or continuing breach of Contract.

3.6.2 Any waiver of a party's rights, powers or remedies under the Contract must be in writing, must be dated and signed by an authorized representative of the party granting such waiver, and must specify the right and the extent to which it is being waived.

### 3.7 Severability

If any provision or condition of the Contract is prohibited or rendered invalid or unenforceable, such prohibition, invalidity or unenforceability shall not affect the validity or enforceability of any other provisions and conditions of the Contract.

### 3.8 Country of Origin

"Origin" means the place where the plant and component parts thereof are mined, grown, produced or manufactured, and from which the services are provided. Plant components are produced when, through

manufacturing, processing, or substantial or major assembling of components, a commercially recognized product results that is substantially in its basic characteristics or in purpose or utility from its components.

- 4. Communications** 4.1 Wherever these Conditions provide for the giving or issuing of approvals, certificates, consents, determinations, notices, requests and discharges, these communications shall be:
- (a) in writing and delivered against receipt; and
  - (b) delivered, sent or transmitted to the address for the recipient's communications as stated in the Contract Agreement.

When a certificate is issued to a Party, the certifier shall send a copy to the other Party. When a notice is issued to a Party, by the other Party or the Project Manager, a copy shall be sent to the Project Manager or the other Party, as the case may be.

- 5. Law and Language**
- 5.1 The Contract shall be governed by and interpreted in accordance with laws of the country specified in the SCC.
- 5.2 The ruling language of the Contract shall be that stated in the SCC.
- 5.3 The language for communications shall be the ruling language unless otherwise stated in the SCC.

- 6. Fraud and Corruption**
- 6.1 Employers Anticorruption Policy requires Borrowers (including beneficiaries of financed activity), as well as Bidders, suppliers, and contractors under locally financed contracts, observe the highest standard of ethics during the procurement and execution of such contracts. In pursuance of this policy, Employer
- (a) defines, for the purposes of this provision, the terms set forth below as follows:
    - (i) "corrupt practice" means the offering, giving, receiving, or soliciting, directly or indirectly, anything of value to influence improperly the actions of another party;
    - (ii) "fraudulent practice" means any act or omission, including a misrepresentation, that knowingly or recklessly misleads, or attempts to mislead, a party to obtain a financial or other benefit or to avoid an obligation;
    - (iii) "coercive practice" means impairing or harming, or threatening to impair or harm, directly or indirectly, any party or the property of the party to influence improperly the actions of a party;
    - (iv) "collusive practice" means an arrangement between two or more parties designed to achieve an improper purpose, including influencing improperly the actions of another party;
    - (v) "integrity violation" means any act, as defined under Integrity Principles and Guidelines, which violates Anticorruption Policy including corrupt, fraudulent, coercive, or collusive practice, abuse, and obstructive practice;

- (vi) “obstructive practice” means (a) deliberately destroying, falsifying, altering or concealing of evidence material to an investigation; (b) making false statements to investigators in order to materially impede an investigation; (c) failing to comply with requests to provide information, documents or records in connection with an Office of Anticorruption and Integrity (OAI) investigation; (d) threatening, harassing, or intimidating any party to prevent it from disclosing its knowledge of matters relevant to the investigation or from pursuing the investigation, or (e) materially impeding Employers contractual rights of audit or access to information.
- (b) will reject a proposal for award if it determines that the Bidder recommended for award has, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices or other integrity violations in competing for the Contract;
- (c) will sanction impose remedial actions on a firm or an individual, at any time, in accordance with Anticorruption Policy and Integrity Principles and Guidelines (both as amended from time to time), including declaring ineligible, either indefinitely or for a stated period of time, to participate<sup>1</sup> or administered or supported activities or to benefit from Employer-financed, administered or supported contract, financially or otherwise, if it at any time determines that the firm or individual has, directly or through an agent, engaged in corrupt, fraudulent, collusive, coercive, or obstructive practices or other integrity violations; and
- (d) Will have the right to require suppliers and contractors to permit Employer or its representative to inspect their accounts and records and other documents relating to the bid submission and contract performance and to have them audited by auditors appointed by Employer.

## B. Subject Matter of Contract

### 7. Scope of Facilities

- 7.1 Unless otherwise expressly limited in the Employer’s Requirements, the Contractor’s obligations cover the provision of all Plant and the performance of all Installation Services required for the design, the manufacture (including procurement, quality assurance, construction, installation, associated civil works, Pre-commissioning and delivery) of the Plant and the installation, completion and commissioning of the Facilities in accordance with the plans, procedures, specifications, drawings, codes and any other documents as specified in the Section, Employer’s Requirements. Such specifications include, but are not limited to, the provision of supervision and engineering services; the supply of labor, materials, equipment, spare parts (as specified in GCC Sub-Clause 7.3 below) and accessories; Contractor’s Equipment;

<sup>1</sup> Whether as a contractor, nominated subcontractor, consultant, manufacturer or supplier, or service provider; or in any other capacity (different names are used depending on the particular bidding document). A nominated subcontractor is one which either has been: (i) included by the bidder in its prequalification application or bid because it brings specific and critical experience and know-how that are accounted for in the evaluation of the bidder’s prequalification application or the bid; or (ii) appointed by the Employer.

construction utilities and supplies; temporary materials, structures and facilities; transportation (including, without limitation, unloading and hauling to, from and at the Site); and storage, except for those supplies, works and services that will be provided or performed by the Employer, as set forth in the Appendix (Scope of Works and Supply by the Employer) to the Contract Agreement.

- 7.2 The Contractor shall, unless specifically excluded in the Contract, perform all such work and/or supply all such items and materials not specifically mentioned in the Contract but that can be reasonably inferred from the Contract as being required for attaining Completion of the Facilities as if such work and/or items and materials were expressly mentioned in the Contract.
- 7.3 In addition to the supply of Mandatory Spare Parts included in the Contract, the Contractor agrees to supply spare parts required for the operation and maintenance of the Facilities for the period specified in the SCC and the provisions, if any, specified in the SCC. However, the identity, specifications and quantities of such spare parts and the terms and conditions relating to the supply thereof are to be agreed between the Employer and the Contractor.

**8. Time for Commencement and Completion**

- 8.1 The Contractor shall commence work on the Facilities within the period specified in the SCC and without prejudice to GCC Sub-Clause 26.2 hereof, the Contractor shall thereafter proceed with the Facilities in accordance with the time schedule specified in the Appendix 4 (Time Schedule) to the Contract Agreement.
- 8.2 The Contractor shall attain Completion of the Facilities or of a part where a separate time for Completion of such part is specified in the Contract, within the time stated in the SCC or within such extended time to which the Contractor shall be entitled under GCC Clause 40 hereof.

**9. Contractor's Responsibilities**

- 9.1 The Contractor shall design, manufacture including associated purchases and/or subcontracting, install and complete the Facilities in accordance with the Contract. When completed, the Facilities should be fit for the purposes for which they are intended as defined in the Contract.
- 9.2 The Contractor confirms that it has entered into this Contract on the basis of a proper examination of the data relating to the Facilities including any data as to boring tests provided by the Employer, and on the basis of information that the Contractor could have obtained from a visual inspection of the Site if access thereto was available and of other data readily available to it relating to the Facilities as of the date 28 days prior to bid submission. The Contractor acknowledges that any failure to acquaint itself with all such data and information shall not relieve its responsibility for properly estimating the difficulty or cost of successfully performing the Facilities.
- 9.3 The Contractor shall acquire and pay for all permits, approvals and/or licenses from all local, state or national government authorities or public service undertakings in the country where the Site is located which such authorities or undertakings require the Contractor to obtain in its name and which are necessary for the performance of the Contract, including, without limitation, visas for the Contractor's and Subcontractor's personnel and entry permits for all imported Contractor's Equipment. The Contractor shall acquire all other permits, approvals and/or licenses

that are not the responsibility of the Employer under GCC Sub-Clause 10.3 hereof and that are necessary for the performance of the Contract.

- 9.4 The Contractor shall comply with all laws in force in the country where the Facilities are to be implemented. The laws will include all local, state, national or other laws that affect the performance of the Contract and bind upon the Contractor. The Contractor shall indemnify and hold harmless the Employer from and against any and all liabilities, damages, claims, fines, penalties and expenses of whatever nature arising or resulting from the violation of such laws by the Contractor or its personnel, including the Subcontractors and their personnel, but without prejudice to GCC Sub-Clause 10.1 hereof.
- 9.5 Any plant and services that will be incorporated in or be required for the Facilities and other supplies shall have their origin as specified under GCC Clause 1 (Country of Origin). Any subcontractors retained by the Contractor shall be from a country as specified in GCC Clause 1 (Country of Origin).
- 9.6 The Contractor shall permit Employer to inspect the Contractor's accounts and records relating to the performance of the Contractor and to have them audited by auditors appointed by Employer, if so required by Employer.
- 9.7 If the Contractor is a joint venture or consortium of two or more *persons*, all such *persons* shall be jointly and severally bound to the Employer for the fulfillment of the provisions of the Contract and shall designate one of such *persons* to act as a leader with authority to bind the joint venture or consortium. The composition or the constitution of the joint venture or consortium shall not be altered without the prior consent of the Employer.

#### **10. Employer's Responsibilities**

- 10.1 All information and/or data to be supplied by the Employer as described in the Appendix (Scope of Works and Supply by the Employer) to the Contract Agreement shall be deemed to be accurate, except when the Employer expressly states otherwise.
- 10.2 The Employer shall be responsible for acquiring and providing legal and physical possession of the Site and access thereto, and for providing possession of and access to all other areas reasonably required for the proper execution of the Contract, including all requisite rights of way, as specified in the Appendix (Scope of Works and Supply by the Employer) to the Contract Agreement. The Employer shall give full possession of and accord all rights of access thereto on or before the date(s) specified in that Appendix.
- 10.3 The Employer shall acquire and pay for all permits, approvals and/or licenses from all local, state or national government authorities or public service undertakings in the country where the Site is located which (a) such authorities or undertakings require the Employer to obtain in the Employer's name, (b) are necessary for the execution of the Contract, including those required for the performance by both the Contractor and the Employer of their respective obligations under the Contract, and (c) are specified in the Appendix (Scope of Works and Supply by the Employer) to the Contract Agreement.
- 10.4 If requested by the Contractor, the Employer shall use its best endeavors to assist the Contractor in obtaining in a timely and

expeditious manner all permits, approvals and/or licenses necessary for the execution of the Contract from all local, state or national government authorities or public service undertakings that such authorities or undertakings require the Contractor or Subcontractors or the personnel of the Contractor or Subcontractors, as the case may be, to obtain.

- 10.5 Unless otherwise specified in the Contract or agreed upon by the Employer and the Contractor, the Employer shall provide sufficient, properly qualified operating and maintenance personnel; shall supply and make available all raw materials, utilities, lubricants, chemicals, catalysts, other materials and facilities; and shall perform all work and services of whatsoever nature, including those required by the Contractor to properly carry out Pre-commissioning, Commissioning and Guarantee Tests, all in accordance with the provisions of the Appendix (Scope of Works and Supply by the Employer) to the Contract Agreement at or before the time specified in the program furnished by the Contractor under GCC Sub-Clause 18.2 hereof and in the manner thereupon specified or as otherwise agreed upon by the Employer and the Contractor.
- 10.6 The Employer shall be responsible for the continued operation of the Facilities after Completion, in accordance with GCC Sub-Clause 24.8, and shall be responsible for facilitating the Guarantee Test(s) for the Facilities, in accordance with GCC Sub-Clause 25.2.
- 10.7 All costs and expenses involved in the performance of the obligations under this GCC Clause 10 shall be the responsibility of the Employer, except those incurred by the Contractor with respect to the performance of Guarantee Tests, in accordance with GCC Sub-Clause 25.2.
- 10.8 In the event that the Employer shall be in breach of any of his obligations imposed by the Contract, then the additional cost reasonably incurred by the Contractor in consequence thereof shall be added to the Contract Price.

### **C. Payment**

- 12.3 In the event that the Employer fails to make any payment by its respective due date or within the period set forth in the Contract, the Employer shall pay to the Contractor interest on the amount of such delayed payment at the rate(s) shown in the Appendix (Terms and Procedures of Payment) to the Contract Agreement for the period of delay until payment has been made in full, whether before or after judgment or arbitration award.
- 12.4 The currency or currencies in which payments are made to the Contractor under this Contract shall be specified in the Appendix (Terms and Procedures of Payment) to the Contract Agreement, subject to the general principle that payments will be made in the currency or currencies in which the Contract Price has been stated in the Contractor's bid.

### 13. Securities

- 13.1 Issuance of Securities  
The Contractor shall provide the securities specified below in favor of the Employer at the times, and in the amount, manner and form specified below.
- 13.2 Advance Payment Security
- 13.2.1 The Contractor shall, within 30 days of signing the Contract agreement, provide a security in an amount equal to the advance payment calculated in accordance with the Appendix (Terms and Procedures of Payment) to the Contract Agreement, and in the same currency or currencies.
- 13.2.2 The security shall be in the form provided in the bidding documents or in another form acceptable to the Employer. The amount of the security shall be reduced in proportion to the value of the Facilities executed by and paid to the Contractor from time to time, and shall automatically become null and void when the full amount of the advance payment has been recovered by the Employer. The security shall be returned to the Contractor immediately after its expiration.
- 13.3 Performance Security
- 13.3.1 The Contractor shall, within 28 days of the notification of contract award, provide a security for the due performance of the Contract in the **amount specified in the SCC**.
- 13.3.2 The security shall be denominated in the currency or currencies of the Contract, or in a freely convertible currency acceptable to the Employer, and shall be in one of the forms of *bank guarantees* provided in the bidding documents, as stipulated by the Employer in the SCC, or in another form acceptable to the Employer.
- 13.3.3 Unless otherwise specified in the SCC, the security shall be reduced by half on the date of the Operational Acceptance. The Security shall become null and void, or shall be reduced pro rata to the Contract Price of a part of the Facilities for which a separate Time for Completion is provided, 540 days after Completion of the Facilities or 365 days after Operational Acceptance of the Facilities, whichever occurs first; provided, however, that if the Defects Liability Period has been extended on any part of the Facilities pursuant to GCC Sub-Clause 27.8 hereof, the Contractor shall issue an additional security in an amount proportionate to the Contract Price of that part. The security shall be returned to the Contractor immediately after its expiration, provided, however, that if the Contractor, pursuant to GCC Sub-Clause 27.10, is liable for an extended defect liability

obligation, the performance security shall be extended for the period and up to the amount specified in the SCC.

#### **14. Taxes and Duties**

- 14.1 Except as otherwise specifically provided in the Contract, the Employer shall bear and pay all taxes, duties, levies and charges assessed on the Contractor, its Subcontractors or their employees by all municipal, state or national government authorities in connection with the Facilities in and outside of the country where the Site is located.
- 14.2 Notwithstanding GCC Sub-Clause 14.1 above, the Employer shall bear and promptly pay all customs and import duties as well as other local taxes like, e.g., a value added tax (VAT), imposed by the law of the country where the Site is located on the Plant specified in Price Schedule No. 1 and that are to be incorporated into the Facilities.
- 14.3 If any tax exemptions, reductions, allowances or privileges may be available to the Contractor in the country where the Site is located, the Employer shall use its best endeavors to enable the Contractor to benefit from any such tax savings to the maximum allowable extent.
- 14.4 For the purpose of the Contract, it is agreed that the Contract Price specified in Article 2 (Contract Price and Terms of Payment) of the Contract Agreement is based on the taxes, duties, levies and charges prevailing at the date 28 days prior to the date of bid submission in the country where the Site is located (hereinafter called "Tax" in this GCC Sub-Clause 14.4). If any rates of Tax are increased or decreased, a new Tax is introduced, an existing Tax is abolished, or any change in interpretation or application of any Tax occurs in the course of the performance of Contract, which was or will be assessed on the Contractor, Subcontractors or their employees in connection with performance of the Contract, an equitable adjustment of the Contract Price shall be made to fully take into account any such change by addition to the Contract Price or deduction therefrom, as the case may be, in accordance with GCC Clause 36 hereof.

#### **D. Intellectual Property**

#### **15. License/Use of Technical Information**

- 15.1 For the operation and maintenance of the Plant, the Contractor hereby grants a non-exclusive and non-transferable license (without the right to sub-license) to the Employer under the patents, utility models or other industrial property rights owned by the Contractor or by a third party from whom the Contractor has received the right to grant licenses thereunder, and shall also grant to the Employer a non-exclusive and non-transferable right (without the right to sub-license) to use the know-how and other technical information disclosed to the Employer under the Contract. Nothing contained herein shall be construed as transferring ownership of any patent, utility model, trademark, design, copyright, know-how or other intellectual property right from the Contractor or any third party to the Employer.
- 15.2 The copyright in all drawings, documents and other materials containing data and information furnished to the Employer by the Contractor herein shall remain vested in the Contractor or, if they are furnished to the Employer directly or through the Contractor by any third party, including suppliers of materials, the copyright in such materials shall remain vested in such third party.

#### **16. Confidential Information**

- 16.1 The Employer and the Contractor shall keep confidential and shall not, without the written consent of the other party hereto, divulge to any third party any documents, data or other information furnished directly or

indirectly by the other party hereto in connection with the Contract, whether such information has been furnished prior to, during or following termination of the Contract. Notwithstanding the above, the Contractor may furnish to its Subcontractor(s) such documents, data and other information it receives from the Employer to the extent required for the Subcontractor(s) to perform its work under the Contract, in which event the Contractor shall obtain from such Subcontractor(s) an undertaking of confidentiality similar to that imposed on the Contractor under this GCC Clause 16.

- 16.2 The Employer shall not use such documents, data and other information received from the Contractor for any purpose other than the operation and maintenance of the Facilities. Similarly, the Contractor shall not use such documents, data and other information received from the Employer for any purpose other than the design, procurement of Plant, construction or such other work and services as are required for the performance of the Contract.
- 16.3 The obligation of a party under GCC Sub-Clauses 16.1 and 16.2 above, however, shall not apply to that information which
- (a) now or hereafter enters the public domain through no fault of that party
  - (b) can be proven to have been possessed by that party at the time of disclosure and which was not previously obtained, directly or indirectly, from the other party hereto
  - (c) otherwise lawfully becomes available to that party from a third party that has no obligation of confidentiality.
- 16.4 The above provisions of this GCC Clause 16 shall not in any way modify any undertaking of confidentiality given by either of the parties hereto prior to the date of the Contract in respect of the Facilities or any part thereof.
- 16.5 The provisions of this GCC Clause 16 shall survive termination, for whatever reason, of the Contract.

## **E. Execution of the Facilities**

### **17. Representatives**

#### **17.1 Project Manager**

If the Project Manager is not named in the Contract, then within 14 days of the Effective Date, the Employer shall appoint and notify the Contractor in writing of the name of the Project Manager. The Employer may from time to time appoint some other person as the Project Manager in place of the person previously so appointed, and shall give a notice of the name of such other person to the Contractor without delay. No such appointment shall be made at such a time or in such a manner as to impede the progress of work on the Facilities. Such appointment shall only take effect upon receipt of such notice by the Contractor. The Project Manager shall represent and act for the Employer at all times during the performance of the Contract. All notices, instructions, orders, certificates, approvals and all other communications under the Contract shall be given by the Project Manager, except as herein otherwise provided.

All notices, instructions, information and other communications given by the Contractor to the Employer under the Contract shall be given to the Project Manager, except as herein otherwise provided.

**17.2 Contractor's Representative & Construction Manager**

17.2.1 If the Contractor's Representative is not named in the Contract, then within 14 days of the Effective Date, the Contractor shall appoint the Contractor's Representative and shall request the Employer in writing to approve the person so appointed. If the Employer makes no objection to the appointment within 14 days, the Contractor's Representative shall be deemed to have been approved. If the Employer objects to the appointment within 14 days giving the reason therefor, then the Contractor shall appoint a replacement within 14 days of such objection, and the foregoing provisions of this GCC Sub-Clause 17.2.1 shall apply thereto.

17.2.2 The Contractor's Representative shall represent and act for the Contractor at all times during the performance of the Contract and shall give to the Project Manager all the Contractor's notices, instructions, information and all other communications under the Contract.

All notices, instructions, information and all other communications given by the Employer or the Project Manager to the Contractor under the Contract shall be given to the Contractor's Representative or, in its absence, its deputy, except as herein otherwise provided.

The Contractor shall not revoke the appointment of the Contractor's Representative without the Employer's prior written consent, which shall not be unreasonably withheld. If the Employer consents thereto, the Contractor shall appoint some other person as the Contractor's Representative, pursuant to the procedure set out in GCC Sub-Clause 17.2.1.

17.2.3 The Contractor's Representative may, subject to the approval of the Employer which shall not be unreasonably withheld, at any time delegate to any person any of the powers, functions and authorities vested in him or her. Any such delegation may be revoked at any time. Any such delegation or revocation shall be subject to a prior notice signed by the Contractor's Representative, and shall specify the powers, functions and authorities thereby delegated or revoked. No such delegation or revocation shall take effect unless and until a copy thereof has been delivered to the Employer and the Project Manager.

Any act or exercise by any person of powers, functions and authorities so delegated to him or her in accordance with this GCC Sub-Clause 17.2.3 shall be deemed to be an act or exercise by the Contractor's Representative.

17.2.4 From the commencement of installation of the Facilities at the Site until Completion, the Contractor's Representative shall appoint a suitable person as the Construction Manager. The Construction Manager shall supervise all work done at the Site by the Contractor and shall be present at the Site throughout normal working hours except when on leave, sick or absent for reasons connected with the proper performance of the Contract. Whenever the Construction Manager is absent from the Site, the Contractor's Representative or the Construction Manager shall appoint a suitable person to act as the Construction Manager's deputy.

17.2.5 The Employer may by notice to the Contractor object to any representative or person employed by the Contractor in the execution of the Contract who, in the reasonable opinion of the Employer, may behave inappropriately, may be incompetent or negligent, or may commit a serious breach of the Site regulations provided under GCC Sub-Clause 22.4. The Employer shall provide evidence of the same, whereupon the Contractor shall remove such person from the Facilities.

17.2.6 If any representative or person employed by the Contractor is removed in accordance with GCC Sub-Clause 17.2.5, the Contractor shall, where required, promptly appoint a replacement.

## 18. Work Program

### 18.1 Contractor's Organization

The Contractor shall supply to the Employer and the Project Manager a chart showing the proposed organization to be established by the Contractor for carrying out work on the Facilities within 21 days of the Effective Date. The chart shall include the identities of the key personnel and the curricula vitae of such key personnel to be employed shall be supplied together with the chart. The Contractor shall promptly inform the Employer and the Project Manager in writing of any revision or alteration of such an organization chart.

### 18.2 Program of Performance

Within 28 days after the Effective Date, the Contractor shall submit to the Project Manager a detailed program of performance of the Contract, made in a form acceptable to the Project Manager and showing the sequence in which it proposes to design, manufacture, transport, assemble, install and precommission the Facilities, as well as the date by which the Contractor reasonably requires that the Employer shall have fulfilled its obligations under the Contract so as to enable the Contractor to execute the Contract in accordance with the program and to achieve Completion, Commissioning and Acceptance of the Facilities in accordance with the Contract. The program so submitted by the Contractor shall accord with the Time Schedule included in the Appendix (Time Schedule) to the Contract Agreement and any other dates and periods specified in the Contract. The Contractor shall update and revise the program as and when appropriate or when required by the Project Manager, but without modification in the Times for Completion given in the SCC and any extension granted in accordance with GCC Clause 40, and shall submit all such revisions to the Project Manager.

### 18.3 Progress Report

The Contractor shall monitor progress of all the activities specified in the program referred to in GCC Sub-Clause 18.2 above, and supply a progress report to the Project Manager every month.

The progress report shall be in a form acceptable to the Project Manager and shall indicate: (a) percentage completion achieved compared with the planned percentage completion for each activity; and (b) where any activity is behind the program, giving comments and likely consequences and stating the corrective action being taken.

### 18.4 Progress of Performance

If at any time the Contractor's actual progress falls behind the program referred to in GCC Sub-Clause 18.2, or it becomes apparent that it will so fall behind, the Contractor shall, at the request of the Employer or the Project Manager, prepare and submit to the Project Manager a revised program, taking into account the prevailing circumstances, and shall notify the Project Manager of the steps being taken to expedite progress

so as to attain Completion of the Facilities within the Time for Completion under GCC Sub-Clause 8.2, any extension thereof entitled under GCC Sub-Clause 40.1, or any extended period as may otherwise be agreed upon between the Employer and the Contractor.

#### 18.5 Procedures

The Contract shall be executed in accordance with the Contract Documents including the procedures given in the Forms and Procedures of the Employer's Requirements.

The Contractor may execute the Contract in accordance with its own standard project execution plans and procedures to the extent that they do not conflict with the provisions contained in the Contract.

### **19. Subcontracting**

19.1 The Appendix (List of Major Items of Supply and Services and List of Approved Subcontractors) to the Contract Agreement specifies major items of supply or services and a list of approved Subcontractors against each item, including manufacturers. Insofar as no Subcontractors are listed against any such item, the Contractor shall prepare a list of Subcontractors for such item for inclusion in such list. The Contractor may from time to time propose any addition to or deletion from any such list. The Contractor shall submit any such list or any modification thereto to the Employer for its approval in sufficient time so as not to impede the progress of work on the Facilities. Such approval by the Employer for any of the Subcontractors shall not relieve the Contractor from any of its obligations, duties or responsibilities under the Contract.

19.2 The Contractor shall select and employ its Subcontractors for such major items from those listed in the lists referred to in GCC Sub-Clause 19.1.

19.3 For items or parts of the Facilities not specified in the Appendix (List of Major Items of Supply and Services and List of Approved Subcontractors for Major Items) to the Contract Agreement, the Contractor may employ such Subcontractors as it may select, at its discretion.

19.4 Each sub-contract shall include provisions which would entitle the Employer to require the sub-contract to be assigned to the Employer under GCC 19.5 (if and when applicable), or in event of termination by the Employer under GCC 42.2.

19.5 If a sub-contractor's obligations extend beyond the expiry date of the relevant Defects Liability Period and the Project Manager, prior to that date, instructs the Contractor to assign the benefits of such obligations to the Employer, then the Contractor shall do so.

### **20. Design and Engineering**

#### 20.1 Specifications and Drawings

20.1.1 The Contractor shall execute the basic and detailed design and the engineering work in compliance with the provisions of the Contract, or where not so specified, in accordance with good engineering practice.

The Contractor shall be responsible for any discrepancies, errors or omissions in the specifications, drawings and other technical documents that it has prepared, whether such specifications, drawings and other documents have been approved by the Project Manager or not, provided that such discrepancies, errors or omissions are not because of inaccurate information furnished in writing to the Contractor by or on behalf of the Employer.

20.1.2 The Contractor shall be entitled to disclaim responsibility for any design, data, drawing, specification or other document, or any modification thereof provided or designated by or on behalf of the Employer, by giving a notice of such disclaimer to the Project Manager.

20.2 Codes and Standards

Wherever references are made in the Contract to codes and standards in accordance with which the Contract shall be executed, the edition or the revised version of such codes and standards current at the date 28 days prior to date of bid submission shall apply unless otherwise specified. During Contract execution, any changes in such codes and standards shall be applied subject to approval by the Employer and shall be treated in accordance with GCC Clause 39.

20.3 Approval/Review of Technical Documents by Project Manager

20.3.1 The Contractor shall prepare or cause its Subcontractors to prepare, and furnish to the Project Manager the documents listed in the Appendix (List of Documents for Approval or Review) to the Contract Agreement for its approval or review as specified and in accordance with the requirements of GCC Sub-Clause 18.2 (Program of Performance).

Any part of the Facilities covered by or related to the documents to be approved by the Project Manager shall be executed only after the Project Manager's approval thereof.

GCC Sub-Clauses 20.3.2 through 20.3.7 shall apply to those documents requiring the Project Manager's approval, but not to those furnished to the Project Manager for its review only.

20.3.2 Within 14 days after receipt by the Project Manager of any document requiring the Project Manager's approval in accordance with GCC Sub-Clause 20.3.1, the Project Manager shall either return one copy thereof to the Contractor with its approval endorsed thereon or shall notify the Contractor in writing of its disapproval thereof and the reasons therefor and the modifications that the Project Manager proposes.

If the Project Manager fails to take such action within the said 14 days, then the said document shall be deemed to have been approved by the Project Manager.

20.3.3 The Project Manager shall not disapprove any document, except on the grounds that the document does not comply with the Contract or that it is contrary to good engineering practice. If the Project Manager disapproves a document, he shall specify the reasons for his decision.

20.3.4 If the Project Manager disapproves the document, the Contractor shall modify the document and resubmit it for the Project Manager's approval in accordance with GCC Sub-Clause 20.3.2. If the Project Manager approves the document subject to modification(s), the Contractor shall make the required modification(s), whereupon the document shall be deemed to have been approved.

20.3.5 If any dispute or difference occurs between the Employer and the Contractor in connection with or arising out of the disapproval by the Project Manager of any document and/or any modification(s) thereto that cannot be settled between the parties within a

reasonable period, then such dispute or difference may be referred to an Dispute Board for determination in accordance with GCC Sub-Clause 45.3 hereof. If such dispute or difference is referred to an Dispute Board, the Project Manager shall give instructions as to whether and if so, how, performance of the Contract is to proceed. The Contractor shall proceed with the Contract in accordance with the Project Manager's instructions, provided that if the Dispute Board upholds the Contractor's view on the dispute and if the Employer has not given notice under Sub-Clause 45.3 hereof, then the Contractor shall be reimbursed by the Employer for any additional costs incurred by reason of such instructions and shall be relieved of such responsibility or liability in connection with the dispute and the execution of the instructions as the Dispute Board shall decide, and the Time for Completion shall be extended accordingly.

20.3.6 The Project Manager's approval, with or without modification of the document furnished by the Contractor, shall not relieve the Contractor of any responsibility or liability imposed upon it by any provisions of the Contract except to the extent that any subsequent failure results from modifications required by the Project Manager.

20.3.7 The Contractor shall not depart from any approved document unless the Contractor has first submitted to the Project Manager an amended document and obtained the Project Manager's approval thereof, pursuant to the provisions of this GCC Sub-Clause 20.3.

If the Project Manager requests any change in any already approved document and/or in any document based thereon, the provisions of GCC Clause 39 shall apply to such request.

## 21. Procurement

### 21.1 Materials

Subject to GCC Sub-Clause 14.2, the Contractor shall procure and transport all materials in an expeditious and orderly manner to the Site.

### 21.2 Employer-Supplied Materials

If the Appendix (Scope of Works and Supply by the Employer) to the Contract Agreement provides that the Employer shall furnish any specific items to the Contractor, the following provisions shall apply:

21.2.1 The Employer shall, at its own risk and expense, transport each item to the place on or near the Site as agreed upon by the parties and make such item available to the Contractor at the time specified in the program furnished by the Contractor, pursuant to GCC Sub-Clause 18.2, unless otherwise mutually agreed.

21.2.2 Upon receipt of such item, the Contractor shall inspect the same visually and notify the Project Manager of any detected shortage, defect or default. The Employer shall immediately remedy any shortage, defect or default, or the Contractor shall, if practicable and possible, at the request of the Employer, remedy such shortage, defect or default at the Employer's cost and expense. After inspection, such item shall fall under the care, custody and control of the Contractor. The provision of this GCC Sub-Clause 21.2.2 shall apply to any item supplied to remedy any such shortage or defect or to substitute for any defective item, or shall apply to defective items that have been repaired.

21.2.3 The foregoing responsibilities of the Contractor and its obligations of care, custody and control shall not relieve the Employer of liability for any undetected shortage, defect or default, nor place



the Contractor under any liability for any such shortage, defect or default whether under GCC Clause 27 or under any other provision of Contract.

### 21.3 Transportation

21.3.1 The Contractor shall at its own risk and expense transport all the materials and the Contractor's Equipment to the Site by the mode of transport that the Contractor judges most suitable under all the circumstances.

21.3.2 Unless otherwise provided in the Contract, the Contractor shall be entitled to select any safe mode of transport operated by any person to carry the materials and the Contractor's Equipment.

21.3.3 Upon dispatch of each shipment of materials and the Contractor's Equipment, the Contractor shall notify the Employer by telex, cable, facsimile or electronic means, of the description of the materials and of the Contractor's Equipment, the point and means of dispatch, and the estimated time and point of arrival in the country where the Site is located, if applicable, and at the Site. The Contractor shall furnish the Employer with relevant shipping documents to be agreed upon between the parties.

21.3.4 The Contractor shall be responsible for obtaining, if necessary, approvals from the authorities for transportation of the materials and the Contractor's Equipment to the Site. The Employer shall use its best endeavors in a timely and expeditious manner to assist the Contractor in obtaining such approvals, if requested by the Contractor. The Contractor shall indemnify and hold harmless the Employer from and against any claim for damage to roads, bridges or any other traffic facilities that may be caused by the transport of the materials and the Contractor's Equipment to the Site.

### 21.4 Customs Clearance

The Contractor shall, at its own expense, handle all imported materials and Contractor's Equipment at the point(s) of import and shall handle any formalities for customs clearance, subject to the Employer's obligations under GCC Sub-Clause 14.2, provided that if applicable laws or regulations require any application or act to be made by or in the name of the Employer, the Employer shall take all necessary steps to comply with such laws or regulations. In the event of delays in customs clearance that are not the fault of the Contractor, the Contractor shall be entitled to an extension in the Time for Completion, pursuant to GCC Clause 40.

## 22. Installation

### 22.1 **Setting Out/Supervision**

#### 22.1.1 Bench Mark

- (a) The Contractor shall be responsible for the true and proper setting-out of the Facilities in relation to bench marks, reference marks and lines provided to it in writing by *or on behalf of* the Employer.
- (b) If, at any time during the progress of installation of the Facilities, any error shall appear in the position, level or alignment of the Facilities, the Contractor shall forthwith notify the Project Manager of such error and, at its own expense, immediately rectify such error to the reasonable satisfaction of the Project Manager. If such error is based on incorrect data provided in writing by *or on behalf of* the

Employer, the expense of rectifying the same shall be borne by the Employer.

#### 22.1.2 Contractor's Supervision

The Contractor shall give or provide all necessary superintendence during the installation of the Facilities, and the Construction Manager or its deputy shall be constantly on the Site to provide full-time superintendence of the installation. The Contractor shall provide and employ only technical personnel who are skilled and experienced in their respective callings and supervisory staff who are competent to adequately supervise the work at hand.

### **22.2 Labor**

#### 22.2.1 Engagement of Staff and Labor

- (a) Except as otherwise stated in the Specification, the Contractor shall make arrangements for the engagement of all staff and labor, local or otherwise, and for their payment, housing, feeding and transport.
- (b) The Contractor shall provide and employ on the Site in the installation of the Facilities such skilled, semi-skilled and unskilled labor as is necessary for the proper and timely execution of the Contract. The Contractor is encouraged to use local labor that has the necessary skills.
- (c) The Contractor shall be responsible for obtaining all necessary permit(s) and/or visa(s) from the appropriate authorities for the entry of all labor and personnel to be employed on the Site into the country where the Site is located. The Employer will, if requested by the Contractor, use his best endeavors in a timely and expeditious manner to assist the Contractor in obtaining any local, state, national or government permission required for bringing in the Contractor's personnel.
- (d) The Contractor shall at its own expense provide the means of repatriation to all of its and its Subcontractor's personnel employed on the Contract at the Site to the place where they were recruited or to their domicile. It shall also provide suitable temporary maintenance of all such persons from the cessation of their employment on the Contract to the date programmed for their departure. In the event that the Contractor defaults in providing such means of transportation and temporary maintenance, the Employer may provide the same to such personnel and recover the cost of doing so from the Contractor.

#### 22.2.2 Persons in the Service of Employer

The Contractor shall not recruit, or attempt to recruit, staff and labor from amongst the Employer's Personnel.

#### 22.2.3 Labor Laws

- (a) The Contractor shall comply with all the relevant labor Laws applicable to the Contractor's Personnel, including Laws relating to their employment, health, safety, welfare,

immigration and emigration, and shall allow them all their legal rights.

- (b) The Contractor shall at all times during the progress of the Contract use its best endeavors to prevent any unlawful, riotous or disorderly conduct or behavior by or amongst its employees and the labor of its Subcontractors.
- (c) The Contractor shall, in all dealings with its labor and the labor of its Subcontractors currently employed on or connected with the Contract, pay due regard to all recognized festivals, official holidays, religious or other customs and all local laws and regulations pertaining to the employment of labor.

#### 22.2.4 Rates of Wages and Conditions of Labor

- (a) The Contractor shall pay rates of wages, and observe conditions of labor, which are not lower than those established for the trade or industry where the work is carried out. If no established rates or conditions are applicable, the Contractor shall pay rates of wages and observe conditions which are not lower than the general level of wages and conditions observed locally by employers whose trade or industry is similar to that of the Contractor.
- (b) The Contractor shall inform the Contractor's Personnel about their liability to pay personal income taxes in the Country in respect of such of their salaries, wages and allowances as are chargeable under the Laws for the time being in force, and the Contractor shall perform such duties in regard to such deductions thereof as may be imposed on him by such Laws.

#### 22.2.5 Working Hours

- (a) No work shall be carried out on the Site on locally recognized days of rest, or outside the normal working hours stated in the SCC, unless:
  - (i) otherwise stated in the Contract,
  - (ii) the Project Manager gives consent, or
  - (iii) the work is unavoidable, or necessary for the protection of life or property or for the safety of the Works, in which case the Contractor shall immediately advise the Project Manager.
- (b) If and when the Contractor considers it necessary to carry out work at night or on public holidays so as to meet the Time for Completion and requests the Project Manager's consent thereto, the Project Manager shall not unreasonably withhold such consent.
- (c) This Sub-Clause shall not apply to any work which is customarily carried out by rotary or double-shifts.

#### 22.2.6 Facilities for Staff and Labor

- (a) Except as otherwise stated in the Specification, the Contractor shall provide and maintain all necessary accommodation and welfare facilities for the Contractor's

Personnel. The Contractor shall also provide facilities for the Employer's Personnel as stated in the Specification.

- (b) The Contractor shall not permit any of the Contractor's Personnel to maintain any temporary or permanent living quarters within the structures forming part of the Permanent Works.

#### 22.2.7 Health and Safety

- (a) The Contractor shall at all times take all reasonable precautions to maintain the health and safety of the Contractor's Personnel. In collaboration with local health authorities, the Contractor shall ensure that medical staff, first aid facilities, sick bay and ambulance service are available at all times at the Site and at any accommodation for Contractor's and Employer's Personnel, and that suitable arrangements are made for all necessary welfare and hygiene requirements and for the prevention of epidemics.
- (b) The Contractor shall appoint an accident prevention officer at the Site, responsible for maintaining safety and protection against accidents. This person shall be qualified for this responsibility, and shall have the authority to issue instructions and take protective measures to prevent accidents. Throughout the performance of the Contract, the Contractor shall provide whatever is required by this person to exercise this responsibility and authority.
- (c) The Contractor shall send, to the Project Manager, details of any accident as soon as practicable after its occurrence. The Contractor shall maintain records and make reports concerning health, safety and welfare of persons, and damage to property, as the Project Manager may reasonably require.

#### 22.2.8 Funeral Arrangements

In the event of the death of any of the Contractor's personnel or accompanying members of their families, the Contractor shall be responsible for making the appropriate arrangements for their return or burial, unless otherwise specified in the SCC.

#### 22.2.9 Records of Contractor's Personnel

The Contractor shall keep accurate records of the Contractor's personnel, including the number of each class of Contractor's Personnel on the Site and the names, ages, genders, hours worked and wages paid to all workers. These records shall be summarized on a monthly basis in a form approved by the Project Manager and shall be available for inspection by the Project Manager. until the Contractor has completed all work.

#### 22.2.10 Supply of Foodstuffs

The Contractor shall arrange for the provision of a sufficient supply of suitable food as may be stated in the Specification at reasonable prices for the Contractor's Personnel for the purposes of or in connection with the Contract.

#### 22.2.11 Supply of Water

The Contractor shall, having regard to local conditions, provide on the Site an adequate supply of drinking and other water for the use of the Contractor's Personnel.

22.2.12 Measures against Insect and Pest Nuisance

The Contractor shall at all times take the necessary precautions to protect the Contractor's Personnel employed on the Site from insect and pest nuisance, and to reduce their danger to health. The Contractor shall comply with all the regulations of the local health authorities, including use of appropriate insecticide.

22.2.13 Alcoholic Liquor or Drugs

The Contractor shall not, otherwise than in accordance with the Laws of the Country, import, sell, give barter or otherwise dispose of any alcoholic liquor or drugs, or permit or allow importation, sale, gift barter or disposal by Contractor's Personnel.

22.2.14 Arms and Ammunition

The Contractor shall not give, barter, or otherwise dispose of, to any person, any arms or ammunition of any kind, or allow Contractor's Personnel to do so.

22.2.15 Prohibition of All Forms of Forced or Compulsory Labor

The contractor shall not employ "forced or compulsory labor" in any form. "Forced or compulsory labor" consists of all work or service, not voluntarily performed, that is extracted from an individual under threat of force or penalty.

22.2.16 Prohibition of Harmful Child Labor

The Contractor shall not employ any child to perform any work that is economically exploitative, or is likely to be hazardous to, or to interfere with, the child's education, or to be harmful to the child's health or physical, mental, spiritual, moral, or social development.

22.3 Contractor's Equipment

22.3.1 All Contractor's Equipment brought by the Contractor onto the Site shall be deemed to be intended to be used exclusively for the execution of the Contract. The Contractor shall not remove the same from the Site without the Project Manager's consent that such Contractor's Equipment is no longer required for the execution of the Contract.

22.3.2 Unless otherwise specified in the Contract, upon completion of the Facilities, the Contractor shall remove from the Site all Equipment brought by the Contractor onto the Site and any surplus materials remaining thereon.

22.3.3 The Employer will, if requested, use its best endeavors to assist the Contractor in obtaining any local, state or national government permission required by the Contractor for the export of the Contractor's Equipment imported by the Contractor for use in the execution of the Contract that is no longer required for the execution of the Contract.

22.4 Site Regulations and Safety

The Employer and the Contractor shall establish Site regulations setting out the rules to be observed in the execution of the Contract at the Site and shall comply therewith. The Contractor shall prepare and submit to

the Employer, with a copy to the Project Manager, proposed Site regulations for the Employer's approval, which approval shall not be unreasonably withheld.

Such Site regulations shall include, but shall not be limited to, rules in respect of security, safety of the Facilities, gate control, sanitation, medical care, and fire prevention.

## 22.5 Opportunities for Other Contractors

22.5.1 The Contractor shall, upon written request from the Employer or the Project Manager, give all reasonable opportunities for carrying out the work to any other contractors employed by the Employer on or near the Site.

22.5.2 If the Contractor, upon written request from the Employer or the Project Manager, makes available to other contractors any roads or ways the maintenance for which the Contractor is responsible, permits the use by such other contractors of the Contractor's Equipment, or provides any other service of whatsoever nature for such other contractors, the Employer shall fully compensate the Contractor for any loss or damage caused or occasioned by such other contractors in respect of any such use or service, and shall pay to the Contractor reasonable remuneration for the use of such equipment or the provision of such services.

22.5.3 The Contractor shall also so arrange to perform its work as to minimize, to the extent possible, interference with the work of other contractors. The Project Manager shall determine the resolution of any difference or conflict that may arise between the Contractor and other contractors and the workers of the Employer in regard to their work.

22.5.4 The Contractor shall notify the Project Manager promptly of any defects in the other contractors' work that come to its notice, and that could affect the Contractor's work. The Project Manager shall determine the corrective measures, if any, required to rectify the situation after inspection of the Facilities. Decisions made by the Project Manager shall be binding on the Contractor.

## 22.6 Emergency Work

If, by reason of an emergency arising in connection with and during the execution of the Contract, any protective or remedial work is necessary as a matter of urgency to prevent damage to the Facilities, the Contractor shall immediately carry out such work.

If the Contractor is unable or unwilling to do such work immediately, the Employer may do or cause such work to be done as the Employer may determine is necessary in order to prevent damage to the Facilities. In such event the Employer shall, as soon as practicable after the occurrence of any such emergency, notify the Contractor in writing of such emergency, the work done and the reasons therefor. If the work done or caused to be done by the Employer is work that the Contractor was liable to do at its own expense under the Contract, the reasonable costs incurred by the Employer in connection therewith shall be paid by the Contractor to the Employer. Otherwise, the cost of such remedial work shall be borne by the Employer.

## 22.7 Site Clearance

22.7.1 Site Clearance in Course of Performance

In the course of carrying out the Contract, the Contractor shall keep the Site reasonably free from all unnecessary obstruction, store or remove any surplus materials, clear away any wreckage, rubbish or temporary works from the Site, and remove any Contractor's Equipment no longer required for execution of the Contract.

22.7.2 Clearance of Site after Completion

After Completion of all parts of the Facilities, the Contractor shall clear away and remove all wreckage, rubbish and debris of any kind from the Site, and shall leave the Site and Facilities in a clean and safe condition.

22.8 Watching and Lighting

The Contractor shall provide and maintain at its own expense all lighting, fencing, and watching when and where necessary for the proper execution and the protection of the Facilities, or for the safety of the owners and occupiers of adjacent property and for the safety of the public.

**23. Test and Inspection**

23.1 The Contractor shall at its own expense carry out at the place of manufacture and/or on the Site all such tests and/or inspections of the Plant and any part of the Facilities as are specified in the Contract.

23.2 The Employer and the Project Manager or their designated representatives shall be entitled to attend the aforesaid test and/or inspection, provided that the Employer shall bear all costs and expenses incurred in connection with such attendance including, but not limited to, all traveling and board and lodging expenses.

23.3 Whenever the Contractor is ready to carry out any such test and/or inspection, the Contractor shall give a reasonable advance notice of such test and/or inspection and of the place and time thereof to the Project Manager. The Contractor shall obtain from any relevant third party or manufacturer any necessary permission or consent to enable the Employer and the Project Manager or their designated representatives to attend the test and/or inspection.

23.4 The Contractor shall provide the Project Manager with a certified report of the results of any such test and/or inspection.

If the Employer or Project Manager or their designated representatives fails to attend the test and/or inspection, or if it is agreed between the parties that such persons shall not do so, then the Contractor may proceed with the test and/or inspection in the absence of such persons, and may provide the Project Manager with a certified report of the results thereof.

23.5 The Project Manager may require the Contractor to carry out any test and/or inspection not required by the Contract, provided that the Contractor's reasonable costs and expenses incurred in the carrying out of such test and/or inspection shall be added to the Contract Price. Further, if such test and/or inspection impedes the progress of work on the Facilities and/or the Contractor's performance of its other obligations under the Contract, due allowance will be made in respect of the Time for Completion and the other obligations so affected.

- 23.6 If any Plant or any part of the Facilities fails to pass any test and/or inspection, the Contractor shall either rectify or replace such Plant or part of the Facilities and shall repeat the test and/or inspection upon giving a notice under GCC Sub-Clause 23.3.
- 23.7 If any dispute or difference of opinion shall arise between the parties in connection with or arising out of the test and/or inspection of the Plant or part of the Facilities that cannot be settled between the parties within a reasonable period of time, it may be referred to a Dispute Board for determination in accordance with GCC Sub-Clause 45.3.
- 23.8 The Contractor shall afford the Employer and the Project Manager, at the Employer's expense, access at any reasonable time to any place where the Plant are being manufactured or the Facilities are being installed, in order to inspect the progress and the manner of manufacture or installation, provided that the Project Manager shall give the Contractor a reasonable prior notice.
- 23.9 The Contractor agrees that neither the execution of a test and/or inspection of Plant or any part of the Facilities, nor the attendance by the Employer or the Project Manager, nor the issue of any test certificate pursuant to GCC Sub-Clause 23.4, shall release the Contractor from any other responsibilities under the Contract.
- 23.10 No part of the Facilities or foundations shall be covered up on the Site without the Contractor carrying out any test and/or inspection required under the Contract. The Contractor shall give a reasonable notice to the Project Manager whenever any such parts of the Facilities or foundations are ready or about to be ready for test and/or inspection; such test and/or inspection and notice thereof shall be subject to the requirements of the Contract.
- 23.11 The Contractor shall uncover any part of the Facilities or foundations, or shall make openings in or through the same as the Project Manager may from time to time require at the Site, and shall reinstate and make good such part or parts.

If any parts of the Facilities or foundations have been covered up at the Site after compliance with the requirement of GCC Sub-Clause 23.10 and are found to be executed in accordance with the Contract, the expenses of uncovering, making openings in or through, reinstating, and making good the same shall be borne by the Employer, and the Time for Completion shall be reasonably adjusted to the extent that the Contractor has thereby been delayed or impeded in the performance of any of its obligations under the Contract.

#### **24. Completion of the Facilities**

- 24.1 As soon as the Facilities or any part thereof has, in the opinion of the Contractor, been completed operationally and structurally and put in a tight and clean condition as specified in the Employer's Requirements, excluding minor items not materially affecting the operation or safety of the Facilities, the Contractor shall so notify the Employer in writing.
- 24.2 Within 7 days after receipt of the notice from the Contractor under GCC Sub-Clause 24.1, the Employer shall supply the operating and maintenance personnel specified in the Appendix (Scope of Works and Supply by the Employer) to the Contract Agreement for Pre-commissioning of the Facilities or any part thereof.

Pursuant to the Appendix (Scope of Works and Supply by the Employer) to the Contract Agreement, the Employer shall also provide, within the said seven (7) day period, the raw materials, utilities, lubricants,



chemicals, catalysts, facilities, services and other matters required for Pre-commissioning of the Facilities or any part thereof.

- 24.3 As soon as reasonably practicable after the operating and maintenance personnel have been supplied by the Employer and the raw materials, utilities, lubricants, chemicals, catalysts, facilities, services and other matters have been provided by the Employer in accordance with GCC Sub-Clause 24.2, the Contractor shall commence Pre-commissioning of the Facilities or the relevant part thereof in preparation for Commissioning, subject to GCC Sub-Clause 25.5.
- 24.4 As soon as all works in respect of Pre-commissioning are completed and, in the opinion of the Contractor, the Facilities or any part thereof is ready for Commissioning, the Contractor shall so notify the Project Manager in writing.
- 24.5 The Project Manager shall, within 14 days after receipt of the Contractor's notice under GCC Sub-Clause 24.4, either issue a Completion Certificate in the form specified in the Employer's Requirements (Forms and Procedures), stating that the Facilities or that part thereof have reached Completion as of the date of the Contractor's notice under GCC Sub-Clause 24.4, or notify the Contractor in writing of any defects and/or deficiencies.

If the Project Manager notifies the Contractor of any defects and/or deficiencies, the Contractor shall then correct such defects and/or deficiencies, and shall repeat the procedure described in GCC Sub-Clause 24.4.

If the Project Manager is satisfied that the Facilities or that part thereof have reached Completion, the Project Manager shall, within 7 days after receipt of the Contractor's repeated notice, issue a Completion Certificate stating that the Facilities or that part thereof have reached Completion as of the date of the Contractor's repeated notice.

If the Project Manager is not so satisfied, then it shall notify the Contractor in writing of any defects and/or deficiencies within 7 days after receipt of the Contractor's repeated notice, and the above procedure shall be repeated.

- 24.6 If the Project Manager fails to issue the Completion Certificate and fails to inform the Contractor of any defects and/or deficiencies within 14 days after receipt of the Contractor's notice under GCC Sub-Clause 24.4 or within 7 days after receipt of the Contractor's repeated notice under GCC Sub-Clause 24.5, or if the Employer makes use of the Facilities or part thereof, then the Facilities or that part thereof shall be deemed to have reached Completion as of the date of the Contractor's notice or repeated notice, or as of the Employer's use of the Facilities, as the case may be.
- 24.7 As soon as possible after Completion, the Contractor shall complete all outstanding minor items so that the Facilities are fully in accordance with the requirements of the Contract, failing which the Employer will undertake such completion and deduct the costs thereof from any monies owing to the Contractor.
- 24.8 Upon Completion, the Employer shall be responsible for the care and custody of the Facilities or the relevant part thereof, together with the risk of loss or damage thereto, and shall thereafter take over the Facilities or the relevant part thereof.

**25. Commissioning and Operational Acceptance****25.1 Commissioning**

25.1.1 Commissioning of the Facilities or any part thereof shall be commenced by the Contractor immediately after issue of the Completion Certificate by the Project Manager, pursuant to GCC Sub-Clause 24.5, or immediately after the date of the deemed Completion, under GCC Sub-Clause 24.6.

25.1.2 The Employer shall supply the operating and maintenance personnel and all raw materials, utilities, lubricants, chemicals, catalysts, facilities, services and other matters required for Commissioning.

25.1.3 In accordance with the requirements of the Contract, the Contractor's and Project Manager's advisory personnel shall attend the Commissioning, including the Guarantee Test, and shall advise and assist the Employer.

**25.2 Guarantee Test**

25.2.1 Subject to GCC Sub-Clause 25.5, the Guarantee Test and repeats thereof shall be conducted by the Contractor during Commissioning of the Facilities or the relevant part thereof to ascertain whether the Facilities or the relevant part can attain the Functional Guarantees specified in the Appendix (Functional Guarantees) to the Contract Agreement. The Employer shall promptly provide the Contractor with such information as the Contractor may reasonably require in relation to the conduct and results of the Guarantee Test and any repeats thereof.

25.2.2 If for reasons not attributable to the Contractor, the Guarantee Test of the Facilities or the relevant part thereof cannot be successfully completed within the period from the date of Completion specified in the SCC or any other period agreed upon by the Employer and the Contractor, the Contractor shall be deemed to have fulfilled its obligations with respect to the Functional Guarantees, and GCC Sub-Clauses 28.2 and 28.3 shall not apply.

**25.3 Operational Acceptance**

25.3.1 Subject to GCC Sub-Clause 25.4 below, Operational Acceptance shall occur in respect of the Facilities or any part thereof when

- (a) the Guarantee Test has been successfully completed and the Functional Guarantees are met; or
- (b) the Guarantee Test has not been successfully completed or has not been carried out for reasons not attributable to the Contractor within the period from the date of Completion specified in the SCC or any other agreed upon period as specified in GCC Sub-Clause 25.2.2 above; or
- (c) the Contractor has paid the liquidated damages specified in GCC Sub-Clause 28.3 hereof; and
- (d) any minor items mentioned in GCC Sub-Clause 24.7 hereof relevant to the Facilities or that part thereof have been completed.

25.3.2 At any time after any of the events set out in GCC Sub-Clause 25.3.1 have occurred, the Contractor may give a notice to the Project Manager requesting the issue of an Operational

Acceptance Certificate in the form provided in the Employer's Requirements (Forms and Procedures) in respect of the Facilities or the part thereof specified in such notice as of the date of such notice.

25.3.3 The Project Manager shall, after consultation with the Employer, and within 7 days after receipt of the Contractor's notice, issue an Operational Acceptance Certificate.

25.3.4 If within 7 days after receipt of the Contractor's notice, the Project Manager fails to issue the Operational Acceptance Certificate or fails to inform the Contractor in writing of the justifiable reasons why the Project Manager has not issued the Operational Acceptance Certificate, the Facilities or the relevant part thereof shall be deemed to have been accepted as of the date of the Contractor's said notice.

#### 25.4 Partial Acceptance

25.4.1 If the Contract specifies that Completion and Commissioning shall be carried out in respect of parts of the Facilities, the provisions relating to Completion and Commissioning including the Guarantee Test shall apply to each such part of the Facilities individually, and the Operational Acceptance Certificate shall be issued accordingly for each such part of the Facilities.

25.4.2 If a part of the Facilities comprises facilities such as buildings, for which no Commissioning or Guarantee Test is required, then the Project Manager shall issue the Operational Acceptance Certificate for such facility when it attains Completion, provided that the Contractor shall thereafter complete any outstanding minor items that are listed in the Operational Acceptance Certificate.

#### 25.5 Delayed Precommissioning and/or Guarantee Test

25.5.1 In the event that the Contractor is unable to proceed with the Precommissioning of the Facilities pursuant to Sub-Clause 24.3, or with the Guarantee Test pursuant to Sub-Clause 25.2, for reasons attributable to the Employer either on account of non availability of other facilities under the responsibilities of other contractor(s), or for reasons beyond the Employer's control, the provisions leading to "deemed" completion of activities such as Completion, pursuant to GCC Sub-Clause 24.6, and Operational Acceptance, pursuant to GCC Sub-Clause 25.3.4, and Contractor's obligations regarding Defect Liability Period, pursuant to GCC Sub-Clause 27.2, Functional Guarantee, pursuant to GCC Clause 28, and Care of Facilities, pursuant to GCC Clause 32, and GCC Clause 41.1, Suspension, shall not apply. In this case, the following provisions shall apply.

25.5.2 When the Contractor is notified by the Project Manager that he will be unable to proceed with the activities and obligations pursuant to above Sub-Clause 25.5.1, the Contractor shall be entitled to the following:

- (a) the Time of Completion shall be extended for the period of suspension without imposition of liquidated damages pursuant to GCC Sub-Clause 26.2;

- (b) payments due to the Contractor in accordance with the provision specified in the Appendix (Terms and Procedures of Payment) to the Contract Agreement, which would not have been payable in normal circumstances due to non-completion of the subject activities, shall be released to the Contractor against submission of a security in the form of a bank guarantee of equivalent amount acceptable to the Employer, and which shall become null and void when the Contractor will have complied with its obligations regarding those payments, subject to the provision of Sub-Clause 25.5.3 below;
- (c) the expenses towards the above security and extension of other securities under the contract, of which validity needs to be extended, shall be reimbursed to the Contractor by the Employer;
- (d) the additional charges towards the care of the Facilities pursuant to GCC Sub-Clause 32.1 shall be reimbursed to the Contractor by the Employer for the period between the notification mentioned above and the notification mentioned in Sub-Clause 25.5.4 below. The provision of GCC Sub-Clause 33.2 shall apply to the Facilities during the same period.

25.5.3 In the event that the period of suspension under above Sub-Clause 25.5.1 actually exceeds 180 days, the Employer and Contractor shall mutually agree to any additional compensation payable to the Contractor.

25.5.4 When the Contractor is notified by the Project Manager that the plant is ready for Precommissioning, the Contractor shall proceed without delay in performing all the specified activities and obligations under the contract.

## F. Guarantees and Liabilities

### 26. Completion Time Guarantee

- 26.1 The Contractor guarantees that it shall attain Completion of the Facilities (or a part for which a separate time for completion is specified) within the Time for Completion specified in the SCC pursuant to GCC Sub-Clause 8.2, or within such extended time to which the Contractor shall be entitled under GCC Clause 40 hereof.
- 26.2 If the Contractor fails to attain Completion of the Facilities or any part thereof within the Time for Completion or any extension thereof under GCC Clause 40, the Contractor shall pay to the Employer liquidated damages in the amount specified in the SCC as a percentage rate of the Contract Price or the relevant part thereof. The aggregate amount of such liquidated damages shall in no event exceed the amount specified as "Maximum" in the SCC as a percentage rate of the Contract Price. Once the "Maximum" is reached, the Employer may consider termination of the Contract, pursuant to GCC Sub-Clause 42.2.2.

Such payment shall completely satisfy the Contractor's obligation to attain Completion of the Facilities or the relevant part thereof within the Time for Completion or any extension thereof under GCC Clause 40.

The Contractor shall have no further liability whatsoever to the Employer in respect thereof.

However, the payment of liquidated damages shall not in any way relieve the Contractor from any of its obligations to complete the Facilities or from any other obligations and liabilities of the Contractor under the Contract.

Save for liquidated damages payable under this GCC Sub-Clause 26.2, the failure by the Contractor to attain any milestone or other act, matter or thing by any date specified in the Appendix (Time Schedule) to the Contract Agreement and/or other program of work prepared pursuant to GCC Sub-Clause 18.2 shall not render the Contractor liable for any loss or damage thereby suffered by the Employer.

- 26.3 If the Contractor attains Completion of the Facilities or any part thereof before the Time for Completion or any extension thereof under GCC Clause 40, the Employer shall pay to the Contractor a bonus in the amount specified in the SCC. The aggregate amount of such bonus shall in no event exceed the amount specified as "Maximum" in the SCC.

## 27. Defect Liability

- 27.1 The Contractor warrants that the Facilities or any part thereof shall be free from defects in the design, engineering, materials and workmanship of the Plant supplied and of the work executed.

- 27.2 The Defect Liability Period shall be 540 days from the date of Completion of the Facilities (or any part thereof) or one year from the date of Operational Acceptance of the Facilities (or any part thereof), whichever first occurs, unless specified otherwise in the SCC pursuant to GCC Sub-Clause 27.10.

If during the Defect Liability Period any defect should be found in the design, engineering, materials and workmanship of the Plant supplied or of the work executed by the Contractor, the Contractor shall promptly, in consultation and agreement with the Employer regarding appropriate remedying of the defects, and at its cost, repair, replace or otherwise make good as the Contractor shall determine at its discretion, such defect as well as any damage to the Facilities caused by such defect. The Contractor shall not be responsible for the repair, replacement or making good of any defect or of any damage to the Facilities arising out of or resulting from any of the following causes:

- (a) improper operation or maintenance of the Facilities by the Employer;
  - (b) operation of the Facilities outside specifications provided in the Contract; or
  - (c) normal wear and tear.
- 27.3 The Contractor's obligations under this GCC Clause 27 shall not apply to:
- (a) any materials that are supplied by the Employer under GCC Sub-Clause 21.2, are normally consumed in operation, or have a normal life shorter than the Defect Liability Period stated herein;
  - (b) any designs, specifications or other data designed, supplied or specified by or on behalf of the Employer or any matters for which the Contractor has disclaimed responsibility herein; or

- (c) any other materials supplied or any other work executed by or on behalf of the Employer, except for the work executed by the Employer under GCC Sub-Clause 27.7.

27.4 The Employer shall give the Contractor a notice stating the nature of any such defect together with all available evidence thereof, promptly following the discovery thereof. The Employer shall afford all reasonable opportunity for the Contractor to inspect any such defect.

27.5 The Employer shall afford the Contractor all necessary access to the Facilities and the Site to enable the Contractor to perform its obligations under this GCC Clause 27.

The Contractor may, with the consent of the Employer, remove from the Site any Plant or any part of the Facilities that are defective if the nature of the defect, and/or any damage to the Facilities caused by the defect, is such that repairs cannot be expeditiously carried out at the Site.

27.6 If the repair, replacement or making good is of such a character that it may affect the efficiency of the Facilities or any part thereof, the Employer may give to the Contractor a notice requiring that tests of the defective part of the Facilities shall be made by the Contractor immediately upon completion of such remedial work, whereupon the Contractor shall carry out such tests.

If such part fails the tests, the Contractor shall carry out further repair, replacement or making good, as the case may be, until that part of the Facilities passes such tests. The tests shall be agreed upon by the Employer and the Contractor.

27.7 If the Contractor fails to commence the work necessary to remedy such defect or any damage to the Facilities caused by such defect within a reasonable time (which shall in no event be considered to be less than 15 days), the Employer may, following notice to the Contractor, proceed to do such work, and the reasonable costs incurred by the Employer in connection therewith shall be paid to the Employer by the Contractor or may be deducted by the Employer from any monies due the Contractor or claimed under the Performance Security.

27.8 If the Facilities or any part thereof cannot be used by reason of such defect and/or making good of such defect, the Defect Liability Period of the Facilities or such part, as the case may be, shall be extended by a period equal to the period during which the Facilities or such part cannot be used by the Employer because of any of the aforesaid reasons.

27.9 Except as provided in GCC Clauses 27 and 33, the Contractor shall be under no liability whatsoever and howsoever arising, and whether under the Contract or at law, in respect of defects in the Facilities or any part thereof, the Plant, design or engineering or work executed that appear after Completion of the Facilities or any part thereof, except where such defects are the result of the gross negligence, fraud, criminal or willful action of the Contractor.

27.10 In addition, any such component of the Facilities and during the period of time as may be specified in the SCC shall be subject to an extended Defect Liability Period. Such obligation of the Contractor shall be in addition to the Defect Liability Period specified under GCC Sub-Clause 27.2.

## **28. Functional Guarantees**

28.1 The Contractor guarantees that during the Guarantee Test, the Facilities and all parts thereof shall attain the Functional Guarantees specified in

the Appendix (Functional Guarantees) to the Contract Agreement, subject to and upon the conditions therein specified.

- 28.2 If, for reasons attributable to the Contractor, the minimum level of the Functional Guarantees specified in the Appendix (Functional Guarantees) to the Contract Agreement are not met either in whole or in part, the Contractor shall at its cost and expense make such changes, modifications and/or additions to the Plant or any part thereof as may be necessary to meet at least the minimum level of such Guarantees. The Contractor shall notify the Employer upon completion of the necessary changes, modifications and/or additions, and shall request the Employer to repeat the Guarantee Test until the minimum level of the Guarantees has been met. If the Contractor eventually fails to meet the minimum level of Functional Guarantees, the Employer may consider termination of the Contract, pursuant to GCC Sub-Clause 42.2.2.
- 28.3 If, for reasons attributable to the Contractor, the Functional Guarantees specified in the Appendix (Functional Guarantees) to the Contract Agreement are not attained either in whole or in part, but the minimum level of the Functional Guarantees specified in the said Appendix to the Contract Agreement is met, the Contractor shall, at the Contractor's option, either
- (a) make such changes, modifications and/or additions to the Facilities or any part thereof that are necessary to attain the Functional Guarantees at its cost and expense, and shall request the Employer to repeat the Guarantee Test or
  - (b) pay liquidated damages to the Employer in respect of the failure to meet the Functional Guarantees in accordance with the provisions in the Appendix (Functional Guarantees) to the Contract Agreement.
- 28.4 The payment of liquidated damages under GCC Sub-Clause 28.3, up to the limitation of liability specified in the Appendix (Functional Guarantees) to the Contract Agreement, shall completely satisfy the Contractor's guarantees under GCC Sub-Clause 28.3, and the Contractor shall have no further liability whatsoever to the Employer in respect thereof. Upon the payment of such liquidated damages by the Contractor, the Project Manager shall issue the Operational Acceptance Certificate for the Facilities or any part thereof in respect of which the liquidated damages have been so paid.

## **29. Patent Indemnity**

- 29.1 The Contractor shall, subject to the Employer's compliance with GCC Sub-Clause 29.2, indemnify and hold harmless the Employer and its employees and officers from and against any and all suits, actions or administrative proceedings, claims, demands, losses, damages, costs, and expenses of whatsoever nature, including attorney's fees and expenses, which the Employer may suffer as a result of any infringement or alleged infringement of any patent, utility model, registered design, trademark, copyright or other intellectual property right registered or otherwise existing at the date of the Contract by reason of: (a) the installation of the Facilities by the Contractor or the use of the Facilities in the country where the Site is located; and
- (b) the sale of the products produced by the Facilities in any country.

Such indemnity shall **not** cover any use of the Facilities or any part thereof other than for the purpose indicated by or to be reasonably inferred from the Contract, any infringement resulting from the use of the Facilities or any part thereof, or any products produced thereby in association or combination with any other equipment, plant or materials not supplied by the Contractor, pursuant to the Contract Agreement.

- 29.2 If any proceedings are brought or any claim is made against the Employer arising out of the matters referred to in GCC Sub-Clause 29.1, the Employer shall promptly give the Contractor a notice thereof, and the Contractor may at its own expense and in the Employer's name conduct such proceedings or claim and any negotiations for the settlement of any such proceedings or claim.

If the Contractor fails to notify the Employer within 28 days after receipt of such notice, that it intends to conduct any such proceedings or claim, then the Employer shall be free to conduct the same on its own behalf. Unless the Contractor has so failed to notify the Employer within the 28 days period, the Employer shall make no admission that may be prejudicial to the defense of any such proceedings or claim.

The Employer shall, at the Contractor's request, afford all available assistance to the Contractor in conducting such proceedings or claim, and shall be reimbursed by the Contractor for all reasonable expenses incurred in so doing.

- 29.3 The Employer shall indemnify and hold harmless the Contractor and its employees, officers and Subcontractors from and against any and all suits, actions or administrative proceedings, claims, demands, losses, damages, costs, and expenses of whatsoever nature, including attorney's fees and expenses, which the Contractor may suffer as a result of any infringement or alleged infringement of any patent, utility model, registered design, trademark, copyright or other intellectual property right registered or otherwise existing at the date of the Contract arising out of or in connection with any design, data, drawing, specification, or other documents or materials provided or designed by or on behalf of the Employer.

### **30. Limitation of Liability**

- 30.1 Except in cases of criminal negligence or willful misconduct,
- (a) the Contractor shall not be liable to the Employer, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the Contractor to pay liquidated damages to the Employer and
  - (b) the aggregate liability of the Contractor to the Employer, whether under the Contract, in tort or otherwise, shall not exceed a multiple of the Contract Price specified in the SCC or, if a multiple is not so specified, the total Contract Price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment, or to any obligation of the Contractor to indemnify the Employer with respect to patent infringement.

## **G. Risk Distribution**

### **31. Transfer of Ownership**

- 31.1 Ownership of the Plant (including spare parts) to be imported into the country where the Site is located shall be transferred to the Employer upon loading on to the mode of transport to be used to convey the Plant from the country of origin to that country.
- 31.2 Ownership of the Plant (including spare parts) procured in the country where the Site is located shall be transferred to the Employer when the Plant are brought on to the Site.



- 31.3 Ownership of the Contractor's Equipment used by the Contractor and its Subcontractors in connection with the Contract shall remain with the Contractor or its Subcontractors.
- 31.4 Ownership of any Plant in excess of the requirements for the Facilities shall revert to the Contractor upon Completion of the Facilities or at such earlier time when the Employer and the Contractor agree that the Plant in question are no longer required for the Facilities.
- 31.5 Notwithstanding the transfer of ownership of the Plant, the responsibility for care and custody thereof together with the risk of loss or damage thereto shall remain with the Contractor pursuant to GCC Clause 32 (Care of Facilities) hereof until Completion of the Facilities or the part thereof in which such Plant are incorporated.

## **32. Care of Facilities**

- 32.1 The Contractor shall be responsible for the care and custody of the Facilities or any part thereof until the date of Completion of the Facilities pursuant to GCC Clause 24 or, where the Contract provides for Completion of the Facilities in parts, until the date of Completion of the relevant part, and shall make good at its own cost any loss or damage that may occur to the Facilities or the relevant part thereof from any cause whatsoever during such period. The Contractor shall also be responsible for any loss or damage to the Facilities caused by the Contractor or its Subcontractors in the course of any work carried out, pursuant to GCC Clause 27. Notwithstanding the foregoing, the Contractor shall not be liable for any loss or damage to the Facilities or that part thereof caused by reason of any of the matters specified or referred to in paragraphs (a), (b) and (c) of GCC Sub-Clauses 32.2 and 38.1.
- 32.2 If any loss or damage occurs to the Facilities or any part thereof or to the Contractor's temporary facilities by reason of
- (a) insofar as they relate to the country where the Site is located, nuclear reaction, nuclear radiation, radioactive contamination, pressure wave caused by aircraft or other aerial objects, or any other occurrences that an experienced contractor could not reasonably foresee, or if reasonably foreseeable could not reasonably make provision for or insure against, insofar as such risks are not normally insurable on the insurance market and are mentioned in the general exclusions of the policy of insurance, including War Risks and Political Risks, taken out under GCC Clause 34 hereof; or
  - (b) any use or occupation by the Employer or any third party other than a Subcontractor, authorized by the Employer of any part of the Facilities; or
  - (c) any use of or reliance upon any design, data or specification provided or designated by or on behalf of the Employer, or any such matter for which the Contractor has disclaimed responsibility herein,

the Employer shall pay to the Contractor all sums payable in respect of the Facilities executed, notwithstanding that the same be lost, destroyed or damaged, and will pay to the Contractor the replacement value of all temporary facilities and all parts thereof lost, destroyed or damaged. If the Employer requests the Contractor in writing to make good any loss or damage to the Facilities thereby occasioned, the Contractor shall make good the same at the cost of the Employer in accordance with GCC Clause 39. If the Employer does not request the Contractor in

writing to make good any loss or damage to the Facilities thereby occasioned, the Employer shall either request a change in accordance with GCC Clause 39, excluding the performance of that part of the Facilities thereby lost, destroyed or damaged, or, where the loss or damage affects a substantial part of the Facilities, the Employer shall terminate the Contract pursuant to GCC Sub-Clause 42.1 hereof.

32.3 The Contractor shall be liable for any loss of or damage to any Contractor's Equipment, or any other property of the Contractor used or intended to be used for purposes of the Facilities, except (i) as mentioned in GCC Sub-Clause 32.2 with respect to the Contractor's temporary facilities, and (ii) where such loss or damage arises by reason of any of the matters specified in GCC Sub-Clauses 32.2 (b) and (c) and 38.1.

32.4 With respect to any loss or damage caused to the Facilities or any part thereof or to the Contractor's Equipment by reason of any of the matters specified in GCC Sub-Clause 38.1, the provisions of GCC Sub-Clause 38.3 shall apply.

**33. Loss of or  
Damage to  
Property;  
Accident or Injury  
to Workers;  
Indemnification**

33.1 Subject to GCC Sub-Clause 33.3, the Contractor shall indemnify and hold harmless the Employer and its employees and officers from and against any and all suits, actions or administrative proceedings, claims, demands, losses, damages, costs, and expenses of whatsoever nature, including attorney's fees and expenses, in respect of the death or injury of any person or loss of or damage to any property other than the Facilities whether accepted or not, arising in connection with the supply and installation of the Facilities and by reason of the negligence of the Contractor or its Subcontractors, or their employees, officers or agents, except any injury, death or property damage caused by the negligence of the Employer, its contractors, employees, officers or agents.

33.2 If any proceedings are brought or any claim is made against the Employer that might subject the Contractor to liability under GCC Sub-Clause 33.1, the Employer shall promptly give the Contractor a notice thereof and the Contractor may at its own expense and in the Employer's name conduct such proceedings or claim and any negotiations for the settlement of any such proceedings or claim.

If the Contractor fails to notify the Employer within 28 days after receipt of such notice that it intends to conduct any such proceedings or claim, then the Employer shall be free to conduct the same on its own behalf. Unless the Contractor has so failed to notify the Employer within the 28 day period, the Employer shall make no admission that may be prejudicial to the defense of any such proceedings or claim.

The Employer shall, at the Contractor's request, afford all available assistance to the Contractor in conducting such proceedings or claim, and shall be reimbursed by the Contractor for all reasonable expenses incurred in so doing.

33.3 The Employer shall indemnify and hold harmless the Contractor and its employees, officers and Subcontractors from any liability for loss of or damage to property of the Employer, other than the Facilities not yet taken over, that is caused by fire, explosion or any other perils, in excess of the amount recoverable from insurances procured under GCC Clause 34, provided that such fire, explosion or other perils were not caused by any act or failure of the Contractor.

33.4 The party entitled to the benefit of an indemnity under this GCC Clause 33 shall take all reasonable measures to mitigate any loss or damage which has occurred. If the party fails to take such measures, the other party's liabilities shall be correspondingly reduced.

### 34. Insurance

34.1 To the extent specified in the Appendix (Insurance Requirements) to the Contract Agreement, the Contractor shall at its expense take out and maintain in effect, or cause to be taken out and maintained in effect, during the performance of the Contract, the insurances set forth below in the sums and with the deductibles and other conditions specified in the said Appendix. The identity of the insurers and the form of the policies shall be subject to the approval of the Employer, who should not unreasonably withhold such approval.

(a) Cargo Insurance During Transport

Covering loss or damage occurring while in transit from the Contractor's or Subcontractor's works or stores until arrival at the Site, to the Plant (including spare parts therefor) and to the Contractor's Equipment.

(b) Installation All Risks Insurance

Covering physical loss or damage to the Facilities at the Site, occurring prior to Completion of the Facilities, with an extended maintenance coverage for the Contractor's liability in respect of any loss or damage occurring during the Defect Liability Period while the Contractor is on the Site for the purpose of performing its obligations during the Defect Liability Period.

(c) Third Party Liability Insurance

Covering bodily injury or death suffered by third parties including the Employer's personnel, and loss of or damage to property occurring in connection with the supply and installation of the Facilities.

(d) Automobile Liability Insurance

Covering use of all vehicles used by the Contractor or its Subcontractors, whether or not owned by them, in connection with the execution of the Contract.

(e) Workers' Compensation

In accordance with the statutory requirements applicable in any country where the Contract or any part thereof is executed.

(f) Employer's Liability

In accordance with the statutory requirements applicable in any country where the Contract or any part thereof is executed.

(g) Other Insurances

Such other insurances as may be specifically agreed upon by the parties hereto as listed in the Appendix (Insurance Requirements) to the Contract Agreement.

34.2 The Employer shall be named as co-insured under all insurance policies taken out by the Contractor pursuant to GCC Sub-Clause 34.1, except for the Third Party Liability, Workers' Compensation and Employer's Liability Insurances, and the Contractor's Subcontractors shall be named as co-insureds under all insurance policies taken out by the Contractor pursuant to GCC Sub-Clause 34.1 except for the Cargo

Insurance During Transport, Workers' Compensation and Employer's Liability Insurances. All insurer's rights of subrogation against such co-insureds for losses or claims arising out of the performance of the Contract shall be waived under such policies.

- 34.3 The Contractor shall, in accordance with the provisions of the Appendix (Insurance Requirements) to the Contract Agreement, deliver to the Employer certificates of insurance or copies of the insurance policies as evidence that the required policies are in full force and effect. The certificates shall provide that no less than 21 days' notice shall be given to the Employer by insurers prior to cancellation or material modification of a policy.
- 34.4 The Contractor shall ensure that, where applicable, its Subcontractor(s) shall take out and maintain in effect adequate insurance policies for their personnel and vehicles and for work executed by them under the Contract, unless such Subcontractors are covered by the policies taken out by the Contractor.
- 34.5 The Employer shall at its expense take out and maintain in effect during the performance of the Contract those insurances specified in the Appendix (Insurance Requirements) to the Contract Agreement, in the sums and with the deductibles and other conditions specified in the said Appendix. The Contractor and the Contractor's Subcontractors shall be named as co-insureds under all such policies. All insurers' rights of subrogation against such co-insureds for losses or claims arising out of the performance of the Contract shall be waived under such policies. The Employer shall deliver to the Contractor satisfactory evidence that the required insurances are in full force and effect. The policies shall provide that not less than 21 days' notice shall be given to the Contractor by all insurers prior to any cancellation or material modification of the policies. If so requested by the Contractor, the Employer shall provide copies of the policies taken out by the Employer under this GCC Sub-Clause 34.5.
- 34.6 If the Contractor fails to take out and/or maintain in effect the insurances referred to in GCC Sub-Clause 34.1, the Employer may take out and maintain in effect any such insurances and may from time to time deduct from any amount due the Contractor under the Contract any premium that the Employer shall have paid to the insurer, or may otherwise recover such amount as a debt due from the Contractor. If the Employer fails to take out and/or maintain in effect the insurances referred to in GCC 34.5, the Contractor may take out and maintain in effect any such insurances and may from time to time deduct from any amount due the Employer under the Contract any premium that the Contractor shall have paid to the insurer, or may otherwise recover such amount as a debt due from the Employer. If the Contractor fails to or is unable to take out and maintain in effect any such insurances, the Contractor shall nevertheless have no liability or responsibility towards the Employer, and the Contractor shall have full recourse against the Employer for any and all liabilities of the Employer herein.
- 34.7 Unless otherwise provided in the Contract, the Contractor shall prepare and conduct all and any claims made under the policies effected by it pursuant to this GCC Clause 34, and all monies payable by any insurers shall be paid to the Contractor. The Employer shall give to the Contractor all such reasonable assistance as may be required by the Contractor. With respect to insurance claims in which the Employer's interest is involved, the Contractor shall not give any release or make any compromise with the insurer without the prior written consent of the

Employer. With respect to insurance claims in which the Contractor's interest is involved, the Employer shall not give any release or make any compromise with the insurer without the prior written consent of the Contractor.

**35. Unforeseen Conditions**

35.1 If, during the execution of the Contract, the Contractor shall encounter on the Site any physical conditions other than climatic conditions, or artificial obstructions that could not have been reasonably foreseen prior to the date of the Contract Agreement by an experienced contractor on the basis of reasonable examination of the data relating to the Facilities including any data as to boring tests, provided by the Employer, and on the basis of information that it could have obtained from a visual inspection of the Site if access thereto was available, or other data readily available to it relating to the Facilities, and if the Contractor determines that it will in consequence of such conditions or obstructions incur additional cost and expense or require additional time to perform its obligations under the Contract that would not have been required if such physical conditions or artificial obstructions had not been encountered, the Contractor shall promptly, and before performing additional work or using additional Plant or Contractor's Equipment, notify the Project Manager in writing of

- (a) the physical conditions or artificial obstructions on the Site that could not have been reasonably foreseen;
- (b) the additional work and/or Plant and/or Contractor's Equipment required, including the steps which the Contractor will or proposes to take to overcome such conditions or obstructions;
- (c) the extent of the anticipated delay; and
- (d) the additional cost and expense that the Contractor is likely to incur.

On receiving any notice from the Contractor under this GCC Sub-Clause 35.1, the Project Manager shall promptly consult with the Employer and Contractor and decide upon the actions to be taken to overcome the physical conditions or artificial obstructions encountered. Following such consultations, the Project Manager shall instruct the Contractor, with a copy to the Employer, of the actions to be taken.

35.2 Any reasonable additional cost and expense incurred by the Contractor in following the instructions from the Project Manager to overcome such physical conditions or artificial obstructions referred to in GCC Sub-Clause 35.1 shall be paid by the Employer to the Contractor as an addition to the Contract Price.

35.3 If the Contractor is delayed or impeded in the performance of the Contract because of any such physical conditions or artificial obstructions referred to in GCC Sub-Clause 35.1, the Time for Completion shall be extended in accordance with GCC Clause 40.

**36. Change in Laws and Regulations**

36.1 If, after the date 28 days prior to the date of Bid submission, in the country where the Site is located, any law, regulation, ordinance, order or by-law having the force of law is enacted, promulgated, abrogated or changed which shall be deemed to include any change in interpretation or application by the competent authorities, that subsequently affects the costs and expenses of the Contractor and/or the Time for Completion, the Contract Price shall be correspondingly increased or decreased, and/or the Time for Completion shall be reasonably adjusted to the

extent that the Contractor has thereby been affected in the performance of any of its obligations under the Contract. Notwithstanding the foregoing, such additional or reduced costs shall not be separately paid or credited if the same has already been accounted for in the price adjustment provisions where applicable, in accordance with the SCC, pursuant to GCC Sub-Clause 11.2.

### **37. Force Majeure**

- 37.1 "Force Majeure" shall mean any event beyond the reasonable control of the Employer or of the Contractor, as the case may be, and which is unavoidable notwithstanding the reasonable care of the party affected, and shall include, without limitation, the following:
- (a) war, hostilities or warlike operations whether a state of war be declared or not, invasion, act of foreign enemy and civil war
  - (b) rebellion, revolution, insurrection, mutiny, usurpation of civil or military government, conspiracy, riot, civil commotion and terrorist acts
  - (c) confiscation, nationalization, mobilization, commandeering or requisition by or under the order of any government or de jure or de facto authority or ruler or any other act or failure to act of any local state or national government authority
  - (d) strike, sabotage, lockout, embargo, import restriction, port congestion, lack of usual means of public transportation and communication, industrial dispute, shipwreck, shortage or restriction of power supply, epidemics, quarantine and plague
  - (e) earthquake, landslide, volcanic activity, fire, flood or inundation, tidal wave, typhoon or cyclone, hurricane, storm, lightning, or other inclement weather condition, nuclear and pressure waves or other natural or physical disaster
  - (f) shortage of labor, materials or utilities where caused by circumstances that are themselves Force Majeure.
- 37.2 If either party is prevented, hindered or delayed from or in performing any of its obligations under the Contract by an event of Force Majeure, then it shall notify the other in writing of the occurrence of such event and the circumstances thereof within 14 days after the occurrence of such event.
- 37.3 The party who has given such notice shall be excused from the performance or punctual performance of its obligations under the Contract for so long as the relevant event of Force Majeure continues and to the extent that such party's performance is prevented, hindered or delayed. The Time for Completion shall be extended in accordance with GCC Clause 40.
- 37.4 The party or parties affected by the event of Force Majeure shall use reasonable efforts to mitigate the effect thereof upon its or their performance of the Contract and to fulfill its or their obligations under the Contract, but without prejudice to either party's right to terminate the Contract under GCC Sub-Clauses 37.6 and 38.5.
- 37.5 No delay or nonperformance by either party hereto caused by the occurrence of any event of Force Majeure shall
- (a) constitute a default or breach of the Contract, or

- (b) give rise to any claim for damages or additional cost or expense occasioned thereby, subject to GCC Sub-Clauses 32.2, 38.3 and 38.4

if and to the extent that such delay or nonperformance is caused by the occurrence of an event of Force Majeure.

- 37.6 If the performance of the Contract is substantially prevented, hindered or delayed for a single period of more than 60 days or an aggregate period of more than 120 days on account of one or more events of Force Majeure during the currency of the Contract, the parties will attempt to develop a mutually satisfactory solution, failing which either party may terminate the Contract by giving a notice to the other, but without prejudice to either party's right to terminate the Contract under GCC Sub-Clause 38.5.
- 37.7 In the event of termination pursuant to GCC Sub-Clause 37.6, the rights and obligations of the Employer and the Contractor shall be as specified in GCC Sub-Clauses 42.1.2 and 42.1.3.
- 37.8 Notwithstanding GCC Sub-Clause 37.5, Force Majeure shall not apply to any obligation of the Employer to make payments to the Contractor herein.

### **38. War Risks**

- 38.1 "War Risks" shall mean any event specified in paragraphs (a) and (b) of GCC Sub-Clause 37.1 and any explosion or impact of any mine, bomb, shell, grenade or other projectile, missile, munitions or explosive of war, occurring or existing in or near the country (or countries) where the Site is located.
- 38.2 Notwithstanding anything contained in the Contract, the Contractor shall have no liability whatsoever for or with respect to
  - (a) destruction of or damage to Facilities, Plant, or any part thereof;
  - (b) destruction of or damage to property of the Employer or any third party; or
  - (c) injury or loss of life

if such destruction, damage, injury or loss of life is caused by any War Risks, and the Employer shall indemnify and hold the Contractor harmless from and against any and all claims, liabilities, actions, lawsuits, damages, costs, charges or expenses arising in consequence of or in connection with the same.
- 38.3 If the Facilities or any Plant or Contractor's Equipment or any other property of the Contractor used or intended to be used for the purposes of the Facilities shall sustain destruction or damage by reason of any War Risks, the Employer shall pay the Contractor for
  - (a) any part of the Facilities or the Plant so destroyed or damaged to the extent not already paid for by the Employer and so far as may be required by the Employer, and as may be necessary for completion of the Facilities
  - (b) replacing or making good any Contractor's Equipment or other property of the Contractor so destroyed or damaged
  - (c) replacing or making good any such destruction or damage to the Facilities or the Plant or any part thereof .

If the Employer does not require the Contractor to replace or make good any such destruction or damage to the Facilities, the Employer shall either request a change in accordance with GCC Clause 39, excluding the performance of that part of the Facilities thereby destroyed or damaged or, where the loss, destruction or damage affects a substantial part of the Facilities, shall terminate the Contract, pursuant to GCC Sub-Clause 42.1.

If the Employer requires the Contractor to replace or make good on any such destruction or damage to the Facilities, the Time for Completion shall be extended in accordance with GCC 40.

- 38.4 Notwithstanding anything contained in the Contract, the Employer shall pay the Contractor for any increased costs or incidentals to the execution of the Contract that are in any way attributable to, consequent on, resulting from, or in any way connected with any War Risks, provided that the Contractor shall as soon as practicable notify the Employer in writing of any such increased cost.
- 38.5 If during the performance of the Contract any War Risks shall occur that financially or otherwise materially affect the execution of the Contract by the Contractor, the Contractor shall use its reasonable efforts to execute the Contract with due and proper consideration given to the safety of its and its Subcontractors' personnel engaged in the work on the Facilities, provided, however, that if the execution of the work on the Facilities becomes impossible or is substantially prevented for a single period of more than 60 days or an aggregate period of more than 120 days on account of any War Risks, the parties will attempt to develop a mutually satisfactory solution, failing which either party may terminate the Contract by giving a notice to the other.
- 38.6 In the event of termination pursuant to GCC Sub-Clauses 38.3 or 38.5, the rights and obligations of the Employer and the Contractor shall be specified in GCC Sub-Clauses 42.1.2 and 42.1.3.

## H. Change in Contract Elements

### 39. Change in the Facilities

#### 39.1 Introducing a Change

39.1.1 Subject to GCC Sub-Clauses 39.2.5 and 39.2.7, the Employer shall have the right to propose, and subsequently require, that the Project Manager order the Contractor from time to time during the performance of the Contract to make any change, modification, addition or deletion to, in or from the Facilities hereinafter called "Change", provided that such Change falls within the general scope of the Facilities and does not constitute unrelated work and that it is technically practicable, taking into account both the state of advancement of the Facilities and the technical compatibility of the Change envisaged with the nature of the Facilities as specified in the Contract.

39.1.2 The Contractor may from time to time during its performance of the Contract propose to the Employer with a copy to the Project Manager, any Change that the Contractor considers necessary or desirable to improve the quality, efficiency or safety of the Facilities. The Employer may at its discretion approve or reject any Change proposed by the Contractor, provided that the



Employer shall approve any Change proposed by the Contractor to ensure the safety of the Facilities.

39.1.3 Notwithstanding GCC Sub-Clauses 39.1.1 and 39.1.2, no change made necessary because of any default of the Contractor in the performance of its obligations under the Contract shall be deemed to be a Change, and such change shall not result in any adjustment of the Contract Price or the Time for Completion.

39.1.4 The procedure on how to proceed with and execute Changes is specified in GCC Sub-Clauses 39.2 and 39.3, and further details and forms are provided in the Employer's Requirements (Forms and Procedures).

## 39.2 Changes Originating from Employer

39.2.1 If the Employer proposes a Change pursuant to GCC Sub-Clause 39.1.1, it shall send to the Contractor a "Request for Change Proposal," requiring the Contractor to prepare and furnish to the Project Manager as soon as reasonably practicable a "Change Proposal," which shall include the following:

- (a) brief description of the Change
- (b) effect on the Time for Completion
- (c) estimated cost of the Change
- (d) effect on Functional Guarantees (if any)
- (e) effect on the Facilities
- (f) effect on any other provisions of the Contract.

39.2.2 Prior to preparing and submitting the "Change Proposal," the Contractor shall submit to the Project Manager an "Estimate for Change Proposal," which shall be an estimate of the cost of preparing and submitting the Change Proposal.

Upon receipt of the Contractor's Estimate for Change Proposal, the Employer shall do one of the following:

- (a) accept the Contractor's estimate with instructions to the Contractor to proceed with the preparation of the Change Proposal
- (b) advise the Contractor of any part of its Estimate for Change Proposal that is unacceptable and request the Contractor to review its estimate
- (c) advise the Contractor that the Employer does not intend to proceed with the Change.

39.2.3 Upon receipt of the Employer's instruction to proceed under GCC Sub-Clause 39.2.2 (a), the Contractor shall, with proper expedition, proceed with the preparation of the Change Proposal, in accordance with GCC Sub-Clause 39.2.1.

39.2.4 The pricing of any Change shall, as far as practicable, be calculated in accordance with the rates and prices included in the Contract. If such rates and prices are inequitable, the parties

thereto shall agree on specific rates for the valuation of the Change.

- 39.2.5 If before or during the preparation of the Change Proposal it becomes apparent that the aggregate effect of compliance therewith and with all other Change Orders that have already become binding upon the Contractor under this GCC Clause 39 would be to increase or decrease the Contract Price as originally set forth in Article 2 (Contract Price) of the Contract Agreement by more than 15%, the Contractor may give a written notice of objection thereto prior to furnishing the Change Proposal as aforesaid. If the Employer accepts the Contractor's objection, the Employer shall withdraw the proposed Change and shall notify the Contractor in writing thereof.

The Contractor's failure to so object shall neither affect its right to object to any subsequent requested Changes or Change Orders herein, nor affect its right to take into account, when making such subsequent objection, the percentage increase or decrease in the Contract Price that any Change not objected to by the Contractor represents.

- 39.2.6 Upon receipt of the Change Proposal, the Employer and the Contractor shall mutually agree upon all matters therein contained. Within 14 days after such agreement, the Employer shall, if it intends to proceed with the Change, issue the Contractor with a Change Order.

If the Employer is unable to reach a decision within 14 days, it shall notify the Contractor with details of when the Contractor can expect a decision.

If the Employer decides not to proceed with the Change for whatever reason, it shall, within the said period of 14 days, notify the Contractor accordingly. Under such circumstances, the Contractor shall be entitled to reimbursement of all costs reasonably incurred by it in the preparation of the Change Proposal, provided that these do not exceed the amount given by the Contractor in its Estimate for Change Proposal submitted in accordance with GCC Sub-Clause 39.2.2.

- 39.2.7 If the Employer and the Contractor cannot reach agreement on the price for the Change, an equitable adjustment to the Time for Completion, or any other matters identified in the Change Proposal, the Employer may nevertheless instruct the Contractor to proceed with the Change by issue of a "Pending Agreement Change Order."

Upon receipt of a Pending Agreement Change Order, the Contractor shall immediately proceed with effecting the Changes covered by such Order. The parties shall thereafter attempt to reach agreement on the outstanding issues under the Change Proposal.

If the parties cannot reach agreement within 60 days from the date of issue of the Pending Agreement Change Order, then the matter may be referred to the Dispute Board in accordance with the provisions of GCC Sub-Clause 45.3.

### 39.3 Changes Originating from Contractor

39.3.1 If the Contractor proposes a Change pursuant to GCC Sub-Clause 39.1.2, the Contractor shall submit to the Project Manager a written "Application for Change Proposal," giving reasons for the proposed Change and including the information specified in GCC Sub-Clause 39.2.1.

Upon receipt of the Application for Change Proposal, the parties shall follow the procedures outlined in GCC Sub-Clauses 39.2.6 and 39.2.7. However, should the Employer choose not to proceed, the Contractor shall not be entitled to recover the costs of preparing the Application for Change Proposal.

### 40. Extension of Time for Completion

40.1 The Time(s) for Completion specified in the SCC shall be extended if the Contractor is delayed or impeded in the performance of any of its obligations under the Contract by reason of any of the following:

- (a) any Change in the Facilities as provided in GCC Clause 39
- (b) any occurrence of Force Majeure as provided in GCC Clause 37, unforeseen conditions as provided in GCC Clause 35, or other occurrence of any of the matters specified or referred to in paragraphs (a), (b) and (c) of GCC Sub-Clause 32.2
- (c) any suspension order given by the Employer under GCC Clause 41 hereof or reduction in the rate of progress pursuant to GCC Sub-Clause 41.2 or
- (d) any changes in laws and regulations as provided in GCC Clause 36 or
- (e) any default or breach of the Contract by the Employer, or any activity, act or omission of the Employer, or the Project Manager, or any other contractors employed by the Employer or
- (f) any other matter specifically mentioned in the Contract
- (g) any delay on the part of a sub-contractor, provided such delay is due to a cause for which the Contractor himself would have been entitled to an extension of time under this sub-clause

by such period as shall be fair and reasonable in all the circumstances and as shall fairly reflect the delay or impediment sustained by the Contractor.

40.2 Except where otherwise specifically provided in the Contract, the Contractor shall submit to the Project Manager a notice of a claim for an extension of the Time for Completion, together with particulars of the event or circumstance justifying such extension as soon as reasonably practicable after the commencement of such event or circumstance. As soon as reasonably practicable after receipt of such notice and supporting particulars of the claim, the Employer and the Contractor shall agree upon the period of such extension. In the event that the Contractor does not accept the Employer's estimate of a fair and reasonable time extension, the Contractor shall be entitled to refer the matter to a Dispute Board, pursuant to GCC Sub-Clause 45.3.

40.3 The Contractor shall at all times use its reasonable efforts to minimize any delay in the performance of its obligations under the Contract.

In all cases where the Contractor has given a notice of a claim for an extension of time under GCC 40.2, the Contractor shall consult with the Project Manager in order to determine the steps (if any) which can be taken to overcome or minimize the actual or anticipated delay. The Contractor shall thereafter comply with all reasonable instructions which the Project Manager shall give in order to minimize such delay. If compliance with such instructions shall cause the Contractor to incur extra costs and the Contractor is entitled to an extension of time under GCC 40.1, the amount of such extra costs shall be added to the Contract Price.

#### **41. Suspension**

41.1 The Employer may request the Project Manager, by notice to the Contractor, to order the Contractor to suspend performance of any or all of its obligations under the Contract. Such notice shall specify the obligation of which performance is to be suspended, the effective date of the suspension and the reasons therefor. The Contractor shall thereupon suspend performance of such obligation, except those obligations necessary for the care or preservation of the Facilities, until ordered in writing to resume such performance by the Project Manager.

If, by virtue of a suspension order given by the Project Manager, other than by reason of the Contractor's default or breach of the Contract, the Contractor's performance of any of its obligations is suspended for an aggregate period of more than 90 days, then at any time thereafter and provided that at that time such performance is still suspended, the Contractor may give a notice to the Project Manager requiring that the Employer shall, within 28 days of receipt of the notice, order the resumption of such performance or request and subsequently order a change in accordance with GCC Clause 39, excluding the performance of the suspended obligations from the Contract.

If the Employer fails to do so within such period, the Contractor may, by a further notice to the Project Manager, elect to treat the suspension, where it affects a part only of the Facilities, as a deletion of such part in accordance with GCC Clause 39 or, where it affects the whole of the Facilities, as termination of the Contract under GCC Sub-Clause 42.1.

41.2 If

- (a) the Employer has failed to pay the Contractor any sum due under the Contract within the specified period, has failed to approve any invoice or supporting documents without just cause pursuant to the Appendix (Terms and Procedures of Payment) to the Contract Agreement, or commits a substantial breach of the Contract, the Contractor may give a notice to the Employer that requires payment of such sum, with interest thereon as stipulated in GCC Sub-Clause 12.3, requires approval of such invoice or supporting documents, or specifies the breach and requires the Employer to remedy the same, as the case may be. If the Employer fails to pay such sum together with such interest, fails to approve such invoice or supporting documents or give its reasons for withholding such approval, or fails to remedy the breach or take steps to remedy the breach within 14 days after receipt of the Contractor's notice or
- (b) the Contractor is unable to carry out any of its obligations under the Contract for any reason attributable to the Employer, including but not limited to the Employer's failure to provide possession of or access to the Site or other areas in accordance with GCC Sub-

Clause 10.2, or failure to obtain any governmental permit necessary for the execution and/or completion of the Facilities,

then the Contractor may by 14 days' notice to the Employer suspend performance of all or any of its obligations under the Contract, or reduce the rate of progress.

- 41.3 If the Contractor's performance of its obligations is suspended or the rate of progress is reduced pursuant to this GCC Clause 41, then the Time for Completion shall be extended in accordance with GCC Sub-Clause 40.1, and any and all additional costs or expenses incurred by the Contractor as a result of such suspension or reduction shall be paid by the Employer to the Contractor in addition to the Contract Price, except in the case of suspension order or reduction in the rate of progress by reason of the Contractor's default or breach of the Contract.
- 41.4 During the period of suspension, the Contractor shall not remove from the Site any Plant, any part of the Facilities or any Contractor's Equipment, without the prior written consent of the Employer.

## 42. Termination

### 42.1 Termination for Employer's Convenience

42.1.1 The Employer may at any time terminate the Contract for any reason by giving the Contractor a notice of termination that refers to this GCC Sub-Clause 42.1.

42.1.2 Upon receipt of the notice of termination under GCC Sub-Clause 42.1.1, the Contractor shall either immediately or upon the date specified in the notice of termination

- (a) cease all further work, except for such work as the Employer may specify in the notice of termination for the sole purpose of protecting that part of the Facilities already executed, or any work required to leave the Site in a clean and safe condition
- (b) terminate all subcontracts, except those to be assigned to the Employer pursuant to paragraph (d) (ii) below
- (c) remove all Contractor's Equipment from the Site, repatriate the Contractor's and its Subcontractors' personnel from the Site, remove from the Site any wreckage, rubbish and debris of any kind, and leave the whole of the Site in a clean and safe condition, and
- (d) subject to the payment specified in GCC Sub-Clause 42.1.3,
  - (i) deliver to the Employer the parts of the Facilities executed by the Contractor up to the date of termination
  - (ii) to the extent legally possible, assign to the Employer all right, title and benefit of the Contractor to the Facilities and to the Plant as of the date of termination, and, as may be required by the Employer, in any subcontracts concluded between the Contractor and its Subcontractors; and
  - (iii) deliver to the Employer all non-proprietary drawings, specifications and other documents prepared by the Contractor or its Subcontractors as at the date of termination in connection with the Facilities.

42.1.3 In the event of termination of the Contract under GCC Sub-Clause 42.1.1, the Employer shall pay to the Contractor the following amounts:

- (a) the Contract Price, properly attributable to the parts of the Facilities executed by the Contractor as of the date of termination
- (b) the costs reasonably incurred by the Contractor in the removal of the Contractor's Equipment from the Site and in the repatriation of the Contractor's and its Subcontractors' personnel
- (c) any amounts to be paid by the Contractor to its Subcontractors in connection with the termination of any subcontracts, including any cancellation charges
- (d) costs incurred by the Contractor in protecting the Facilities and leaving the Site in a clean and safe condition pursuant to paragraph (a) of GCC Sub-Clause 42.1.2
- (e) the cost of satisfying all other obligations, commitments and claims that the Contractor may in good faith have undertaken with third parties in connection with the Contract and that are not covered by paragraphs (a) through (d) above.

#### 42.2 Termination for Contractor's Default

42.2.1 The Employer, without prejudice to any other rights or remedies it may possess, may terminate the Contract forthwith in the following circumstances by giving a notice of termination and its reasons therefor to the Contractor, referring to this GCC Sub-Clause 42.2:

- (a) if the Contractor becomes bankrupt or insolvent, has a receiving order issued against it, compounds with its creditors, or, if the Contractor is a corporation, a resolution is passed or order is made for its winding up, other than a voluntary liquidation for the purposes of amalgamation or reconstruction, a receiver is appointed over any part of its undertaking or assets, or if the Contractor takes or suffers any other analogous action in consequence of debt
- (b) if the Contractor assigns or transfers the Contract or any right or interest therein in violation of the provision of GCC Clause 43.
- (c) if the Contractor, in the judgment of the Employer has engaged in fraud and corruption, as defined in GCC Clause 6, in competing for or in executing the Contract.

#### 42.2.2 If the Contractor

- (a) has abandoned or repudiated the Contract
- (b) has without valid reason failed to commence work on the Facilities promptly or has suspended, other than pursuant to GCC Sub-Clause 41.2, the progress of Contract performance for more than 28 days after receiving a written instruction from the Employer to proceed

- (c) persistently fails to execute the Contract in accordance with the Contract or persistently neglects to carry out its obligations under the Contract without just cause
- (d) refuses or is unable to provide sufficient materials, services or labor to execute and complete the Facilities in the manner specified in the program furnished under GCC Sub-Clause 18.2 at rates of progress that give reasonable assurance to the Employer that the Contractor can attain Completion of the Facilities by the Time for Completion as extended,

then the Employer may, without prejudice to any other rights it may possess under the Contract, give a notice to the Contractor stating the nature of the default and requiring the Contractor to remedy the same. If the Contractor fails to remedy or to take steps to remedy the same within 14 days of its receipt of such notice, then the Employer may terminate the Contract forthwith by giving a notice of termination to the Contractor that refers to this GCC Sub-Clause 42.2.

42.2.3 Upon receipt of the notice of termination under GCC Sub-Clauses 42.2.1 or 42.2.2, the Contractor shall, either immediately or upon such date as is specified in the notice of termination,

- (a) cease all further work, except for such work as the Employer may specify in the notice of termination for the sole purpose of protecting that part of the Facilities already executed, or any work required to leave the Site in a clean and safe condition
- (b) terminate all subcontracts, except those to be assigned to the Employer pursuant to paragraph (d) below
- (c) deliver to the Employer the parts of the Facilities executed by the Contractor up to the date of termination
- (d) to the extent legally possible, assign to the Employer all right, title and benefit of the Contractor to the Facilities and to the Plant as of the date of termination, and, as may be required by the Employer, in any subcontracts concluded between the Contractor and its Subcontractors
- (e) deliver to the Employer all drawings, specifications and other documents prepared by the Contractor or its Subcontractors as of the date of termination in connection with the Facilities.

42.2.4 The Employer may enter upon the Site, expel the Contractor, and complete the Facilities itself or by employing any third party. The Employer may, to the exclusion of any right of the Contractor over the same, take over and use with the payment of a fair rental rate to the Contractor, with all the maintenance costs to the account of the Employer and with an indemnification by the Employer for all liability including damage or injury to persons arising out of the Employer's use of such equipment, any Contractor's Equipment owned by the Contractor and on the Site in connection with the Facilities for such reasonable period as the Employer considers expedient for the supply and installation of the Facilities.

Upon completion of the Facilities or at such earlier date as the Employer thinks appropriate, the Employer shall give notice to the Contractor that such Contractor's Equipment will be returned to

the Contractor at or near the Site and shall return such Contractor's Equipment to the Contractor in accordance with such notice. The Contractor shall thereafter without delay and at its cost remove or arrange removal of the same from the Site.

42.2.5 Subject to GCC Sub-Clause 42.2.6, the Contractor shall be entitled to be paid the Contract Price attributable to the Facilities executed as of the date of termination, the value of any unused or partially used Plant on the Site, and the costs, if any, incurred in protecting the Facilities and in leaving the Site in a clean and safe condition pursuant to paragraph (a) of GCC Sub-Clause 42.2.3. Any sums due the Employer from the Contractor accruing prior to the date of termination shall be deducted from the amount to be paid to the Contractor under this Contract.

42.2.6 If the Employer completes the Facilities, the cost of completing the Facilities by the Employer shall be determined.

If the sum that the Contractor is entitled to be paid, pursuant to GCC Sub-Clause 42.2.5, plus the reasonable costs incurred by the Employer in completing the Facilities, exceeds the Contract Price, the Contractor shall be liable for such excess.

If such excess is greater than the sums due the Contractor under GCC Sub-Clause 42.2.5, the Contractor shall pay the balance to the Employer, and if such excess is less than the sums due the Contractor under GCC Sub-Clause 42.2.5, the Employer shall pay the balance to the Contractor.

The Employer and the Contractor shall agree, in writing, on the computation described above and the manner in which any sums shall be paid.

### 42.3 Termination by Contractor

#### 42.3.1 If

- (a) the Employer has failed to pay the Contractor any sum due under the Contract within the specified period, has failed to approve any invoice or supporting documents without just cause pursuant to the Appendix (Terms and Procedures of Payment) to the Contract Agreement, or commits a substantial breach of the Contract, the Contractor may give a notice to the Employer that requires payment of such sum, with interest thereon as stipulated in GCC Sub-Clause 12.3, requires approval of such invoice or supporting documents, or specifies the breach and requires the Employer to remedy the same, as the case may be. If the Employer fails to pay such sum together with such interest, fails to approve such invoice or supporting documents or give its reasons for withholding such approval, fails to remedy the breach or take steps to remedy the breach within 14 days after receipt of the Contractor's notice, or
- (b) the Contractor is unable to carry out any of its obligations under the Contract for any reason attributable to the Employer, including but not limited to the Employer's failure to provide possession of or access to the Site or other areas



or failure to obtain any governmental permit necessary for the execution and/or completion of the Facilities,

then the Contractor may give a notice to the Employer thereof, and if the Employer has failed to pay the outstanding sum, to approve the invoice or supporting documents, to give its reasons for withholding such approval, or to remedy the breach within 28 days of such notice, or if the Contractor is still unable to carry out any of its obligations under the Contract for any reason attributable to the Employer within 28 days of the said notice, the Contractor may by a further notice to the Employer referring to this GCC Sub-Clause 42.3.1, forthwith terminate the Contract.

- 42.3.2 The Contractor may terminate the Contract forthwith by giving a notice to the Employer to that effect, referring to this GCC Sub-Clause 42.3.2, if the Employer becomes bankrupt or insolvent, has a receiving order issued against it, compounds with its creditors, or, being a corporation, if a resolution is passed or order is made for its winding up (other than a voluntary liquidation for the purposes of amalgamation or reconstruction), a receiver is appointed over any part of its undertaking or assets, or if the Employer takes or suffers any other analogous action in consequence of debt.
- 42.3.3 If the Contract is terminated under GCC Sub-Clauses 42.3.1 or 42.3.2, then the Contractor shall immediately
- (a) cease all further work, except for such work as may be necessary for the purpose of protecting that part of the Facilities already executed, or any work required to leave the Site in a clean and safe condition
  - (b) terminate all subcontracts, except those to be assigned to the Employer pursuant to paragraph (d) (ii)
  - (c) remove all Contractor's Equipment from the Site and repatriate the Contractor's and its Subcontractors' personnel from the Site, and
  - (d) subject to the payment specified in GCC Sub-Clause 42.3.4,
    - (i) deliver to the Employer the parts of the Facilities executed by the Contractor up to the date of termination
    - (ii) to the extent legally possible, assign to the Employer all right, title and benefit of the Contractor to the Facilities and to the Plant as of the date of termination, and, as may be required by the Employer, in any subcontracts concluded between the Contractor and its Subcontractors, and
    - (iii) deliver to the Employer all drawings, specifications and other documents prepared by the Contractor or its Subcontractors as of the date of termination in connection with the Facilities.
- 42.3.4 If the Contract is terminated under GCC Sub-Clauses 42.3.1 or 42.3.2, the Employer shall pay to the Contractor all payments specified in GCC Sub-Clause 42.1.3, and reasonable compensation for all loss, except for loss of profit, or damage sustained by the Contractor arising out of, in connection with or in consequence of such termination.

42.3.5 Termination by the Contractor pursuant to this GCC Sub-Clause 42.3 is without prejudice to any other rights or remedies of the Contractor that may be exercised in lieu of or in addition to rights conferred by GCC Sub-Clause 42.3.

42.4 In this GCC Clause 42, the expression "Facilities executed" shall include all work executed, Installation Services provided, and all Plant acquired, or subject to a legally binding obligation to purchase, by the Contractor and used or intended to be used for the purpose of the Facilities, up to and including the date of termination.

42.5 In this GCC Clause 42, in calculating any monies due from the Employer to the Contractor, account shall be taken of any sum previously paid by the Employer to the Contractor under the Contract, including any advance payment paid pursuant to the Appendix (Terms and Procedures of Payment) to the Contract Agreement.

#### **43. Assignment**

43.1 Neither the Employer nor the Contractor shall, without the express prior written consent of the other party which consent shall not be unreasonably withheld, assign to any third party the Contract or any part thereof, or any right, benefit, obligation or interest therein or thereunder, except that the Contractor shall be entitled to assign either absolutely or by way of charge any monies due and payable to it or that may become due and payable to it under the Contract.

### **I. Claims, Disputes and Arbitration**

#### **44. Contractor's Claims**

44.1 If the Contractor considers himself to be entitled to any extension of the Time for Completion and/or any additional payment, under any Clause of these Conditions or otherwise in connection with the Contract, the Contractor shall submit a notice to the Project Manager, describing the event or circumstance giving rise to the claim. The notice shall be given as soon as practicable, and not later than 28 days after the Contractor became aware, or should have become aware, of the event or circumstance.

If the Contractor fails to give notice of a claim within such period of 28 days, the Time for Completion shall not be extended, the Contractor shall not be entitled to additional payment, and the Employer shall be discharged from all liability in connection with the claim. Otherwise, the following provisions of this Sub-Clause shall apply.

The Contractor shall also submit any other notices which are required by the Contract, and supporting particulars for the claim, all as relevant to such event or circumstance.

The Contractor shall keep such contemporary records as may be necessary to substantiate any claim, either on the Site or at another location acceptable to the Project Manager. Without admitting the Employer's liability, the Project Manager may, after receiving any notice under this Sub-Clause, monitor the record-keeping and/or instruct the Contractor to keep further contemporary records. The Contractor shall permit the Project Manager to inspect all these records, and shall (if instructed) submit copies to the Project Manager.

Within 42 days after the Contractor became aware (or should have become aware) of the event or circumstance giving rise to the claim, or within such other period as may be proposed by the Contractor and approved by the Project Manager, the Contractor shall send to the

Project Manager a fully detailed claim which includes full supporting particulars of the basis of the claim and of the extension of time and/or additional payment claimed. If the event or circumstance giving rise to the claim has a continuing effect:

- (a) this fully detailed claim shall be considered as interim;
- (b) the Contractor shall send further interim claims at monthly intervals, giving the accumulated delay and/or amount claimed, and such further particulars as the Project Manager may reasonably require; and
- (c) the Contractor shall send a final claim within 28 days after the end of the effects resulting from the event or circumstance, or within such other period as may be proposed by the Contractor and approved by the Project Manager.

Within 42 days after receiving a claim or any further particulars supporting a previous claim, or within such other period as may be proposed by the Project Manager and approved by the Contractor, the Project Manager shall respond with approval, or with disapproval and detailed comments. He may also request any necessary further particulars, but shall nevertheless give his response on the principles of the claim within such time.

Each Payment Certificate shall include such amounts for any claim as have been reasonably substantiated as due under the relevant provision of the Contract. Unless and until the particulars supplied are sufficient to substantiate the whole of the claim, the Contractor shall only be entitled to payment for such part of the claim as he has been able to substantiate.

The Project Manager shall agree with the Contractor or estimate: (i) the extension (if any) of the Time for Completion (before or after its expiry) in accordance with GCC Clause 40, and/or (ii) the additional payment (if any) to which the Contractor is entitled under the Contract.

The requirements of this Sub-Clause are in addition to those of any other Sub-Clause which may apply to a claim. If the Contractor fails to comply with this or another Sub-Clause in relation to any claim, any extension of time and/or additional payment shall take account of the extent (if any) to which the failure has prevented or prejudiced proper investigation of the claim, unless the claim is excluded under the second paragraph of this Sub-Clause.

In the event that the Contractor and the Employer cannot agree on any matter relating to a claim, either party may refer the matter to the Dispute Board pursuant to GCC 45 hereof.

## **45. Disputes and Arbitration**

### **45.1 Appointment of the Dispute Board**

Disputes shall be referred to a DB for decision in accordance with GCC Sub-Clause 45.3. The Parties shall appoint a DB by the date stated in the SCC.

The DB shall comprise, as stated in the SCC, either one or three suitably qualified persons (“the members”), each of whom shall be fluent in the language for communication defined in the Contract and shall be a professional experienced in the type of activities involved in the performance of the Contract and with the interpretation of contractual documents. If the number is not so stated and the Parties do not agree otherwise, the DB shall comprise three persons, one of whom shall serve as chairman.

If the Parties have not jointly appointed the DB 21 days before the date stated in the SCC and the DB is to comprise three persons, each Party shall nominate one member for the approval of the other Party. The first two members shall recommend and the Parties shall agree upon the third member, who shall act as chairman.

However, if a list of potential members is included in the SCC, the members shall be selected from those on the list, other than anyone who is unable or unwilling to accept appointment to the DB.

The agreement between the Parties and either the sole member or each of the three members shall incorporate by reference the General Conditions of Dispute Board Agreement contained in the Appendix to these General Conditions, with such amendments as are agreed between them.

The terms of the remuneration of either the sole member or each of the three members, including the remuneration of any expert whom the DB consults, shall be mutually agreed upon by the Parties when agreeing the terms of appointment of the member or such expert (as the case may be). Each Party shall be responsible for paying one-half of this remuneration.

If a member declines to act or is unable to act as a result of death, disability, resignation or termination of appointment, a replacement shall be appointed in the same manner as the replaced person was required to have been nominated or agreed upon, as described in this Sub-Clause.

The appointment of any member may be terminated by mutual agreement of both Parties, but not by the Employer or the Contractor acting alone. Unless otherwise agreed by both Parties, the appointment of the DB (including each member) shall expire when the Operational Acceptance Certificate has been issued in accordance with GCC Clause 25.3.

#### 45.2 Failure to Agree Dispute Board

If any of the following conditions apply, namely:

- (a) the Parties fail to agree upon the appointment of the sole member of the DB by the date stated in the first paragraph of GCC Sub-Clause 45.1,

- (b) either Party fails to nominate a member (for approval by the other Party) of a DB of three persons by such date,
- (c) the Parties fail to agree upon the appointment of the third member (to act as chairman) of the DB by such date, or
- (d) the Parties fail to agree upon the appointment of a replacement person within 42 days after the date on which the sole member or one of the three members declines to act or is unable to act as a result of death, disability, resignation or termination of appointment,

then the appointing entity or official named in the SCC shall, upon the request of either or both of the Parties and after due consultation with both Parties, appoint this member of the DB. This appointment shall be final and conclusive. Each Party shall be responsible for paying one-half of the remuneration of the appointing entity or official.

#### **45.3 Obtaining Dispute Board's Decision**

If a dispute (of any kind whatsoever) arises between the Parties in connection with the performance of the Contract, including any dispute as to any certificate, determination, instruction, opinion or valuation of the Project Manager, either Party may refer the dispute in writing to the DB for its decision, with copies to the other Party and the Project Manager. Such reference shall state that it is given under this Sub-Clause.

For a DB of three persons, the DB shall be deemed to have received such reference on the date when it is received by the chairman of the DB.

Both Parties shall promptly make available to the DB all such additional information, further access to the Site, and appropriate facilities, as the DB may require for the purposes of making a decision on such dispute. The DB shall be deemed to be not acting as arbitrator(s).

Within 84 days after receiving such reference, or within such other period as may be proposed by the DB and approved by both Parties, the DB shall give its decision, which shall be reasoned and shall state that it is given under this Sub-Clause. The decision shall be binding on both Parties, who shall promptly give effect to it unless and until it shall be revised in an amicable settlement or an arbitral award as described below. Unless the Contract has already been abandoned, repudiated or terminated, the Contractor shall continue to proceed with the performance of the Facilities in accordance with the Contract.

If either Party is dissatisfied with the DB's decision, then either Party may, within 28 days after receiving the decision, give notice to the other Party of its dissatisfaction and intention to commence arbitration. If the DB fails to give its decision within the period of 84 days (or as otherwise approved) after receiving such reference, then either Party may, within 28 days after this period has expired, give notice to the other Party of its dissatisfaction and intention to commence arbitration.

In either event, this notice of dissatisfaction shall state that it is given under this Sub-Clause, and shall set out the matter in dispute and the reason(s) for dissatisfaction. Except as stated in GCC Sub-Clauses 45.6 and 45.7, neither Party shall be entitled to commence arbitration of a

dispute unless a notice of dissatisfaction has been given in accordance with this Sub-Clause.

If the DB has given its decision as to a matter in dispute to both Parties, and no notice of dissatisfaction has been given by either Party within 28 days after it received the DB's decision, then the decision shall become final and binding upon both Parties.

#### **45.4 Amicable Settlement**

Where notice of dissatisfaction has been given under GCC Sub-Clause 45.3 above, both Parties shall attempt to settle the dispute amicably before the commencement of arbitration. However, unless both Parties agree otherwise, arbitration may be commenced on or after the fifty-sixth day after the day on which notice of dissatisfaction and intention to commence arbitration was given, even if no attempt at amicable settlement has been made.

#### **45.5 Arbitration**

Unless settled amicably, any dispute in respect of which the DB's decision (if any) has not become final and binding shall be finally settled by international arbitration. Unless otherwise agreed by both Parties:

- (a) arbitration proceedings shall be conducted as stated in the Special Conditions,
- (b) if no arbitration proceedings is so stated, the dispute shall be finally settled by institutional arbitration under the Rules of Arbitration of the International Chamber of Commerce,
- (c) the dispute shall be settled by three arbitrators, and
- (d) the arbitration shall be conducted in the language for communications defined in GCC Sub-Clause 5.3.

The arbitrator(s) shall have full power to open up, review and revise any certificate, determination, instruction, opinion or valuation of the Project Manager, and any decision of the DB, relevant to the dispute. Nothing shall disqualify the Project Manager from being called as a witness and giving evidence before the arbitrator(s) on any matter whatsoever relevant to the dispute.

Neither Party shall be limited in the proceedings before the arbitrator(s) to the evidence or arguments previously put before the DB to obtain its decision, or to the reasons for dissatisfaction given in its notice of dissatisfaction. Any decision of the DB shall be admissible in evidence in the arbitration.

Arbitration may be commenced prior to or after completion of the Works. The obligations of the Parties, the Project Manager and the DB shall not be altered by reason of any arbitration being conducted during the progress of the Works.

#### **45.6 Failure to Comply with Dispute Board's Decision**

In the event that a Party fails to comply with a DB decision which has become final and binding, then the other Party may, without prejudice to any other rights it may have, refer the failure itself to arbitration under

GCC Sub-Clause 45.5. GCC Sub-Clauses 45.3 and 45.4 shall not apply to this reference.

**45.7 Expiry of Dispute Board's Appointment**

If a dispute arises between the Parties in connection with the performance of the Contract, and there is no DB in place, whether by reason of the expiry of the DB's appointment or otherwise:

- (a) GCC Sub-Clauses 45.3 and 45.4 shall not apply, and
- (b) the dispute may be referred directly to arbitration under GCC Sub-Clause 45.5

## APPENDIX A

### General Conditions of Dispute Board Agreement

#### 1 Definitions

Each "Dispute Board Agreement" is a tripartite agreement by and between:

- (a) the "Employer";
- (b) the "Contractor"; and
- (c) the "Member" who is defined in the Dispute Board Agreement as being:
  - (i) the sole member of the "DB" and, where this is the case, all references to the "Other Members" do not apply, or
  - (ii) one of the three persons who are jointly called the "DB" (or "dispute board") and, where this is the case, the other two persons are called the "Other Members".

The Employer and the Contractor have entered (or intend to enter) into a contract, which is called the "Contract" and is defined in the Dispute Board Agreement, which incorporates this Appendix. In the Dispute Board Agreement, words and expressions which are not otherwise defined shall have the meanings assigned to them in the Contract.

#### 2 General Provisions

Unless otherwise stated in the Dispute Board Agreement, it shall take effect on the latest of the following dates:

- (a) the Commencement Date defined in the Contract,
- (b) when the Employer, the Contractor and the Member have each signed the Dispute Board Agreement, or
- (c) when the Employer, the Contractor and each of the Other Members (if any) have respectively each signed a dispute board agreement.

This employment of the Member is a personal appointment. At any time, the Member may give not less than 70 days' notice of resignation to the Employer and to the Contractor, and the Dispute Board Agreement shall terminate upon the expiry of this period.

#### 3 Warranties

The Member warrants and agrees that he/she is and shall be impartial and independent of the Employer, the Contractor and the Project Manager. The Member shall promptly disclose, to each of them and to the Other Members (if any), any fact or circumstance which might appear inconsistent with his/her warranty and agreement of impartiality and independence.

When appointing the Member, the Employer and the Contractor relied upon the Member's representations that he/she is:

- (a) experienced in the work which the Contractor is to carry out under the Contract,
- (b) experienced in the interpretation of contract documentation, and



- (c) fluent in the language for communications defined in the Contract.

#### **4 General Obligations of the Member**

The Member shall:

- (a) have no interest financial or otherwise in the Employer, the Contractor or the Project Manager, nor any financial interest in the Contract except for payment under the Dispute Board Agreement;
- (b) not previously have been employed as a consultant or otherwise by the Employer, the Contractor or the Project Manager, except in such circumstances as were disclosed in writing to the Employer and the Contractor before they signed the Dispute Board Agreement;
- (c) have disclosed in writing to the Employer, the Contractor and the Other Members (if any), before entering into the Dispute Board Agreement and to his/her best knowledge and recollection, any professional or personal relationships with any director, officer or employee of the Employer, the Contractor or the Project Manager, and any previous involvement in the overall project of which the Contract forms part;
- (d) not, for the duration of the Dispute Board Agreement, be employed as a consultant or otherwise by the Employer, the Contractor or the Project Manager, except as may be agreed in writing by the Employer, the Contractor and the Other Members (if any);
- (e) comply with the annexed procedural rules and with GCC Sub-Clause 45.3;
- (f) not give advice to the Employer, the Contractor, the Employer's Personnel or the Contractor's Personnel concerning the conduct of the Contract, other than in accordance with the annexed procedural rules;
- (g) not while a Member enter into discussions or make any agreement with the Employer, the Contractor or the Project Manager regarding employment by any of them, whether as a consultant or otherwise, after ceasing to act under the Dispute Board Agreement;
- (h) ensure his/her availability for all site visits and hearings as are necessary;
- (i) become conversant with the Contract and with the progress of the Facilities (and of any other parts of the project of which the Contract forms part) by studying all documents received which shall be maintained in a current working file;
- (j) treat the details of the Contract and all the DB's activities and hearings as private and confidential, and not publish or disclose them without the prior written consent of the Employer, the Contractor and the Other Members (if any); and
- (k) be available to give advice and opinions, on any matter relevant to the Contract when requested by both the Employer and the Contractor, subject to the agreement of the Other Members (if any).

#### **5 General Obligations of the Employer and the Contractor**

The Employer, the Contractor, the Employer's Personnel and the Contractor's Personnel shall not request advice from or consultation with the Member regarding the Contract, otherwise than in the normal course of the DB's activities under the Contract and the Dispute Board Agreement. The Employer and the Contractor shall be responsible for compliance with this provision, by the Employer's Personnel and the Contractor's Personnel respectively.

The Employer and the Contractor undertake to each other and to the Member that the Member shall not, except as otherwise agreed in writing by the Employer, the Contractor, the Member and the Other Members (if any):

- (a) be appointed as an arbitrator in any arbitration under the Contract;
- (b) be called as a witness to give evidence concerning any dispute before arbitrator(s) appointed for any arbitration under the Contract; or
- (c) be liable for any claims for anything done or omitted in the discharge or purported discharge of the Member's functions, unless the act or omission is shown to have been in bad faith.

The Employer and the Contractor hereby jointly and severally indemnify and hold the Member harmless against and from claims from which he is relieved from liability under the preceding paragraph.

Whenever the Employer or the Contractor refers a dispute to the DB under GCC Sub-Clause 45.3, which will require the Member to make a site visit and attend a hearing, the Employer or the Contractor shall provide appropriate security for a sum equivalent to the reasonable expenses to be incurred by the Member. No account shall be taken of any other payments due or paid to the Member.

## **6 Payment**

The Member shall be paid as follows, in the currency named in the Dispute Board Agreement:

- (a) a retainer fee per calendar month, which shall be considered as payment in full for:
  - (i) being available on 28 days' notice for all site visits and hearings;
  - (ii) becoming and remaining conversant with all project developments and maintaining relevant files;
  - (iii) all office and overhead expenses including secretarial services, photocopying and office supplies incurred in connection with his duties; and
  - (iv) all services performed hereunder except those referred to in sub-paragraphs (b) and (c) of this Clause.

The retainer fee shall be paid with effect from the last day of the calendar month in which the Dispute Board Agreement becomes effective; until the last day of the calendar month in which the Taking-Over Certificate is issued for the whole of the Works.

With effect from the first day of the calendar month following the month in which Taking-Over Certificate is issued for the whole of the Works, the retainer fee shall be reduced by one third. This reduced fee shall be paid until the first day of the calendar month in which the Member resigns or the Dispute Board Agreement is otherwise terminated.

- (b) a daily fee which shall be considered as payment in full for:
  - (i) each day or part of a day up to a maximum of 2 days' travel time in each direction for the journey between the Member's home and the site, or another location of a meeting with the Other Members (if any);
  - (ii) each working day on site visits, hearings or preparing decisions; and
  - (iii) each day spent reading submissions in preparation for a hearing.

- (c) all reasonable expenses including necessary travel expenses (air fare in less than first class, hotel and subsistence and other direct travel expenses) incurred in connection with the Member's duties, as well as the cost of telephone calls, courier charges, faxes and telexes: a receipt shall be required for each item in excess of five percent of the daily fee referred to in sub-paragraph (b) of this Clause;
- (d) any taxes properly levied in the Country on payments made to the Member (unless a national or permanent resident of the Country) under this Clause 6.

The retainer and daily fees shall be as specified in the Dispute Board Agreement. Unless it specifies otherwise, these fees shall remain fixed for the first 24 calendar months, and shall thereafter be adjusted by agreement between the Employer, the Contractor and the Member, at each anniversary of the date on which the Dispute Board Agreement became effective.

If the parties fail to agree on the retainer fee or the daily fee the appointing entity or official named in the SCC shall determine the amount of the fees to be used.

The Member shall submit invoices for payment of the monthly retainer and air fares quarterly in advance. Invoices for other expenses and for daily fees shall be submitted following the conclusion of a site visit or hearing. All invoices shall be accompanied by a brief description of activities performed during the relevant period and shall be addressed to the Contractor.

The Contractor shall pay each of the Member's invoices in full within 56 calendar days after receiving each invoice and shall apply to the Employer (in the Statements under the Contract) for reimbursement of one-half of the amounts of these invoices. The Employer shall then pay the Contractor in accordance with the Contract.

If the Contractor fails to pay to the Member the amount to which he/she is entitled under the Dispute Board Agreement, the Employer shall pay the amount due to the Member and any other amount which may be required to maintain the operation of the DB; and without prejudice to the Employer's rights or remedies. In addition to all other rights arising from this default, the Employer shall be entitled to reimbursement of all sums paid in excess of one-half of these payments, plus all costs of recovering these sums and financing charges calculated at the rate specified in accordance with GCC Sub-Clause 12.3.

If the Member does not receive payment of the amount due within 70 days after submitting a valid invoice, the Member may (i) suspend his/her services (without notice) until the payment is received, and/or (ii) resign his/her appointment by giving notice under Clause 7.

## **7 Termination**

At any time: (i) the Employer and the Contractor may jointly terminate the Dispute Board Agreement by giving 42 days' notice to the Member; or (ii) the Member may resign as provided for in Clause 2.

If the Member fails to comply with the Dispute Board Agreement, the Employer and the Contractor may, without prejudice to their other rights, terminate it by notice to the Member. The notice shall take effect when received by the Member.

If the Employer or the Contractor fails to comply with the Dispute Board Agreement, the Member may, without prejudice to his other rights, terminate it by notice to the Employer and the Contractor. The notice shall take effect when received by them both.

Any such notice, resignation and termination shall be final and binding on the Employer, the Contractor and the Member. However, a notice by the Employer or the Contractor, but not by both, shall be of no effect.

## **8 Default of the Member**

If the Member fails to comply with any of his obligations under Clause 4 concerning his impartiality or independence in relation to the Employer or the Contractor, he/she shall not be entitled to any fees or expenses hereunder and shall, without prejudice to their other rights, reimburse each of the Employer and the Contractor for any fees and expenses received by the Member and the Other Members (if any), for proceedings or decisions (if any) of the DB which are rendered void or ineffective by the said failure to comply.

## **9 Disputes**

Any dispute or claim arising out of or in connection with this Dispute Board Agreement, or the breach, termination or invalidity thereof, shall be finally settled by institutional arbitration. If no other arbitration institute is agreed, the arbitration shall be conducted under the Rules of Arbitration of the International Chamber of Commerce by one arbitrator appointed in accordance with these Rules of Arbitration.

## Annex - DISPUTE BOARD GUIDELINES

1. Unless otherwise agreed by the Employer and the Contractor, the DB shall visit the site at intervals of not more than 140 days, including times of critical construction events, at the request of either the Employer or the Contractor. Unless otherwise agreed by the Employer, the Contractor and the DB, the period between consecutive visits shall not be less than 70 days, except as required to convene a hearing as described below.
2. The timing of and agenda for each site visit shall be as agreed jointly by the DB, the Employer and the Contractor, or in the absence of agreement, shall be decided by the DB. The purpose of site visits is to enable the DB to become and remain acquainted with the progress of the Works and of any actual or potential problems or claims, and, as far as reasonable, to prevent potential problems or claims from becoming disputes.
3. Site visits shall be attended by the Employer, the Contractor and the Project Manager and shall be co-ordinated by the Employer in co-operation with the Contractor. The Employer shall ensure the provision of appropriate conference facilities and secretarial and copying services. At the conclusion of each site visit and before leaving the site, the DB shall prepare a report on its activities during the visit and shall send copies to the Employer and the Contractor.
4. The Employer and the Contractor shall furnish to the DB one copy of all documents which the DB may request, including Contract documents, progress reports, variation instructions, certificates and other documents pertinent to the performance of the Contract. All communications between the DB and the Employer or the Contractor shall be copied to the other Party. If the DB comprises three persons, the Employer and the Contractor shall send copies of these requested documents and these communications to each of these persons.
5. If any dispute is referred to the DB in accordance with GCC Sub-Clause 45.3, the DB shall proceed in accordance with GCC Sub-Clause 45.3 and these Guidelines. Subject to the time allowed to give notice of a decision and other relevant factors, the DB shall:
  - (a) act fairly and impartially as between the Employer and the Contractor, giving each of them a reasonable opportunity of putting his case and responding to the other's case, and
  - (b) adopt procedures suitable to the dispute, avoiding unnecessary delay or expense.
6. The DB may conduct a hearing on the dispute, in which event it will decide on the date and place for the hearing and may request that written documentation and arguments from the Employer and the Contractor be presented to it prior to or at the hearing.
7. Except as otherwise agreed in writing by the Employer and the Contractor, the DB shall have power to adopt an inquisitorial procedure, to refuse admission to hearings or audience at hearings to any persons other than representatives of the Employer, the Contractor and the Project Manager, and to proceed in the absence of any party who the DB is satisfied received notice of the hearing; but shall have discretion to decide whether and to what extent this power may be exercised.
8. The Employer and the Contractor empower the DB, among other things, to:
  - (a) establish the procedure to be applied in deciding a dispute,
  - (b) decide upon the DB's own jurisdiction, and as to the scope of any dispute referred to it,
  - (c) conduct any hearing as it thinks fit, not being bound by any rules or procedures other than those contained in the Contract and these Guidelines,

- (d) take the initiative in ascertaining the facts and matters required for a decision,
  - (e) make use of its own specialist knowledge, if any,
  - (f) decide upon the payment of financing charges in accordance with the Contract,
  - (g) decide upon any provisional relief such as interim or conservatory measures,
  - (h) open up, review and revise any certificate, decision, determination, instruction, opinion or valuation of the Project Manager, relevant to the dispute, and
  - (i) appoint, should the DB so consider necessary and the Parties agree, a suitable expert at the cost of the Parties to give advice on a specific matter relevant to the dispute.
9. The DB shall not express any opinions during any hearing concerning the merits of any arguments advanced by the Parties. Thereafter, the DB shall make and give its decision in accordance with GCC Sub-Clause 45.3, or as otherwise agreed by the Employer and the Contractor in writing. If the DB comprises three persons:
- (a) it shall convene in private after a hearing, in order to have discussions and prepare its decision;
  - (b) it shall endeavour to reach a unanimous decision: if this proves impossible the applicable decision shall be made by a majority of the Members, who may require the minority Member to prepare a written report for submission to the Employer and the Contractor; and
  - (c) if a Member fails to attend a meeting or hearing, or to fulfil any required function, the other two Members may nevertheless proceed to make a decision, unless:
    - (i) either the Employer or the Contractor does not agree that they do so, or
    - (ii) the absent Member is the chairman and he/she instructs the other Members to not make a decision.

## Section 8 - Special Conditions of Contract

The following Special Conditions of Contract (SCC) shall supplement the General Conditions of Contract (GCC). Whenever there is a conflict, the provisions herein shall prevail over those in the GCC. The clause number of the SCC is the corresponding clause number of the GCC.

## 7. Scope of Facilities

7.3 The Contractor agrees to supply spare parts for a period of years: **Five (5)**

The Contractor shall carry sufficient inventories to ensure an ex-stock supply of consumable spares for the Plant. Other spare parts and components shall be supplied as promptly as possible, but at the most within six (6) months of placing the order and opening the letter of credit. In addition, in the event of termination of the production of spare parts, advance notification will be made to the Employer of the pending termination, with sufficient time to permit the Employer to procure the needed requirement. Following such termination, the Contractor will furnish to the extent possible and at no cost to the Employer the blueprints, drawings and specifications of the spare parts, if requested.



## 8. Time for Commencement and Completion

- 8.1 The Contractor shall commence work on the Facilities within 20 days from the Effective Date for determining Time for Completion as specified in the Contract Agreement.
- 8.2 The Time for Completion of the whole of the Facilities shall be **450** days from the Effective Date as described in the Contract Agreement.

## 9. Contractor's Responsibilities

9.8 The Contractor shall comply with all applicable national, provincial, and local environmental laws and regulations.

The Contractor shall

1. Establish an operational system for managing environmental impacts.
2. Carry out all of the monitoring and mitigation measures set forth in the [Environmental Impact Assessment]/ [Environmental Management Plan, and
3. Allocate the budget required to ensure that such measures are carried out. The Contractor shall submit semi-annual reports on the carrying out of such measures to the Employer.
4. The Contractor shall particularly comply with (i) the measures and requirements set forth in the Environmental Impact Assessment and Environmental Management Plan attached hereto as Appendix 1 and Appendix 2 respectively; and (ii) any corrective or preventive actions set out in safeguards monitoring reports that the Employer will prepare from time to time to monitor implementation of the Environmental Impact Assessment and the environmental management plan.

Without prejudice to all of the above, provide the Employer with a written notice of any unanticipated environmental, resettlement, or indigenous people's risks or impacts that arise during construction, implementation or operation of a subproject that were not considered in the EIA, the EMP or the LARP.

The contractor will ensure that the preparation, design, construction, implementation, operation, restoration and decommissioning of project comply with

1. all applicable laws and regulations of Pakistan relating to environment, health, and safety;
2. the Environmental Safeguards;
3. the Environment Assessment Review Framework (EARF);
4. all measures and requirements set forth in the respective EIA / IEE and EMP, and any corrective or preventative actions set forth in a Safeguards Monitoring Report.

Pakistan Environmental Protection Act (PEPA) 1997, Baluchistan Environment Protection Act 2012 & Other Agencies shall be strictly adhered to.

### **Environmental Safeguards:**

Contractor(s) shall ensure that

To appoint the Site Environmental Engineer/Specialist with relevant educational background and experience. The CVs of the applicants for the position should be shared with Environment Officer of QESCO and the appointment should only be confirmed after the relevant DISCO's ESC staff approval.

- (a) Implementation of Environmental Management Plan & Monitoring Plan in letter and spirit;
- (b) All mitigation and monitoring measures identified in the respective Environmental Management Plan (EMP) are incorporated in detail design and implemented during construction/operation of the Project facilities;
- (c) All contracts under the subprojects contain provisions on compliance with these requirements;
- (d) To make available budget for all such environmental and social measures;

- (e) To provide GSC and ESC of PMU with a written notice of any unanticipated environmental, resettlement or indigenous peoples risks or impacts that arise during construction, implementation or operation of project that were not considered in the IEE, the EMP or the LARP.
- (f) Trees (Minimum 06-Feet in height) plantation is carried out in accordance with the Environmental Approval obtained from EPA Punjab and in accordance with the aesthetic value of the area.
- (g) All amounts claimed by contractor(s) in lieu of Environment & Social Safeguard Management be sent to DM (Environment & Safeguard) for verification in order to make things proper and transparent.
- (h) To submit monthly monitoring & implementation report to Environment and Social Cell / Environment and Social Unit of QESCO.
- (i) Comply with all pertinent occupational health and safety regulation;
- (j) Personal Protective Equipment's (Safety Helmets, Hard Helmets, Safety Gloves, Safety Shoes, Safety Glasses, and Safety Vests etc) are provided to all the workers at site.
- (k) Safety signs and awareness material printed in Urdu & English languages (4 x 6 feet Pan flexes) are placed & visible at project site.
- (l) To fully restore pathways, other local infrastructure (sewerage line, water transporting system/pipes, rain water drainage system etc) damaged due to construction activity at the project site and agricultural land to at least pre project condition upon the completion of construction.
- (m) Provision of proper sanitation facilities to workers
- (n) Provision of clean drinking water
- (o) Conduct water tests, air quality monitoring, noise measurement on regular basis and record be provided to QESCO.
- (p) Proper landscaping is carried out

And; In case of non-compliance with mitigation measures of BOQ/EMP, QESCO has the right to suspend work and withheld payments till the remedial measures. Any delay caused by the non-compliance of the mitigation measures by the contractor will be account of the contractor and will be liable to pay penalty upto 10% of the total contract and no extension of time will be allowed to the contractor.

### **9.9 Land Acquisition & Resettlement:**

The contractor(s) will ensure that all applicable laws and regulations of the Pakistan relating to land acquisition and involuntary resettlement; (b) the Involuntary Resettlement Safeguards; (c) the LARF; and (d) all measures and requirements set forth in the respective LARP, and any corrective or preventative actions set forth in a Safeguards Monitoring Report and strictly adhered to and ensure that

- (a) Implementation of Land Acquisition & Resettlement Plan (LARP) / Abbreviated Resettlement Plan (ARP) / Resettlement Plan (RP) in letter and spirit;
- (b) No physical or economic displacement takes place in connection with any Subproject until compensation has been paid,
- (c) And all the compensation has been provided to the Project Affected Persons (PAPs), Affected Persons (AP), Affected Households (AH) before the start of any civil work.
- (d) To make available budget for all such environmental and social measures;
- (e) To provide GSC and ESC of PMU with a written notice of any unanticipated environmental, resettlement or indigenous peoples risks or impacts that arise during construction, implementation or operation of project that were not considered in the IEE, the EMP or the LARP
- (f) Use best efforts to employ women living in the vicinity of the Project Area;
- (g) Disseminate information at worksites on risks of sexually transmitted diseases and HIV/AIDS for those employed during construction, and take measures to protect workers from protect workers from potential exposure to sexually transmitted diseases;
- (h) Do not differentiate between men and women's wages or benefits for work of equal

value;

- (i) And abstain from child labor.

#### **9.10 Compensation for unavoidable damages:**

The Contractor will report to Employer, the QESCO, any unavoidable damages to crops, tree cuttings, relocation/ damages to houses etc. during construction of the Transmission lines. Employer, the QESCO, will assess and make payments directly to the owners as per their procedure.

### **13. Securities**

13.3.1 The amount of performance security, as a percentage of the Contract Price for the Facility or for the part of the Facility for which a separate Time for Completion is provided, shall be: **Ten percent (10 %) of the total contract price.**

13.3.2 The Performance Security shall be denominated in the currencies of the Contract and shall be in the form of the Unconditional Bank Guarantee attached hereto in the Section 9 (Contract Forms). The Performance Security shall be issued by (a) any reputable bank in Pakistan, which includes any Scheduled Bank, or (b) a Bank located outside Pakistan duly counter-guaranteed by a corresponding bank in Pakistan to make it enforceable.

13.3.3 The performance security shall not be reduced on the date of the Operational Acceptance.

### **14. Taxes and Duties**

14.2 The words "the Employer shall bear and promptly pay" are replaced with the words "the Contractor shall promptly pay" which shall be reimbursed by the Employer in accordance with provisions of SCC Sub-Clause 14.10.

Following new Sub-Clauses are added:

#### **14.5 Local Taxation**

The rates and prices quoted by the Contractor in the Price Schedules shall be deemed to have included (i) business taxes, income tax or taxes on income and profits, (ii) fees charged for services provided under this Contract, and (iii) all non-reimbursable fees, duties & taxes provided under Clause 14.11 except for those sums reimbursable under Clause 14.10 hereof.

#### **14.6 Categories of Plant**

Plant and material imported by the Contractor into Pakistan for the purpose of or in connection with this Contract, are categorized as below:

##### **Category "A"**

Plant and all other material imported by the Contractor and transported directly from the port of entry in Pakistan to the Site for incorporation in the Facilities, and which when accepted will become the property of the Employer.

It is clarified that raw materials and components imported for the purpose of manufacturing indigenous Plant under this Contract and materials which will become part of reinforced concrete foundations or pile foundations (such as reinforcing steel bars, cement etc.) shall not be treated under this Category.

**Category "B"**

All equipment and materials imported by the Contractor which is the property of the Contractor, and ultimately will be exported out of Pakistan.

**Category "C"**

All equipment and material imported by the Contractor which is the property of the Contractor, and which ultimately will be sold in Pakistan.

The rate of import duty on Categories "B" and "C" will be the applicable rates at the time of import into Pakistan and will be paid in full by the Contractor at such time.

The Contractor shall obtain and pay for export permits or licenses, and all charges for exportation of the Goods, equipment and materials from the country of origin or export to Pakistan for Categories A, B and C under this Contract.

**14.7 Goods imported under Category "A"**

- (1) The Contractor shall obtain and pay for import license and permit fee for- importation of the Plant, Equipment and Mandatory Spare parts falling under Category 'A'.

The Contractor shall pay for Pakistani customs duties, sales taxes and surcharge applicable to the importation of Goods and other materials falling under Category "A".

The sums paid for the above will be reimbursed by the Employer to the Contractor pursuant to **Sub-Clause 14.10 hereof**.

- (2) Fees for import licenses or permits and Pakistani import duties, sales taxes, surcharge and fees on Goods and other material falling under Category "A" , in excess of the Contract Value (CIP) consigned under "No Charge" invoicing shall be payable by the Contractor and shall not be reimbursed.
- (3) A "No Charge" invoice is required by the Customs authorities giving CIP value of each consignment involved so that the correct import duties etc. can be assessed.
- (4) All import clearance permits for Goods and other material falling under Category "A" will be obtained by the Contractor. Upon arrival of each consignment of such imported Goods and other material falling under Category "A" the Contractor shall arrange for the customs examination and clearance thereof. All charges including charges for loading, unloading and forwarding expenses shall be borne by the Contractor.
- (5) The Contractor shall pay all costs paid for any storage, demurrage, or penalties, imposed due to delay in submission of documents, incorrect or incomplete documents and noncompliance with State Laws.

**14.8 Goods imported under Category "B"**

It shall be the sole responsibility of the Contractor to arrange import, clear, handle, transport to the site and re-export from Pakistan and complete all connected Government formalities in respect of returnable equipment and/or material. All the above activities connected with import and re-export of the returnable equipment and/or material will be independently handled by the Contractor. Accordingly all charges such as import license or permit fee, opening of L/C, if any, payment of customs duties, surcharges and sales taxes at the time of importation, port clearance charges, wharf age, demurrage, octroi, transportation charges to the site and similar charges connected with the re-export of returnable equipment and/or material shall be borne by the Contractor. The Contractor shall be responsible for the

repatriation of such equipment and/or material within the stipulated time. The Contractor shall also be responsible for obtaining N.O.C. from the Ministry concerned for banned or restricted items.

#### 14.9 Goods imported under Category "C"

- (1) It shall be the sole responsibility of the Contractor to import, clear handle and transport equipment and material falling under Category "C" to the Site and complete all concerned Government formalities in respect thereof
- (2) The Employer will assist in obtaining the import permits for Category "C" if so required by the Contractor.
- (3) Permission of the Government of Pakistan shall be arranged by the Contractor prior to the sale in Pakistan to any person or organization except the Employer of any equipment and material falling under Category "C". The Employer will have the first option to purchase the equipment and material falling under Category "C".

#### 14.10 Reimbursements to the Contractor

- A. The Employer will reimburse to the Contractor all such sums as the Employer shall certify to have been properly payable (actual without any overhead charges and profits) and paid by the Contractor in respect of the following:

The Contractor shall, in all matters arising in the performance of the contract, comply in all respects with, give all notices and pay all fees required by the provisions of any national or state statute, ordinance or other law or any regulation or bye-law of any duly constituted authority.

1. Non-exempt Pakistani customs duties, sales taxes, duties and surcharges on Plant imported by the Contractor into Pakistan for the purpose of or in connection with this Contract falling under Category "A" provided that the Contractor shall not be entitled to reimbursement of any customs duty or sales tax or duty surcharge in respect of which he might by due and timely application to the appropriate authority, have obtained exemption under State Laws, i.e. Government of Pakistan SROs issued from time to time, which give details about exemption concerning import of various plants, material etc.
  2. Any additional duties and taxes other than Pakistani customs duties and sales taxes and duty surcharges imposed by the Government of Pakistan on Plant falling under Category "A" imported by the Contractor into Pakistan for the purpose of or in connection with this Contract after the date 28 days prior to the fixed date for opening of Bids for the facilities. The provisions of this Para 3 shall not apply to food, tobacco, liquor and other commissary goods and other personal articles imported by the Contractor for use or consumption of his employees.
  3. Sales tax levied upon finished plant and Mandatory Spare Parts supplied from within the Employer's country (Schedule No.1) by the Contractor for the purpose of this Contract (excluding material forming part of tower foundations such as reinforcing steel bars, concrete etc), provided the Contractor/Manufacturer /Employer are not exempted from payment of Sales tax or Sales tax are not refundable to the Contractor/Manufacturer/Employer.
- B. The Contractor shall make all endeavors to avail all applicable concessions and exemptions and in case of failure, the Contractor shall be held responsible.

#### 14.11 Non-Reimbursable Fees, Duties and Taxes

The Contractor shall not be entitled to any reimbursement by the Employer in respect of the following:

1. Any fees paid in compliance with GC sub-clause 10.4, It is clarified that fees paid in respect of import permits or licenses on Plant falling under Category "A" shall not be reimbursable under the provisions of this clause, hereof. By way of illustration but not enumeration; any fees or moneys paid in respect of port or wharfage dues, pilotage charges, anchorage charges, clearance charges, vehicle registration fees, insurance fees, road taxes, octroi charges, bramdat charges, Professional and Trade tax, education cess, group insurance and old age benefits etc., are deemed to be included in the rates and prices entered in the Price Schedules and will not be reimbursable.
2. All equipment and materials in categories A, B and C as defined in Sub-Clause 14.6 hereof, shall be subjected to Karachi Municipal Corporation (KMC) tax levy (if applicable) to be paid by the Contractor will not be reimbursable.
3. Pakistani customs duties, sales taxes, duty surcharges including Iqra surcharge and fees for import permits or licenses in respect of Contractor's Equipment and Goods (under Categories B and C), spare parts and consumables and other articles imported by his employees or food, tobacco, liquor and other commissary goods, Contractor's vehicles and other personal articles imported by the Contractor for use or consumption of his employees.
4. Any element of duty or income tax or super tax and other taxes on income, inherent in the price of local & foreign procured goods and services in Pakistan. All these duties or taxes shall be deemed to be included in the rates and prices entered in the Price Schedules, and
5. In case partial or total exemption of any duty or tax is permissible on Plant falling under Category "A" and Contractor's Equipment in any case due to Government rules and regulations which the Contractor can get by due and timely application to the appropriate authority and the Contractor fails to get this exemption then the payment made by the Contractor of duties and taxes to the extent of exemption permissible will not be reimbursed.

#### 14.11.1 Exempted Duties and Taxes

In case of refundable duties and taxes, if any, the Contractor shall arrange the payment and secure the refund himself from the concerned agencies. In case of taxes and duties, for which the Employer or the Contractor is eligible for exemption under the Contract, such exemption shall be obtained by the Contractor at his own expenses. The Employer shall not be liable to pay to the Contractor amounts that may be paid by him towards any exempted taxes and duties. However, the Employer shall assist the Contractor in obtaining such exemptions.

#### 14.11.2 Statement of Reimbursements

The Contractor shall submit to the Employer after end of each month a statement giving detailed analysis of the amount paid by him during that month in respect of duties and taxes and local body charges for which he is entitled for reimbursements under Sub-Clause 14.10 hereof.

#### 14.12 Foreign Taxation

The prices quoted by the Contractor shall be deemed to have included all taxes, duties and other charges imposed outside Pakistan on the production, manufacture, sale and transport of the Plant including, Erection and Testing Equipment and Maintenance Tools, Spare Parts, Contractor's Equipment, materials and supplies to be furnished or used under the Contract, and on the services performed under the Contract. All such taxes and duties levied outside the territory of Pakistan shall be to the account of the

Contractor.

#### 14.13 Port Charges and Port Congestion

The Contractor shall be deemed to have obtained all information regarding facilities and charges, in respect of port clearance, loading and unloading, storage, transportation, congestion and confirmed the requirements thereof at his own responsibility and all such costs and charges are deemed to be included in the Price Schedules.

#### 14.14 Advance Income Tax

- 1) Deductions of Advance Income Tax from the amount of bill payable except for the reimbursement provided under the Contract shall be made in accordance with the prevalent income tax laws of the Government of Pakistan. Deductions made for this purpose will be deposited by the Employer in the Government treasury to the credit of Contractor's account.
- 2) The Contractor may however, make a timely application to the appropriate Government authority to obtain an exemption under the State Laws from having these deductions made. If such an exemption is granted to the Contractor in respect of this Contract he shall notify the Employer in writing giving all details. The Employer will then be able to make payments without the deduction of advance income tax.

#### 14.15 Payment of Income Tax

The Contractor shall be responsible for the payment of all Pakistani income tax or taxes on income & profits arising out of the Contract, and the rates and prices stated in the Price Schedules shall be deemed to cover all such taxes.

#### 14.16 Personal Taxes and Duties

The Contractor or his personnel shall pay all personal income tax or other taxes due in Pakistan, if any, for the personnel employed by the Contractor for implementing the work or any other activity required by the Contract. The Contractor shall obtain, at his own cost, work permits from competent authorities to enable any foreign personnel to work in Pakistan. The Contractor shall be responsible for all formalities in connection with passports, obtaining visas, police permits, and expenses for customs duties, if any, related to personal goods of foreign personnel employed on the Project. However, the Employer will, if requested, assist the Contractor in obtaining visas and work permits.

### 17. Representatives

#### 17.1 The following text is added at the end of this sub-Clause:

The Project Manager shall obtain the specific prior approval of the Employer for taking any of the following actions:

- (a) Granting any extension of time for completion under Clause 40;
- (b) Suspension of work under Clause 41;
- (c) Completion Certificate under Clause 24;
- (d) Operational Acceptance Certificate under Clause 25;
- (e) Issuing a change order under Clause 39, except in emergency situation, as reasonably determined by the Project Manager.
- (f) if in the opinion of the Project Manager an emergency occurs affecting the safety of life or of the facilities or of adjoining properties he may direct the Contractor to carry out all such work or to do all such things as may be necessary in the opinion of the Project Engineer to abate or reduce the risk. The Contractor shall forthwith comply without appeal with any such direction of the Project Manager. The Project Manager shall determine the amount (if any) of extra payment to which the Contractor may be

entitled in accordance with the Contract in respect of work done pursuant to the provisions of this Sub-Clause. 22.6 and the Employer would be bound by any such determination by the Project Manager regarding extra payment.

(g) Change in Technical Specifications.

17.2.7 The Contractor shall establish an independent office in Pakistan, headed by the Contractor's Representative, at a place determined in consultation with the Employer's Representative.

## 18. Work Program

18.1 Following text is added at the end of sub-clause 18.1:

In case the Contractor fails to provide curricula vitae (CV) of the key personnel (i.e. Project Manager and Construction Manager) acceptable to the Employer/ Employer's Representative, as required in Article 7 (Personnel Requirements) of Section-6: Employer's Requirements, within stipulated period of 21 days, a penalty of an amount @ PKR 20,000 (Pakistani Rupees Twenty Thousands) per day per person will be imposed on the Contractor till submission of acceptable CVs to the Employer/ Employer's Representative.

The amount of penalty shall be recoverable from any amount payable to the Contractor under the Contract.

18.2 The form of the Program of Performance of the Contract shall be: Bar / Gantt Chart or Critical Path Method (CPM), the PERT network, in MS Project.

Add the following subparagraph in addition to sub-Clause 18.3 of the GCC:

and (c) monitoring of the obligations in Sub-Clause 9.8, 9.9, 21.1, 22.1.1, 22.2.3 (d), 22.2.7 (d), 22.2.15 and 22.2.16.

## 19. Subcontracting

19.3 Text of the last sentence "**the Contractor may employ ... at its discretion.**" is deleted and replaced by "**the Contractor may however propose Subcontractor and submit qualification documents to Project Manager for approval.**"

19.6 If any Subcontractor executes any installation which, in the opinion of the Project Engineer, is not in accordance with the Contract, the Project Engineer shall notify the Contractor and the Contractor shall forthwith rectify and remedy such installation and ensure the execution of the installation by the Subcontractor in accordance with the Contract. However, if the action taken is not to the satisfaction of the Project Engineer, then the Project Engineer may by written notice to the Contractor re-quire him to terminate such Subcontract and the Contractor, upon receipt of such notice, shall terminate such Subcontract and dismiss the Subcontractor and arrange for the Subcontractor forthwith to leave the Site.

19.7 The Contractor shall not assign any manufacturing work for any Plant or part thereof to any firm other than the Manufacturer(s) named in the Appendix 5 to the Contract Agreement titled List of Major Items of Plant and Installation Services and List of Approved Subcontractors. In unavoidable circumstance, prior approval of the Employer shall be obtained by the Contractor for assigning any manufacturing work to a manufacturer not named as such in the Contract. Nothing contained in the Contract shall create any contractual relationship or professional obligation between any manufacturer and the Employer. Onus of any discrepancy in the manufacture shall be on the Contractor.

## 21. Procurement

21.1 Materials:

Add following text at the end of Sub-Clause 21.1;



The contractor shall adequately record (using latest techniques of video recording and site photographs) the condition of roads, agricultural land and other infrastructure prior to the start of transporting materials, goods and equipment and construction.

## **22. Installation**

### **22.1.1 Bench Mark**

- (a) The Contractor shall comply with (i) the measures and requirements set forth in the resettlement plan [attached hereto as appendix ( )], to the extent it concerns impacts on affected people during construction; and (ii) any corrective or preventive actions set out in safeguards monitoring reports and the Employer will prepare from time to time to monitor implementation of the resettlement plan.
- (b) The Contractor shall allocate a Budget for compliance with these measures, requirements and actions.

## **22.2 Labor**

### **22.2.1 Engagement of Staff and Labor**

Following subparagraph is added in Sub-Clause 22.2.1;

- e) The Contractor shall use the best efforts, taking into consideration economy and efficiency, to employ women living in the vicinity of the project area for works to be performed under the contract.

### **22.2.3 Labor Laws**

Following subparagraph is added in Sub-Clause 22.2.3;

- (d) The Contractor shall not make employment decisions based upon personal characteristics unrelated to job requirement. The contractor shall base the employment relationship upon equal opportunity and fair treatment, and shall not discriminate with respect to aspects of the employment relationship, including recruitment and hiring, compensation (including wages and benefits), working conditions and terms of employment or retirement, and discipline.

### **22.2.5 Working Hours**

Working Hours will be as per prevailing Labor Laws of Government of Pakistan.

### **22.2.7 Health and Safety**

Following subparagraph is added in Sub-Clause 22.2.7;

- (d) The Contractor shall throughout the contract (including the Defect Liability Period),
  - (i) conduct Information, Education, and Consultation Communication (IEC) campaigns, at least every other month, addressed to all the Site staff and labor (including all the Contractor's employees, all Subcontractor's and Employer's and Project Manager's employees, and all truck drivers and crew making deliveries to Site for construction activities) and to the immediate local communities, concerning the trafficking of women and the risks, dangers, and impact, and appropriate avoidance behavior with respect to Sexually Transmitted Diseases (STD) or Sexually Transmitted Infections (STI) in general and HIV/AIDS in particular;

- (ii) provide male or female condoms for all Site staff and labor as appropriate; and
- (iii) provide for STI and HIV/AIDS screening, diagnosis, counseling, and referral to a dedicated national STI and HIV/AIDS program, (unless otherwise agreed) of all Site staff and labor.

The Contractor shall include in the program to be submitted for the execution of the Facilities under Sub-Clause 18.2 of GCC an alleviation program for Site staff and labor and their families in respect of Sexually Transmitted Infections (STI) and Sexually Transmitted Diseases (STD) including HIV/AIDS. The STI, STD, and HIV/AIDS alleviation program shall indicate when, how, and at what cost the Contractor plans to satisfy the requirements of this Sub clause and the related specification. For each component, the program shall detail the resources to be provided or utilized and any related subcontracting proposed. The program shall also include provision of a detailed cost estimate with supporting documentation. Payment to the Contractor for the preparation and implementation this program shall not exceed the amount dedicated for this purpose.

#### **22.2.16 Prohibition of Harmful Child Labor**

Following paragraph is added at the end of this Sub-Clause:

'Child' means a child below the statutory minimum age under applicable national, provincial laws of Pakistan.

Following new sub-clauses 22.2.17 and 22.2.18 are added:

#### **22.2.17 Respectful Work Environment**

The Contractor shall ensure that its employees and sub-contractors observe the highest ethical standards and refrain from any form of bullying, discrimination, misconduct and harassment, including sexual harassment and shall, at all times, behave in a manner that creates an environment free of unethical behavior, bullying, misconduct and harassment, including sexual harassment. The Contractor shall take appropriate action against any employees or sub-contractors, including suspension or termination of employment or sub-contract, if any form of unethical or inappropriate behavior is identified.

The Contractor shall conduct training programs for its employees and sub-contractors to raise awareness on and prevent any form of bullying, discrimination, misconduct and harassment including sexual harassment, and to promote a respectful work environment. The Contractor shall keep an up to date record of its employees and subcontractors who have attended and completed such training programs and provide such records to the Employer or the Engineer at their first written request.

#### **22.2.18 Freedom of Association**

The Contractor shall allow freedom of association and effectively recognize the right to collective bargaining. The Contractor shall not discourage the Contractor's Personnel from forming or joining workers' organizations of their choosing or from bargaining collectively and shall not discriminate or retaliate against the Contractor's Personnel who participate, in such organizations and bargaining collectively. The Contractor shall engage with such workers' representatives. Workers' organizations are expected to fairly represent the workers in the workforce.

22.3 The following new paragraph is added:

The Contractor shall provide security to his own staff and supervisory staff of

Employer and Project Engineer at the Site.

### 23. Test and Inspection

All the material / equipment (civil /electrical /mechanical) to be installed / used at the works shall be subject to testing /pre-shipment inspection in line with the requirements of relevant specification(s). The following Sub – clauses shall supplement the relevant GCC clause 23, in case of any contradiction the latter shall prevail.

23.2 Two authorized representatives, one from the Employer and one from the Employer's representative, shall carry out pre-shipment inspection of the plant/material/equipment at manufacturer's works at the Contractor's expense. However, all reasonable facilities (laboratory, tools, instruments, machines, samples etc) as provided in the specifications or followed by Trade & Industry in general shall have to be offered to the Inspecting officers by Manufacturer/Supplier at his expense for carrying out Testing and Inspection.

23.3 The text "appearing in second and third line reading as **"a reasonable advance notice of such test and / or inspection"** is replaced with text **"eight (8) weeks advance notice to carry out any test and / or inspection abroad and four (4) weeks advance for any test and / or inspection within Pakistan"**. The following new paragraph is added at the end of this Sub-Clause:

The Project Manager will issue the test and / or Inspection Certificate including Pre- shipment Certificate on successful completion of testing and / or inspection of plant and equipment, after the receipt of test and / or inspection report including Pre-shipment Inspection Report from the Contractor.

23.4 The text **"after issuance of Letter of Waiver by the Employer to ensure timely shipment"** may be added in 2nd para at the end of fourth line before **"", "**.

In the last line after the word **"thereof"** add the text **"before shipment. The Goods and any part thereof shall be shipped or delivered only upon issuance of Pre-shipment Inspection Certificate or Letter of Waiver to Pre-shipment Inspection"**

23.5 The following sentence is added at the end of Sub-Clause:

**"The Contractor shall carry out all the required tests according to relevant standards"**.

23.6 In case the type test reports furnished by the bidder/Contractor are not according to NTDC latest Revised Type Test Policy, the Contractor will have to arrange necessary type testing, in case of award as per NTDC latest Revised Type Test Policy within the quoted Bid Price before delivery of Plant/Equipment without affecting the delivery/completion period as mentioned in Sub-Clause 8.2 hereof. In case of delay or non-compliance of the said requirements, the Employer reserves the right to cancel the Contract Agreement including encashment of performance guarantee and initiate the process for blacklisting as per the Employer's SoP for blacklisting.

Any inspection and/or witnessing of tests or the waiving of such tests and/or surveillance by the Employer shall not relieve the Contractor of its obligations and responsibilities under the Contract regardless of any approval consent given by the Employer and the Employer's representative.

All work covered by the Contract shall be subject to surveillance, testing and inspection by two representatives/Inspector(s) one from the Employer and one from the Employer's representative. The Inspectors may require witnessing any or all the tests to be carried out. For such purpose the Contractor/Manufacturer/Supplier shall provide free access at all times during

manufacturing, assembly and testing to the premises in which the work is being carried out.

In case the type test reports furnished by the bidder are not from one of reputed independent testing laboratories accredited by STL (Short Circuit Testing Liaison) or HV&SC Rawat Lab Pakistan or not relevant to the equipment offered or do not meet or comply with the rating and other requirements of the Purchaser's specifications included in this bidding document or are otherwise not to the satisfaction of the purchaser in any respect, the Contractor will have to arrange necessary type testing in case of award at any of the reputed/ recognized independent testing laboratory accredited by STL or HV&SC Rawat Lab Pakistan, entirely at his cost and arrangements, including the expenses for witnessing the type test by one representative of the Employer and one representative of Consultant/Engineer covering all the expenditures of the each member of inspection team for living, boarding lodging in an A Class Hotel, inland transportation, return air tickets, etc. will be borne by the contractor whereas daily allowance will be US\$200/day/inspector for foreign visit and Rs.5,000/day/inspector for local visit, without effecting stipulated delivery schedule.

In case of type testing, or if the Plant fail to withstand any test performed at manufacturer works, the cost of performing type tests and repeating failed tests and the cost (boarding, lodging, daily allowance of US\$200/day/inspector, return air ticket, visa expense etc.) of witnessing such test by the approved two Nos. representatives/ Inspector, one from the Employer and one from the Project Engineer/Employer's representative, **shall be borne by the Contractor** and the equipment released or modified to the satisfaction of the Employer, without any additional cost to the Employer.

The employer and Project Manager or their designated representatives shall be entitled to attend and witness the aforesaid tests (Factory Acceptance/Pre-shipment) of plant/equipment/material and/or inspection, provided that the **Contractor shall bear all costs** and expenses incurred in connection with such attendance, covering all the expenditures of the each member of inspection team for living, boarding lodging in an A Class Hotel, inland transportation, return air tickets, etc. **will be borne by the contractor** whereas daily allowance will be US\$200/day/inspector for foreign visit and Rs. 5,000/day/inspector for local visit, without effecting stipulated delivery schedule.

- 23.12 The Plant or any part thereof shall be shipped or delivered only upon an authorization in writing (hereinafter called the "Notice to Deliver") which shall be applied for and obtained by the Contractor from the Project Engineer stipulating that the Plant or any part thereof may be shipped or delivered. The Notice to Deliver will be issued within seven (07) days from the date of receipt by the Project Engineer of the Contractor's valid application for request for "Notice to Deliver".

## **24. Completion of the Facilities**

Following new sub-clause 24.9 is added:

- 24.9 Upon the completion of construction, the Contractor shall fully reinstate pathways, the local infrastructure, and agricultural land to at least their pre-project condition as recorded by the contractor in consonance with its obligation in Sub-Clause 21.1 hereof.

## **25. Commissioning and Operational Acceptance**

- 25.2 This Sub-Clause "Guarantee Test" is deleted in its entirety.

25.3.1 The GCC Sub-Clause 25.3.1 is substituted by the following:

Subject to GC Sub-Clause 25.4 below, Operational Acceptance shall occur in respect of the Facilities or any part thereof when:

- a) any minor items mentioned in GCC Sub-Clause 24.7 hereof relevant to the Facilities or that part thereof have been completed; and
- b) As Built Drawings (Records Drawings) and data as mentioned in SI-06.3.7 of Employer's Requirements have been furnished.

## **26. Completion Time Guarantee**

26.2 Applicable rate for liquidated damages: **0.05 % of the Contract Price** per day

Maximum deduction for liquidated damages: **10% of the contract price.**

26.3 No bonus will be given for earlier Completion of the Facilities or part thereof.

## **27. Defect Liability**

27.2 In second paragraph the words "**as the Contractor shall determine at its discretion,**" are replaced with the words "**as the Contractor shall, with the consent of the Employer, determine**".

27.4 The word "**Employer**" is replaced with the word "**Employer / Project Manager**".

27.10 Applicable: **One (1) year** from the date of Operational Acceptance of the Facilities (All components) by the Employer. The date certified in the Completion Certificate for the Works or part thereof.

27.11 When the Defect Liability Period for the Facilities or any part thereof has expired and the Contractor has fulfilled all his obligations under the Contract for defects in the Facilities or that part, the Employer shall issue within seven (07) days a Defect Liability Period Certificate to that effect to the Contractor.

### **Making Good Defects**

(1) The Contractor shall be responsible for making good any defects in or damage to any part of the Works which may appear or occur to any part of the Works, under the conditions provided for by the Contract and under proper use of that part of the Works, during the Defects Liability

Period and which arises from, either:

- (a) any defective materials, workmanship or design, or
  - (b) any act or omission of the Contractor
- (2) The Contractor shall, on the Site, make good the defect or damage as soon as practicable and at his own cost.

## **28. Functional Guarantees**

This Sub-Clause "Functional Guarantees" is deleted in its entirety.

## **30. Limitation of Liability**

30.1 (b) The multiplier of the Contract Price is: [1.5]

## **34. Insurance**

Following new sub-clauses are added in Clause 34:

34.8 Should a loss be sustained, the Contractor shall replace or repair any loss or

damage at his own cost and complete the Facilities in accordance with the Contract as soon as possible after occurrence of such loss or damages, without waiting for the settlement of the insurance claim.

#### 34.9 Contractor to Notify Insurers

1. It shall be the duty of the Contractor to notify the insurer of any insurances referred to above of any matter or event which by the terms of such insurance are required to be so notified. All formalities in connection with insurance surveys (s) shall be the sole responsibility of the Contractor. The Contractor shall indemnify and keep indemnified Employer against all loss, claims, demands, proceedings, costs, charges and expenses whatsoever arising out of or resulting from any default by the Contractor avoidance of any such insurance or otherwise.
2. In case of any insurance claim, the Contractor shall pursue the insurance claim if any, till such time final settlement of such insurance claims is affected.

#### 34.10 Currency of Insurance

All Policies of Insurance under the Contract, shall provide for payment of indemnity to be made in such amounts as will allow making good the loss of or damage to the whole or any part of Facilities, or other requirements under the Contract and in a freely convertible currency.

#### 34.11 Procurement of Insurance Policies

The Contractor shall submit to the Project Manager for review, the draft of the insurance policies to be procured under this Contract as soon as possible after receipt of Notifications of Award so that terms of the Policies may be agreed and approved by the Employer.

#### 34.12 Loss not Covered

The Contractor shall bear the Excess/Deductibles and loss not covered by the insurance in accordance with his responsibility under the Contract.

### **39. Change in the Facilities**

39.2.6 At the end of first sentence the following text is added:

“including Contractor’s Site and general overhead costs of the Contract”.

39.4 “For the removal of doubt, it is declared that any increase or decrease of the estimated quantities set out in the Price Schedule ascertained by measurement in accordance with the provisions of the Contract is not a change order within the meaning of this Clause GCC 39”.

### **45. Disputes and Arbitration**

45.1 The Dispute Board shall be appointed within 28 days after the Effective Date. The Dispute Board shall be sole member.

List of potential Dispute Board members is to be mutually decided by the Contractor and the Employer at the time of signing of the contract

#### 45.2 **Chief Executive Officer (QESCO)**

45.5 Rules of procedure for arbitration proceedings:

- (a) Contracts with foreign contractors:

International arbitration shall be conducted in accordance with the rules of Singapore International Arbitration Centre (SIAC).  
Arbitration shall be administered by SIAC.  
The place of arbitration shall be the place of the institution administering the arbitration.

- (b) Contracts with contractors being nationals of the Employer's country:

Any dispute between the Employer and a Contractor who is a national of the Employer's country arising in connection with the present contract shall be referred to adjudication or arbitration in accordance with the laws of the Employer's country.

### 35. Unforeseen Conditions

- 35.3 In addition to notice of any unforeseeable physical conditions, the Contractor shall provide the Engineer with a written notice of any unanticipated environmental or resettlement risks or impacts that arise during construction, implementation or operation of the Plant or Facilities, which were not considered in the initial environmental examination, the environmental management plan or the resettlement plan [attached hereto as Appendix (1) through Appendix (2)].

## **Appendix 1 - Terms and Procedures of Payment**

In accordance with the provisions of GCC Clause 12 (Terms of Payment), the Employer shall pay the Contractor in the following manner and at the following times, on the basis of the Price Breakdown given in the section on Price Schedules. Payments will be made in the currencies quoted by the Bidder unless otherwise agreed between the parties. Applications for payment in respect of part deliveries may be made by the Contractor as work proceeds.

### **(A) Terms of Payment**

#### **Schedule No. 1 - Plant and Equipment Supplied from Abroad**

In respect of plant and equipment supplied from abroad, the following payments shall be made:

Ten percent (10%) of the total CIP Project Site amount as an advance payment against receipt of invoice and an irrevocable advance payment security for the equivalent amount made out in favor of the Employer. The advance payment security may be reduced in proportion to the value of the plant and equipment delivered to the site, as evidenced by delivery documents.

Eighty percent (80%) of the total or pro rata CIP Project Site or amount upon Incoterm "CIP" upon delivery to Site within forty-five (45) days after receipt of invoice.

Five percent (5%) of the total or pro rata CIP Project Site or amount upon issue of the Completion Certificate, within forty-five (45) days after receipt of invoice.

Five percent (5%) of the total or pro rata CIP Project Site or amount upon issue of the Operational Acceptance Certificate, within forty-five (45) days after receipt of invoice.

#### **Schedule No. 1 - Plant and Mandatory Spare Parts Supplied from Within the Employer's Country**

In respect of plant and mandatory spare parts supplied from within the Employer's country, the following payments shall be made:

Ten percent (10%) of the total EXW amount as an advance payment against receipt of invoice, and an irrevocable advance payment security for the equivalent amount made out in favor of the Employer. The advance payment security may be reduced in proportion to the value of the plant and mandatory spare parts delivered to the site, as evidenced by delivery documents.

Eighty percent (80%) of the total or pro rata EXW amount upon Incoterm "Ex-Works," upon delivery to the site within 45 days after receipt of invoice.

Five percent (5%) of the total or pro rata EXW amount upon issue of the Completion Certificate, within 45 days after receipt of invoice.

Five percent (5%) of the total or pro rata EXW amount upon issue of the Operational Acceptance Certificate, within 45 days after receipt of invoice.

#### **Schedule No. 2 - Installation and other Services**

In respect of installation services for both the foreign and local currency portions, the following payments shall be made:

Ten percent (10%) of the total installation and other services amount as an advance payment against receipt of invoice and an irrevocable advance payment security for the equivalent amount made out in favor of the Employer. The advance payment security may be reduced in proportion to the value of work performed by the Contractor as evidenced by the invoices for installation services.

Eighty percent (80%) of the measured value of work performed by the Contractor, as identified in the said Program of Performance, during the preceding month, as evidenced by the Employer's authorization of the Contractor's application, will be made monthly within forty-five (45) days after receipt of invoice.

Five percent (5%) of the total or pro rata value of installation services performed by the Contractor as evidenced by the Employer's authorization of the Contractor's monthly applications, upon issue of the Completion Certificate, within forty-five (45) days after receipt of invoice.

Five percent (5%) of the total or pro rata value of installation services performed by the Contractor as evidenced by the Employer's authorization of the Contractor's monthly applications, upon issue of the Operational Acceptance Certificate, within forty-five (45) days after receipt of invoice.

In the event that the Employer fails to make any payment on its respective due date, the Employer shall pay to the Contractor interest on the amount of such delayed payment at the rate of five percent (5 %) per annum for period of delay until payment has been made in full.

### (B) Payment Procedures

The procedures to be followed in applying for certification and making payments shall be as follows:

#### 1. Method of Application for Certificate of Payment

- (a) The Contractor shall submit to the Employer ten (10) copies of Application for Certificate of Payment each signed by the Contractor and in such form as the Employer may from time to time prescribe. Such invoices, receipts, or other documentary evidence shall accompany application as the Employer may from time to time require.
- (b) The application for certificate of payment for progress of Work shall be submitted after end of each month accompanying also a statement signed by the Contractor in the form stated in para (4) below and in such other form as the Engineer may from time to time



prescribe showing the amounts to which the Contractor may consider himself to be entitled up to the end of the month in respect of:

- i. The permanent work executed;
- ii. Payment of account of lump sum item in the Price Schedule not included under head (i) above.

Provided further that no amount shall be certified by the Project Manager until and unless all insurance policies under Clauses 29, 30, 32, 33, 34, 35, 37 and 38 of GCC have been furnished to the satisfaction of the Project Manager; and Program of Performance submitted in accordance with Sub-Clause 18.2 of GCC (if not provided earlier), has been approved by the Project Engineer.

- (c) The Applications for Certificate of Payment for supply of Goods shall be submitted on the delivery of any Goods and shall also be accompanied by the following documents:
1. Shipping Documents comprising of
    - (i) Payment/Commercial Invoice
    - (ii) Clean on board Bill of Lading or airway bill issued by the freight forwarder (for imported Goods only)
    - (iii) Delivery Note/Acknowledgement by Employer or its representative, of the material receipt at site or at QESCO designated Warehouses in case of Spare Parts.
    - (iv) Packing list
    - (v) Certificate or Policy of Freight Insurance from Ex- factory to the Project Site or to QESCO designated Warehouses in case of Spare Parts, of the portion of the Goods for which Certificate of Payment is requested
  2. Certificate that the Goods complies with the Specifications
  3. Certificate of origin, issued by the Contractor
  4. Warranty Certificate
  5. Pre-shipment Inspection report/Inspection report or letter of waiver, issued by the Employer.
  6. Notice to Deliver issued in accordance with GCC Sub-Clause 23.12.
  7. Any other document as considered necessary by the Employer.
- (d) The Application for Certificate of Payment shall state the amount claimed and shall set forth in detail, in the order of the Price Schedule, particulars of the Work executed up to the date named in the Application and subsequent to the period covered by the last preceding certificate, if any.

## **2. Issue of Certificate of Payment**

The Employer, within the time stated, after receiving an Application for Certificate of Payment from the Contractor, shall either approve or amend it as he consider reasonable and proper in respect thereof subject to the deductions of any sums which may have become due and payable by the Contractor to QESCO and issue a Certificate of Payment accordingly to QESCO showing the amount due to the Contractor, with a copy to the Contractor, or, advise the Contractor in writing as to the reasons for which it is being withheld.

## **3. Reduction in Payment**

If any Work is not being carried out in accordance with the Contract to the satisfaction of the Employer/Project Engineer, the Employer shall have authority to omit or reduce the value of such Work in any Certificate of Payment.

## **4. Withholding Certificate of Payment**

If the Work or any part thereof are not being carried out in accordance with the Contract to the satisfaction of the Employer, the Employer shall have power to withhold any Certificate of Payment and in order to protect QESCO from loss on account of :

- (a) defective Work not rectified
- (b) claims filed against the Contractor as per the provisions of the contract
- (c) damage to any other Contractor or Contractors employed by the Employer
- (d) Contractor's non-compliance with the Contract
- (e) any Government dues recoverable from the Contractor if notified by the Government
- (f) Any other reason as deemed necessary by the Employer, for substantiation of the invoice.

The Employer shall notify the Contractor regarding this withholding giving reasons/grounds.

#### **5. Certification of Payable Amount**

- (1) A Certificate of Payment other than the Final Certificate of Payment shall not be withheld on account of any part of the payment applied for being disputed. In such case, a Certificate of Payment for the undisputed amount shall be issued.
- (2) The said Application for Certificate of Payment under Clause 1 hereof, shall be approved or amended, such that, in the Employer's opinion, the Certificate of Payment reflects the amount due to the Contractor, in accordance with the Contract. In case where there is a difference of opinion as to the value of any item, the Employer's views shall prevail.

#### **6. Corrections to Certificate of Payment**

The Employer may by any Certificate of Payment make any corrections or modifications in any previous Certificate of Payment (other than one purporting to be a Final Certificate of Payment), which shall have been issued by him.

#### **7. Issue of " Withheld " Certificate of Payment**

When the reasons/grounds for withholding the payment are removed by the Contractor, the Employer shall after examination, and upon being satisfied to that effect issue the "withheld" Certificate of Payment, without mark-up and penalty.

#### **8. Time for Approval of Certificate of Payment**

The amount due to the Contractor under any Certificate of Payment shall be approved by QESCO for payment within the time stated.

#### **9. Payment by Measurement**

Actual quantities of civil works shall be finalized upon completion of final substation layout/orientation, and approval of civil works drawings.

For any part of the Work, which is to be paid according to quantity supplied or work done, the provisions for measurement shall be as following.

#### **Work to be Measured**

The Employer shall, except as otherwise stated, ascertain and determine by measurement the value of the work done in accordance with the Contract and the Contractor shall be paid that value in accordance with this Clause. The Employer shall, when he requires any part of the Work to be measured, give reasonable notice to the Contractor's authorized agent, who shall:

- (a) Forthwith attend or send a qualified representative to assist the Employer in making such measurement, and
- (b) Supply all particulars required by the Employer.

Should the Contractor not attend, or neglect or omit to send such representative, then the measurement made by the Employer or approved by him shall be taken to be the correct measurement of such part of the Work. For the purpose of measuring such Permanent Work as are to be measured by records and drawings, the Employer shall prepare records and drawings as the work proceeds and the Contractor, as and when called upon to do so in writing, shall, within fourteen (14) days, attend to examine and agree such records and drawings with the Employer and shall sign the same when so agreed. If the Contractor does not attend to examine and agree such records and drawings, they shall be taken to be correct. If, after examination of such records and drawings, the Contractor does not agree the same or does not sign the same as agreed, they shall nevertheless be taken to be correct, unless the Contractor, within fourteen (14) days of such examination, lodges with the Employer notice of the respect in which such records and drawings are claimed by him to be incorrect. On receipt of such notice, the Employer shall review the records and drawings and either confirm or vary them.

#### **Method of Measurement**

The Work shall be measured net, notwithstanding any general or local custom, except where otherwise provided for in the Contract.

#### **10. Application for Final Certificate of Payment**

- (1) The Contractor shall make Application for the Final Certificate of Payment with supporting documentation to the Employer within 28 days after the issue of the Defects Liability Certificate, or if more than one, the last Defects Liability Certificate.
- (2) The Application for the Final Certificate of Payment shall be accompanied by a Draft Final Statement prepared by the Contractor. The Draft Final Statement shall give full details of the value of all Goods supplied and Work done under the Contract together with:
  - (a) such additions to or deductions from the Contract Price as have been agreed, and
  - (b) all claims for additional payment to which the Contractor may consider himself entitled under the Contract up to the date of the last Defects Liability Certificate.
- (3) If the Engineer disagrees with or cannot verify any part of the Draft Final Statement, the Contractor shall submit such further information as the Engineer may reasonably require and shall make such changes in all claims for additional payment to which the Contractor may consider himself entitled under the Contract up to the date of the last Defects Liability Certificate.
- 4) Prior to submission to invoices for the payment to PD (GSC) QESCO, the same must be verified/approved by the Engineer.

#### **11. Issue of Final Certificate of Payment**

- (1) The Engineer shall issue to QESCO with a copy to the Contractor, the Final Certificate of Payment within 30 days after receiving an Application with Final Statement in accordance with Sub-Clause 10 hereof.
- (2) If the Contractor has not applied for a Final Certificate of Payment within the time specified in Sub-Clause 10 hereof, the Engineer shall request the Contractor to do so within a further period of 21 days. If the Contractor fails to make such an Application, the Employer shall issue the Final Payment Certificate for such amount as he deems correct.

#### **12. Final Certificate of Payment Conclusive**

- (1) A Final Certificate of Payment shall be conclusive evidence of the value of the Work, that the Work is in accordance with the Contract and that the Contractor has performed all his obligations under the Contract.

- (2) Payment of the amount certified in the Final Certificate of Payment shall be conclusive evidence that QESCO has performed all its obligations under the Contract.
- (3) A Final Certificate of Payment shall not be conclusive if any Arbitration or court proceedings under the Contract have been commenced by either party before the expiry of 84 days after the issue of the Final Certificate of Payment.

**13. Payments Due from Contractor**

QESCO may, without prejudice to any other method of recovery, deduct the amount due from any money in his hand due to or which may become due to the Contractor or recover same through the Performance Security. Such deduction shall not relieve the Contractor from his obligations to complete the Work in accordance with the Contract to the satisfaction of the Employer.

Prices payable to the Contractor, in accordance with the Contract, shall be subject to adjustment during performance of the Contract to reflect changes in the cost of labor and material components, in accordance with the following formula:

- (c) No price adjustment shall be payable on the portion of the Contract price paid to the Contractor as an advance payment.

## Appendix 4 - Time Schedule

1. **420 days** for pre-commissioning activities and **30 days** for commissioning / testing of the facilities from the Effective Date as described in the Contract Agreement.
2. The contractor shall submit to the employer detailed schedule of activities with milestones made on MS-Project/Primavera within 10 days from the date of signing of the contract. The contractor shall also update the said schedule every month during the period of execution of the contract and submit the same to the employer on monthly basis.

Bidder shall provide a detailed program in bar chart / CPM / PERT in MS Project format showing the sequence of work items by which he proposes to complete the work of the entire Contract. The program should indicate the sequence of work items and the period of time during which he proposes to complete the Facilities including the activities like designing, testing of towers and other plant, submittal of drawings, ordering and procurement of materials, manufacturing, delivering, construction of civil works, installation, testing and commissioning of Facilities to be supplied and executed under the Contract.

The Contractor shall ensure the availability of following number of dedicated crews with requisite T&P during construction of civil works (tower foundation) and installation activities (tower erection & stringing) and shall show in their detailed program in bar charts:

1. Foundation of Towers : Minimum 07 Nos of crews
2. Erection of Towers : Minimum 06 Nos of crews
3. Stringing:
  - i. Conductor/Alumoweld Shieldwire stringing: Minimum 04 Nos of crews
  - ii. Dead Ending: Minimum 05 Nos of crews
  - iii. Damper installation & Jumpering: Minimum 05 Nos of crews

The above stated crews are minimum requirement; however, the Contractor shall be fully responsible to deploy more crews to complete the Facilities in Contractual time period.

### Schedule

The Contractor shall carry out the Work in accordance with the dates/ periods specified in General as well as Special Conditions of Contract and with the approved Schedule. The Contractor shall regularly review the Schedule and notify the Employer promptly of any revisions, which in his view may be required from time to time.

### Progress Reports

- 1) The Contractor within thirty (30) days of the signing of the Contract shall submit in writing for the approval of Employer a Schedule for the design, manufacture, delivery, erection, testing and commissioning of the Goods and design and construction of the associated civil work.
- 2) The submission to or approval by the Employer of such Schedule etc. shall not relieve the Contractor of any of his duties or responsibilities under the Contract.
- 3) At monthly intervals after submission of the Schedule, the Contractor shall submit to the Employer up to five (5) copies of a written detailed progress report in an approved form together with copies of the above mentioned Schedule indicating the stage reached in transportation of goods, erection/construction, in percentage terms. Such monthly reports shall show the actual progress plotted against the scheduled progress. These reports shall be accompanied by such photographs, diagrams, bar charts, and curves in approved standard form, as may be required by the Employer. The reports shall be forwarded not later than the 8th of the subsequent month. The numbers of copies shall be as stipulated in the Specifications or as instructed by the Employer.
- (4) The Employer shall at all reasonable times be afforded access to the Contractor and any Sub-Contractor's premises for the purpose of ascertaining progress.

**Meetings**

- 1) Soon after the date of signing of Contract, the Employer will require a conference with the Contractor at a place mutually agreed upon, to discuss scheduling of drawings, manufacture, scheduled sequences of delivery and other similar problems which may be pertinent to the completion of the Project.
- 2) At monthly intervals or from time to time during the execution of the Contract, the Employer may call meetings, either in his Offices or at the Contractor's Offices in Pakistan or QESCO's office as is deemed necessary for the purpose of progress monitoring and proper execution of the Contract.
- 3) As required by the Employer, responsible representatives of the Contractor shall attend such meetings.
- 4) All expenses incurred by the Contractor for attending such meetings shall be borne by the Contractor and shall not be reimbursable.

If the production capacity of the facilities attained in the guarantee test, pursuant to GCC Sub-Clause 25.2, is less than the guaranteed figure specified in para. 3.1 above, but the actual production capacity attained in the guarantee test is not less than the minimum level specified in para. 4.3 below, and the Contractor elects to pay liquidated damages to the Employer in lieu of making changes, modifications and/or additions to the Facilities, pursuant to GCC Sub-Clause 28.3, then the Contractor shall pay liquidated damages at the rate of . . . . . for every complete one percent (1%) of the deficiency in the production capacity of the Facilities, or at a proportionately reduced rate for any deficiency, or part thereof, of less than a complete one percent (1%).

#### 4.2 Raw Materials and Utilities Consumption in Excess of Guaranteed Level

If the actual measured figure of specified raw materials and utilities consumed per unit (or their average total cost of consumption) exceeds the guaranteed figure specified in para. 3.2 above (or their specified average total cost of consumption), but the actual consumption attained in the guarantee test, pursuant to GCC Sub-Clause 25.2, is not more than the maximum level specified in para. 4.3 below, and the Contractor elects to pay liquidated damages to the Employer in lieu of making changes, modifications and/or additions to the Facilities pursuant to GCC Sub-Clause 28.3, then the Contractor shall pay liquidated damages at the rate of . . . . . for every complete one percent (1%) of the excess consumption of the Facilities, or part thereof, of less than a complete one percent (1%).

**4.3 Minimum Levels**

Notwithstanding the provisions of this paragraph, if as a result of the guarantee test(s), the following minimum levels of performance guarantees (and consumption guarantees) are not attained by the Contractor, the Contractor shall at its own cost make good any deficiencies until the Facilities reach any of such minimum performance levels, pursuant to GCC Sub-Clause 28.2:

- (a) production capacity of the Facilities attained in the guarantee test: ninety-five percent (95%) of the guaranteed production capacity

and/or

- (b) average total cost of consumption of all the raw materials and utilities of the Facilities: one hundred and five percent (105%) of the guaranteed figures.

## **Appendix-9 ENVIRONMENTAL MANAGEMENT PLAN / RESETTLEMENT PLAN**

The Contractor shall be cognizant of all environmental and social requirements of the project and their impact, in line with the Environmental Protection Act 1997 of Pakistan and all related components of environmental Concern Matrix (Appended herewith).

Overall responsibility for implementation of safeguards framework rests with the employer, which will designate a focal officer with responsibility for overseeing implementation of environmental and social Safeguard as per above said documents.

At the commencement of the project, the matrix of the responsibilities will be confirmed between the employer and the Contractor.

The Contractor shall make sure that all the environmental / social issues / mitigation steps pertaining to the site being handed over to him / her have been settled / taken care off prior to start of the work on the said site.

### **Environmental Management Plan (EMP):**

The Environmental Management Plan is based on the type, extent and duration of the identified Environment impacts. The contractor should be cognizant of all environmental and social requirements of the project and their impact in line with the Environmental Protection act of Pakistan and all related components of Environmental Concerned Matrix as appended herewith. At the commencement of the Project, the matrix of the responsibilities will be agreed between the Employer and the Contractor. The contractor shall make sure that the relevant environmental/Social issues/mitigation steps pertaining to site have been settled and taken care off prior to start of the work at the site and during the construction phase. It is important that the recommendations and mitigation measures are carried out according to the spirit of the environmental assessment process and in line with the guidelines. In order to facilitate the implementation of the EMP, during the construction phase, the contractor must be prepared to cooperate with the local population in the mitigation of impacts. The contractor should be primed through the contract document and ready to implement all the mitigation measures and engage trained EMP Staff to audit the effectiveness and review the mitigation measures as the Project proceeds.
